

**ORDINANCE A-278**

**AN ORDINANCE ESTABLISHING THE MONTHLY SALARY OF THE MAYOR AND COUNCILMEMBERS**

**BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF GROVE HILL, ALABAMA AS FOLLOWS:**

**SECTION 1.** That the salary of the Mayor of the City of Grove Hill, Alabama, shall be and the same is hereby fixed at the sum of \$1,200.00 per month.

**SECTION 2.** That the salary of each Councilmember of the City of Grove Hill, Alabama, shall be and the same is hereby fixed at the sum of \$800.00 per month.

**SECTION 3.** In addition to the salary provided for herein, the mayor and council members shall also be entitled to any benefits normally offered to all full-time employees of the city as authorized by law.

**SECTION 4.** This ordinance shall become effective on the first Monday in November 2025 and shall continue in force and effect until repealed by action of the council.

**SECTION 5.** The provisions of this ordinance are hereby declared severable; if any portion of this ordinance shall be held unconstitutional or otherwise invalid by a court of competent jurisdiction, such ruling shall not affect the remaining portions of this ordinance.
