I ACKNOWLEDGE AND AGREE that my participation and/or participation of my minor child, is for the purpose of learning, studying and practicing martial arts. The practice of martial arts is physically strenuous, dynamic, and a challenging practice of traditional self-defense techniques which includes, but is not limited to, punching, kicking, striking, blocking, seizing, throwing and grappling, both individually and with partners in the class and will involve the use of traditional weapons such as the Bo, Sai, Nunchaku, Tekko, Kama, Shinai, Boken, Katana, Tinbe & Rochin, Eku, Tonfa, and other blades with sharpened edges. I further fully understand that such activity includes inherent risks, including potentially serious bodily injury, permanent or temporary disability, paralysis or death which may be caused from my actions or inactions, the actions or inactions of others, or the conditions of the facility in which the activity is conducted; I understand that there may be other risks or other social, hedonic or economic losses either not known to me or readily foreseeable at this time; and I HEREBY FULLY AND FREELY ACCEPT AND ASSUME ALL SUCH RISKS AND ASSUME RESPONSIBILITY FOR ALL INJURIES, LOSSES, COSTS, AND DAMAGES incurred as a result of my participation or the participation of my minor child in the activity. I have consulted with my physician prior to engaging in the practice of martial arts and I am, or my minor child are qualified, in good health and I proper physical condition to participate in such activity. I am responsible for monitoring my own activity level and maintaining awareness of my health and/or physical limitations and those of any minor I have allowed to participate. I further agree that I will immediately discontinue the contemplated participation in any activity which I perceive to be unsafe for any reason.

I ALSO HEREBY RELEASE, DISCHARGE, COVENANT NOT TO SUE AND AGREE TO HOLD HARMLESS the National Karate Jujitsu Federation (NKJF), USA-International ®, its instructors, administrators, members, directors, agents, officers, volunteers, employees and other participants, owners, lessors, licensors and licensees of the premises on which the activity takes place (each considered a "Releasee") from any and all liability, claims, demands, losses or damages on account caused or alleged in whole or in part by any act or omission or failure of the Releasees in connection with the activities described above, whether or not caused in whole or in part by the negligence of any Releasee, including rescue operations, and further agree that if, despite this release, I or anyone on my behalf or on behalf of my minor child participant makes a claim against any Releasee, I will indemnify, save and hold harmless each of the Releasees from any litigation expenses, attorney fees, loss liability, damages, payments or cost as may occur as the result of such claim.

I agree to immediately report any unsafe actions or conditions that come to my attention, including but not limited to the floor or any equipment.
