2. Petitioner asks the Court to enter, after a hearing has been held on this petition, a **FINAL JUDGMENT** for protection against stalking prohibiting Respondent from committing any acts of stalking against Petitioner and:

a. prohibiting Respondent from going to or within 500 feet of any place Petitioner lives, or to any specified place regularly frequented by Petitioner and any named family members or individuals closely associated with Petitioner;

c. prohibiting Respondent from contacting Petitioner by telephone, mail, by e-mail, in writing, through another person, or in any other manner;

d. ordering Respondent that he or she shall not have in his or her care, custody, possession, or control any firearm or ammunition;

e. prohibiting Respondent from knowingly and intentionally going to or within 100 feet of Petitioner's motor vehicle, whether or not that vehicle is occupied;

3. Petitioner asks the Court to enter any other terms it deems necessary to protect Petitioner from stalking by Respondent.

I UNDERSTAND THAT BY FILING THIS PETITION, I AM ASKING THE COURT TO HOLD A HEARING ON THIS PETITION, THAT BOTH THE RESPONDENT AND I WILL BE NOTIFIED OF THE HEARING, AND THAT I MUST APPEAR AT THE HEARING. I UNDERSTAND THAT IF EITHER RESPONDENT OR I FAIL TO APPEAR AT THE FINAL HEARING, WE WILL BE BOUND BY THE TERMS OF ANY INJUNCTION OR ORDER ISSUED AT THAT HEARING.

I HAVE READ EVERY STATEMENT MADE IN THIS PETITION, AND EACH STATEMENT IS TRUE AND CORRECT. I UNDERSTAND THAT THE STATEMENTS MADE IN THIS PETITION ARE BEING MADE UNDER PENALTY OF PERJURY, PUNISHABLE AS PROVIDED IN SECTION 837.02, FLORIDA STATUTES.

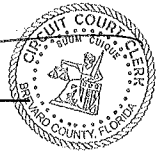

Since March 10, 2021, STEL BAILEY has slandered + attacked me on social media and at Titusville City Council meetings a total of fifteen times. She has misrepresented comments I made about unrelated topics by posting them with the implication that they referred to her water activism. My husband was the Director of Water Resources in Titusville from 2007 until January of 2023. In August 2022, I consulted an attorney due to Stel Bailey's (then 13) attacks on me. Since I was unable to prove fiscal damages and was considered a "quasi-city employee", he did not suggest pursuing the case. At that point, I tuned Miss Bailey out and communicated that to all my friends and family. However, on Sunday 3rd Jan, I received a text from a friend that included a screenshot of Stel Bailey implying I had something to do with "death threats" sent to her via mail.

in 2018. (my first and only interaction with Stel Bailey, online or otherwise, was on 3/10/2021.) I then made a public social media post saying, "STEL BAILEY, STOP ATTACKING ME ONLINE....." ~~AND~~ Then on Monday, 3/27, Stel Bailey posted photos of my child with her name and Facebook profile. She did this twice! Stel Bailey continued from there and once again accused me of threatening her with physical violence. This is now the 15th time she has slandered me online. And now she is also attacking my children.

On Wednesday, 3/29 I was informed by my employer (Titusville YMCA) that Stel Bailey had conspired with a member to file a formal complaint against me. This member, Stan Johnston, has been a vocal public detractor of my husband for over a decade - all well documented

through City of Titusville public records. Stel Bailey has never been and is not currently a member of the Titusville YMCA.

Stel Bailey has used online harassment of myself and my husband to further her water activism self-interests. This has gone on for over 2 years. Neither myself nor my husband is affiliated with the City of Titusville Water Department anymore, yet Stel Bailey continues to attack us as regular citizens. She has now included our children in those attacks and has also attempted to get me fired from my job - and for the sole purpose of a personal vendetta against me.

Stel Bailey has gone to new lengths to spite me and my family, and I cannot rule out physical violence as part of these amped-up measures.

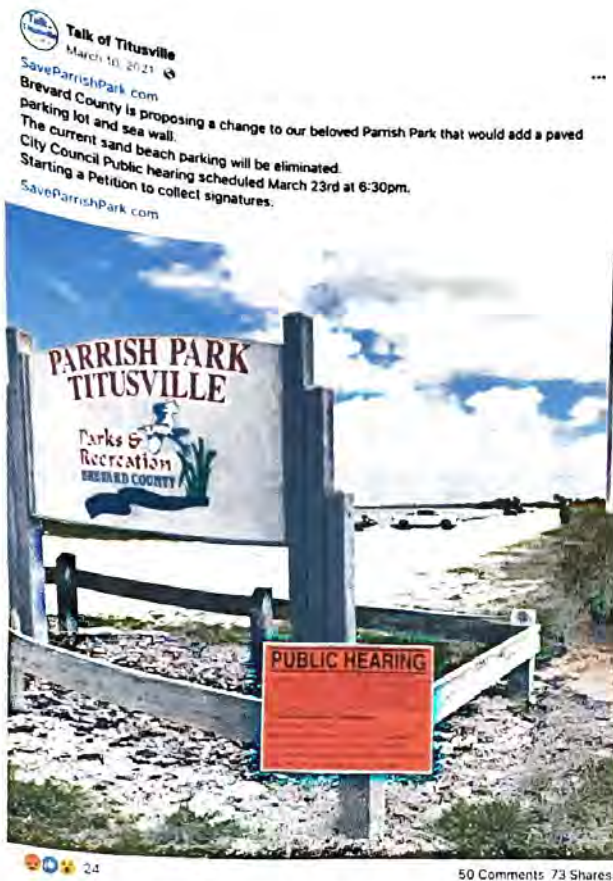

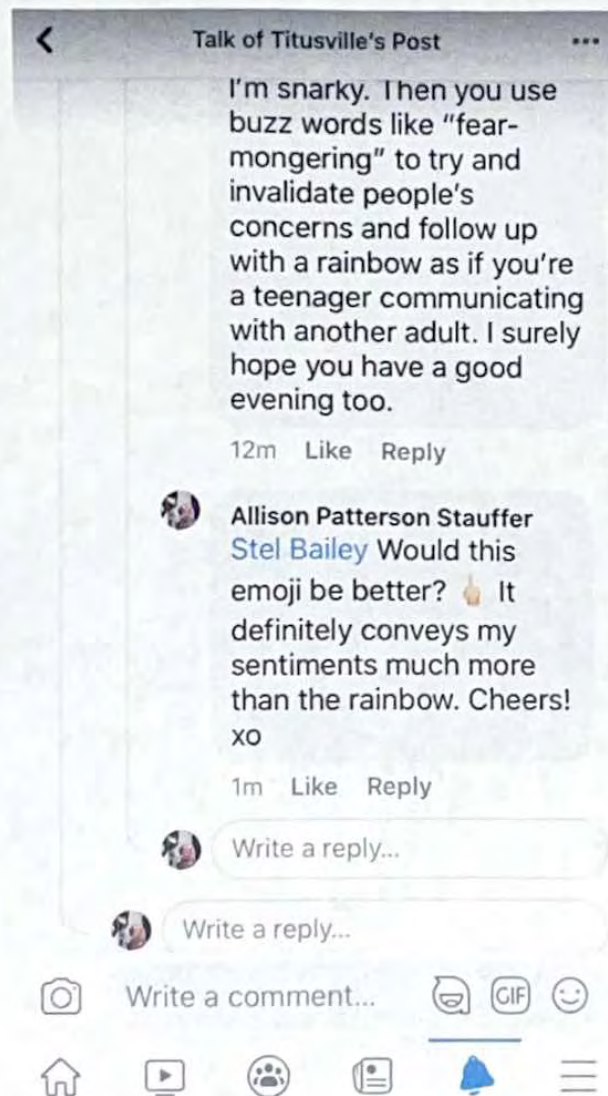

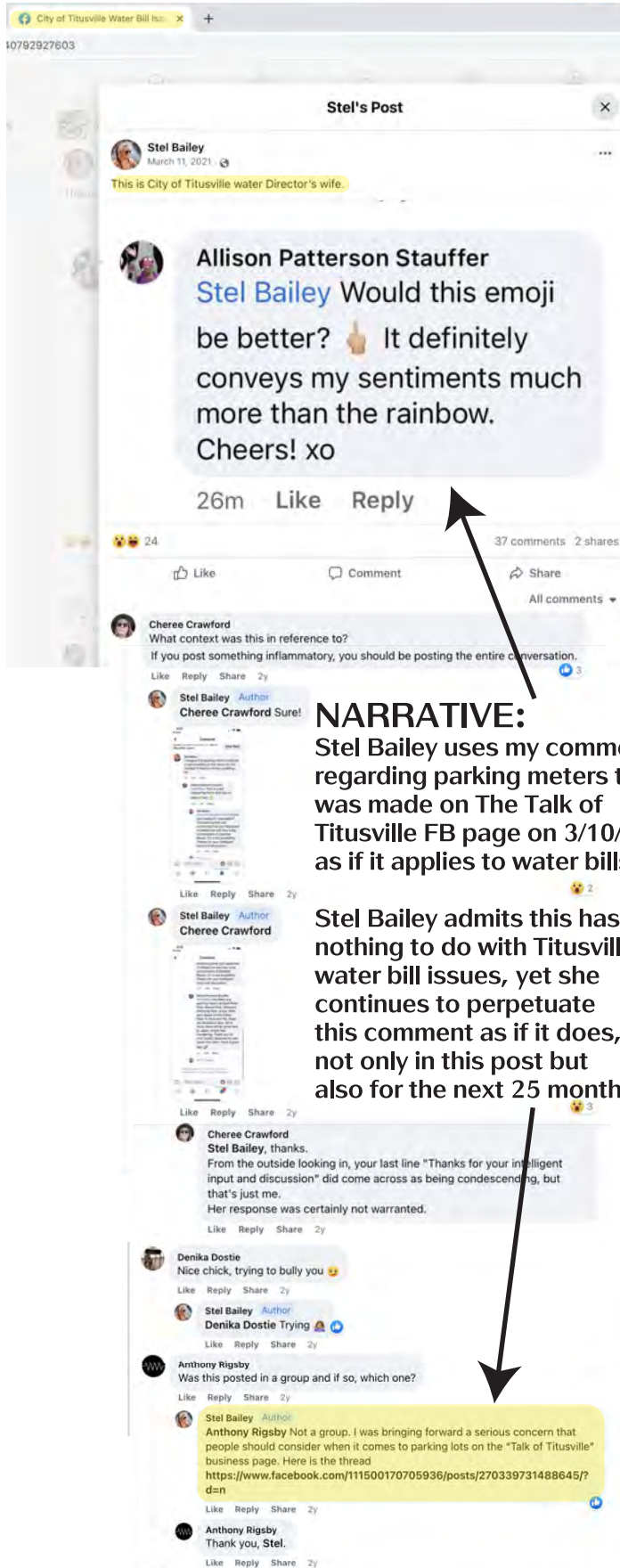
This one comment appears to have been deleted from the thread on Talk of Titusville page (March 10, 2021), so I've included it here and noted the placement in the conversation.

The two people who are employed by Hilton Melbourne Beach Oceanfront are 'Elvis Wilks' and 'Erin Ward' as identified in this perjured complaint.

In his complaint, Dan Willemijn claims/writes:

"At about 3:10 PM a friend of mine (Stel Bailey) sent me a message on Facebook Messenger, informing me that Matt Fleming had just shared my home address in a comment thread at 2:46 PM, along with insinuations that I am working with corrupt government entities and trying to pollute the Indian River Lagoon. Stel was concerned with my safety and rightfully so. For months now Mr. Fleming has been making these wild accusations about me on social media. Up until now I have brushed them off as harmless talk.

Within minutes of receiving the message from Stel, as I was walking around our hotel pool deck doing my beginning-of-shift systems checks, I observed Mr. Fleming walking towards me with this grin on his face that sent chills down my spine. We said nothing to each other, I went about my job checking the pumps and chemical feeders for the pool and the spa, and when I emerged from the fenced off spa pump area I noticed that Mr. Fleming was no longer anywhere on our pool deck."

"Mental/emotional - Every time I think about what he has done to me I get physically sick to my stomach and my legs feel like they're going to give out."

In a group chat, he claims he saw me at around 3:15 and again at 3:45.

I was not at the Hilton or anywhere near it at anytime that day or any day in recent memory.

But that leaves the open question of his motives and malice. Why would he claim to be frightened by me? I have never once threatened him. I have never intimidated to him or anyone that I would hurt or harm him. I HAVE NEVER wanted or wished Dan harm in any way shape or form. I still don't.

So, what started it?

1. The reason he was contacted by Stel Bailey of Fight for Zero is because I made the accusation on a fb post that "they", specifically meaning Stel Bailey and Libby Ann Higbee, are working directly for the "people who caused all the problems" in the lagoon.

2. The people I say "they are working for" are Republican elected officials and/or certain government bureaucrats. I stand by that assertion.

3. I was challenged on that assertion by Stel's friend, Elizabeth Baker, in a very long and obscure comment thread, in a relatively small group I admin.

4. In defense of my statement, I shared screen shots of Stel and DP's [Sunbiz.org](#) public LLC information and told her, Elizabeth Baker, to ask them. (Screenshot below)
5. So that's what Stel texted him. Stel Bailey and DP Willemijn have both claimed in the past to me that they have a written non-disclosure agreement.

Stel Bailey is claiming on social media that I "doxxed" her by sharing that screenshot and that I am "helping cyberstalk and encourage ongoing harassment of her family and kids" which is ABSOLUTELY as false and outrageous as DP's claim that I was at the Hilton on May 8th, 2022.

Recently Stel said, "they have been stalking me since 2018," in another online forum referencing me specifically. That's outrageously false. In 2019 I helped her and others make a video, in 2020, we coordinated to host bridge protests demanding clean water. As recently as January of 2021, I was camping up near Ocala with several ppl which included her.

Her comments come alongside those from a woman named Karen Colby. Karen Colby once publicly claimed I was "antifa" insinuating that I was a "terrorist" after an executive order issued in 2020 labeling "antifa" as a terrorist org. Randy Fine has slanderously called me an anti-Semite, and he is known to have been coordinating to some degree Karen Colby's actions at THAT point in time. He tells Karen Colby I should be treated like "David Duke" who is the former leader of the KKK (I wish I was making any of this up 😬)

Fact: I have never threatened, harassed, stalked, defamed, or otherwise harmed Stel Bailey or Karen Colby.

Interestingly, some years back, DP had filed a stalking affidavit against a woman named Erin Heggedus in what can only be described as a coordinated and malicious character assassination campaign. I have no criminal history of violence or threats, except for the pending charge against me, and legally I am innocent of that until proven guilty. I maintain my innocence regardless, and the facts will bare that out as well.

2. When asked by members of that chat if he had any images or security footage to support his wild and false accusations, he demurs and says the sworn statements from his co-workers would suffice.

3. On the petition for the injunction, question #2 asks: How long has this type of conduct been going on?

He writes: Since 2020.

4. Yet, on November 3rd of 2020 we both manned a voting booth as volunteers during voting at the Satellite Beach precinct location. That's well documented and publicly available.

5. On January 5th of 2021 we were riding around in my truck with the pressure washer spraying in the air and music playing on loudspeakers near a "Stop The Steal" rally where a bunch of in clowns were yelling epithets and whatnot at people in cars bc they were mad that Trump lost the election. That too, is well documented and publicly available info.

A file review conducted on May 5, 2022, found an **unauthorized discharge** that occurred from your system that is grounds for a stipulated penalty after the completion of the evaluation using the Sanitary Sewer Overflow Tool noted in paragraph 10(b) of the referenced Order. Based on paragraph 10(b) of the referenced Order the Department is assessing a total stipulated penalty of \$15,750.00. The penalty was calculated as follows:

- On February 8, 2022 a release of 50 gallons of untreated wastewater, with direct impact to the Indian River, was reported to the Department for which a stipulated penalty of \$750.00 is being assessed.
- From April 5, 2022 to April 12, 2022 a release of 175,200 gallons of untreated wastewater was reported to the Department for which a stipulated penalty of \$15,000.00 is being assessed.

The stipulated penalties are owed within 30 days of the Department's issuance of the stipulated penalty letter and payments shall be made as described in paragraphs 11 and 15 of the above referenced order.
