## Notice Regarding Buyer's Right to Cancel:

The completed contract between the member and PPL Legal Care of Canada Corporation consists of this application, a document which contains the description of benefits, and a Buyer's Right to Cancel clause which can be found on the face of the description of benefits document, the latter two of which will be mailed to you upon receipt of payment. You may cancel your membership at any time after receipt of these materials.

**In British Columbia:** (i) If no delivery date is specified in the contract and the goods are not supplied within 120 days after the date of the contract, then you, the buyer, may cancel the contract within 10 days after the expiry of this 120 day period provided that you have not accepted delivery of the goods; and (ii) this is a contract to which the Consumer Protection Act of British Columbia applies.

**In Nova Scotia:** Between 30 and 60 days before the contract expires, PPL Legal Care of Canada will provide you with a written notice stating (i) the date that the contract is set to expire, and that the notice is written notice that the contract will terminate on that date; or (ii) the date that the contract is set to expire, but that the contract will be automatically extended, on a monthly basis and on the same terms, until either you or PPL Legal Care of Canada gives notice to the other that the contract is not to be further extended.

In New Brunswick and Saskatchewan: You may cancel this Contract from the day you enter into the Contract until 10 days after you receive a copy of the Contract. You do not need a reason to cancel. ## Privacy Policy & Practices for PPL Legal Care of Canada Corporation

a subsidiary of Pre-Paid Legal Services®, Inc.

Protecting personal information is a priority for PPL Legal Care Canada Corporation ("PPL Canada") and Pre-Paid Legal Services, Inc. ("PPLSI") (collectively, "PPL", "we", "us", "our"). To enable us to provide you with membership plans, we need to collect certain personal information from you. However, we want to emphasize that we are committed to maintaining the privacy of this information in accordance with applicable law. This Privacy Statement explains what personal information we collect about members in Canada (whether online or offline) and how we treat that information. This Privacy Policy does not apply to PPL employees.

#### How We Collect, Use and Disclose Member Information

If you apply to become a PPL member, we will collect personal information from you, including: your name; contact information; date of birth; Social Insurance Number ("SIN") or, for business members, the GST Registration Number; the name and date of birth of your spouse and dependants; and your banking, credit card or payroll information. If you become a PPL member, we will also collect the plan and payment information generated through your ongoing membership with PPL as well as quality of service reports from provider lawyers.

We typically use the personal information collected to process, administer and manage your membership and payments; to determine the appropriate planservices and resources to be offered; to respond to your inquiries; to generally manage our business; and to meet legal, regulatory, processing and security requirements. If you provide your SIN or GST Registration Number, we will use it for member identification purposes. If you do not opt out on the membership application, we will use your e-mail address to send you updates about your membership.

We disclose: certain portions of the information collected in the membership application to the Writing Associate of your membership, so that the Associate may assist you in the application process and ensure your ongoing satisfaction as a member; your ongoing plan status to the Writing Associate, Regional Vice President and Regional Managers so that they may ensure your ongoing satisfaction as a member and monitor the status of members for whom they are responsible; your contact and plan information to your provider law firm, so that it may identify eligible members; your banking, credit card or payroll information to your bank, credit card company or employer, so that they can process your payments; and, information to be disclosed to meet legal, regulatory, processing and security requirements. In addition, if you provide your consent on the membership application, the Writing Associate may disclose the information collected in the membership application to Membership Advantage Services (MAS), a Pre-Paid Legal membership retention department, so that it may contact you regarding your satisfaction with PPL's services.

If you provide the name and dates of birth of your spouse and dependants, you confirm that they consent to our collection, use and disclosure of their personal information (where applicable) as outlined above, for the purposes of extending plan services to them.

#### Other Transfers and Disclosures of Information

From time to time, PPL may also share your personal information with our third party vendors, suppliers and providers responsible for administering or providing the products and services you requested, on our behalf. We contractually require the organizations with whom we share your personal information for these purposes to have policies regarding personal information consistent with our Privacy Policy or to abide by our policies as relevant to the personal information shared with them.

We may also use and disclose your personal information to parties connected with the contemplated or actual financing, insuring, sale, assignment or other disposal of all or part of our business or assets, including for the purposes of determining whether to proceed with such transaction or fulfilling any records or other reporting requirements to such parties. We will require that such parties treat your personal information in accordance with this Privacy Policy and to use and disclose it only for the purposes for which it was collected, including to provide the products, services or information that PPL would otherwise provide to you and generally to carry on the PPL business.

#### Your Consent

If you choose to provide personal information to PPL, we assume that you consent to the collection, use and disclosure of your personal information as outlined in this Privacy Policy. If you do not consent, please do not provide your personal information or, where applicable, exercise the opt-in or opt-out options offered. Subject to legal and contractual requirements, you may refuse to consent to our collection, use or disclosure of information about you or you may withdraw your consent to our further collection, use or disclosure of information about you by contacting the Privacy Officer at memberservices@legalshield.com, or call 580-436-7424. We will explain the consequences of the withdrawal of your consent.

If PPL requests additional personal information or intends to use or disclose your personal information differently than described in this Privacy Policy, we will advise you at or before the time of collection, use or disclosure (as the case may be) as to how we will handle that personal information. PPL will not collect, use or disclose personal information other than as described herein, or at the time of collection, use or disclosure (as the case may be), or as otherwise required or permitted by law. There are limited instances where PPL may collect, use or disclose your personal information without your consent, for example to collect a debt owed to us or to comply with a court order.

#### Security and Retention

We maintain appropriate physical, organizational and technological safeguards, appropriate to the nature and sensitivity of the personal information, to protect your personal information from unauthorized access, loss, or misuse. Only authorized PPL employees and agents that need to access your personal information will have access to it.

You can generally visit the PPL Website without revealing any personal information. PPL takes precautions to ensure the security of any personal information submitted by you to PPL on-line. However, given that unencrypted electronically transmitted data is not 100% secure, we make no warranties as to the security of any such information that you submit electronically, which you do at your own risk.

#### Access, Correction, Inquiries and Complaints

We maintain a file of your personal information for the above purposes. This file is accessible at One Pre-Paid Way, Ada, Oklahoma, 74820. If you wish to request access to, or correction of, your personal information in PPL's records, please make your request in writing to Privacy Officer at memberservices@legalshield.com, or One Pre-Paid Way, Ada, Oklahoma 74820. Some information may not be accessed in certain circumstances, for example if it contains personal information of other persons or for other legal reasons. #### The Internet

Generally speaking, you can visit the PPL Website without providing personal information about yourself. However, a technology called cookies may be used to provide you with tailored information. A cookie is a tiny element of data that a Website can send to your browser, which may then be stored on your hard drive so we can recognize you when you return. You may set your browser to notify you when you receive a cookie and you may choose to disable cookies if you wish.

PPL's Website may contain links to other Internet sites owned and operated by third parties. While we try to link only to sites that share our high standards and respect for privacy, we are not responsible for the content or the privacy practices employed by other sites. You should review the privacy policies applicable to the other sites before you provide any personal information on those sites.

The PPL Website logs IP addresses (or domain names), but not the e-mail addresses, of visitors. This information is aggregated and logged, and used to measure statistical information about usage of the Website, including but not limited to the total number of visits, average time spent on the Website, and pages viewed, both in real-time, and within a certain historical time frame. PPL uses this aggregated information to measure the use of our Website and to improve the content and usage of our Website.
