



## A Case Study of a progressive charter school in Makawao, Hawaii

### Confronting Persistent Security Concerns On Premise



#### Challenge

A progressive charter school in Makawao, Hawaii, confronted persistent security concerns within its premises. The improvements scheduled for the video surveillance system will significantly enhancing monitoring capabilities within the charter school, while the upgrading access control software for the security of restricted areas. The addition of panic buttons and intercom systems will greatly improve emergency communication, and reinforce locks and doors providing an additional layer of physical protection.

Most importantly, the implementation of an active threat training program equipping both staff and students with the knowledge and skills needed to respond effectively to potential threats will be invaluable. Collectively, these security enhancements will instill a newfound sense of confidence and preparedness within the school's community. Staff and students will feel safer and more reassured, knowing that proactive measures are being taken to mitigate potential security risks.

The successful acquisition of grant funding and the subsequent implementation of comprehensive security measures demonstrated the charter school's unwavering commitment to the safety and well-being of its students and staff.
