Seller Guarantees:

- 1) Puppy is the breed, mix, generation, and from the parent dogs listed above.
- 2) Puppy is age-appropriately vaccinated and dewormed.
- 3) Puppy has been examined by a veterinarian, and is believed to be healthy and fit for sale.
- 4) Puppy is warranted free of genetic **hip, elbow, eye and heart** problems until the age of 24 months. Buyer may extend this warranty until 36 months by feeding breeder approved products.
- 5) The puppy has been microchipped.
- 6) That if within 10 days after receipt by the buyer, a veterinarian states in writing (referencing the puppy's unique microchip number) that the puppy has a health problem which existed in the animal at the time of delivery, but was not disclosed under the provisions of section 4152, the puppy shall be considered "unfit for sale," and the breeder shall provide the purchaser with his or her choice of:
 - A. Return of the puppy for a refund of the full purchase price of the puppy;
 - B. A replacement puppy of purchaser's choice of equivalent value, providing a replacement is available; or
 - C. Retainment of the animal and reimbursement for $\frac{1}{2}$ of the reasonable veterinary fees up to $\frac{1}{2}$ of the purchase price of the puppy.
- 7) That if within 10 days after receipt by the buyer, a veterinarian states in writing (referencing the puppy's unique microchip number) that the puppy has died from a health problem which existed in the animal at the time of delivery, but was not disclosed under the provisions of section 4152, the breeder shall provide the purchaser with his or her choice of:
 - A. A puppy of equal value, if available; or
 - B. A refund of the full purchase price of the puppy.
- 8) That if, within one year (12 months) after buyer receives a dog, a veterinarian states in writing (referencing the puppy's unique microchip number) that due to a hereditary or congenital defect, the animal has died or has a condition that will shorten its life or will require constant treatment during its life, the animal is considered to have been "unfit for sale" at the time of sale. In such a case, the breeder shall provide the buyer with his or her choice of:
 - A. Return of the puppy for a refund of the full purchase price of the puppy;
 - B. A replacement puppy of purchaser's choice of equivalent value, providing a replacement is available; or
 - C. Reimbursement for $\frac{1}{2}$ the reasonable veterinary fees up to $\frac{1}{2}$ of the purchase price of the puppy.
- 9) That, by the time a purchased puppy is 24 months of age, a veterinarian states in writing (referencing the puppy's unique microchip number) that the dog has a life-threatening, or seriously life-altering hereditary defect of the hips, elbows, eyes or heart, the breeder will: replace the dog with a puppy of equal or greater value (no return of dog needed),

OR

reimburse the 75% of veterinary expenses up to 75% of the original purchase price.

** This guarantee is automatically extended to 36 months of age if the puppy/dog has been maintained exclusively on breeder recommended food <u>and</u> supplements. Continual, active autoship/order records will be used as evidence of product use.

Notes:

After the 10-day period required by the State of Maine, this guarantee does not include viral illnesses, infections, hernias, hypoglycemia, intestinal parasites, improper bites including (base narrow canines), giardia or coccidiosis. It also does not include any illness due to the ingestion of foreign objects, toxic plants, food, chemicals or physical injury occurring after the puppy has left the breeder's premises. In the case of Base Narrow Canines, when the adult tooth is growing into the soft palate (which is very rare) the cost of filing up to \$250 per tooth will be refunded. In the case of an umbilical hernia which needs to be repaired, the breeder will reimburse up to \$250 for the hernia repair when it is done at the same time as the spay or neuter surgery. Should a male puppy have undescended testicles by the time of his neuter (6 months or older) Seller agrees to refund up to \$250 of the extra cost (above normal neuter) when it is done at the same time as the neuter surgery

The breeder has the right to refuse sale to a potential buyer who appears not to accept or understand the provisions of this contract and/or Animal Welfare laws of the State of Maine.

Prior to replacing the dog or reimbursing veterinary expenses, the Breeder has the right to review all reports, x-rays and test results supplied by Buyer's veterinarian

In order to obtain the above remedies, the buyer must:

- A. Notify the breeder, within 2 business days of the diagnosis by a veterinarian;
- B. Provide the breeder with the name and telephone number of the veterinarian; and
- C. Provide the breeder with a copy of the veterinarian's report on the animal.
- D. Return the puppy or dog no later than two (2) business days after receipt of the veterinarian's written statement indicating that the animal is unfit for sale due to a health problem.

A refund, replacement, or reimbursement of veterinary fees will **not** be required if any of the following conditions are met:

- A. The health problem or death resulted from maltreatment from an injury sustained subsequent to receipt of the puppy or dog by the buyer.
- B. A disclosure statement was provided to the purchaser pursuant to section 4152 of Maine Revised Statutes, Title 7: AGRICULTURE AND ANIMALS Chapter 745: SALE OF DOGS AND CATS. See "Disclosures" below.
- C. The health problem is a hereditary or congenital one covered by section 4152 of Maine Revised Statutes, Title 7: AGRICULTURE AND ANIMALS Chapter 745: SALE OF DOGS AND CATS.

Buyer Guarantees:

To have the puppy examined by a licensed veterinarian within 10 days of arriving at Buyer's home.

**During this visit, please ask your veterinarian to scan and record the microchip number.

To pay the entire purchase amount prior to taking possession of the puppy.

To bear all costs related to the transportation of the puppy/dog. The risk of loss or injury to the above described animal is on the Buyer at all times after the puppy/ dog leaves the Breeder. To have the dog spayed or neutered at or before 26 months of age.

To notify the Breeder if Buyer is at any time unable to keep the dog. Acadia Goldendoodles puppies/dogs should never end up in a second home or animal shelter. Breeder will attempt to re-home the dog to an approved home, after providing any necessary rehabilitation or training. Buyer will receive 50% of the selling price if Breeder is able to re-sell the dog, understanding that older dogs are usually sold at lower prices than puppies. If an appropriate home is not found, the dog will continue to live with the Breeder and no reimbursement will be issued.

Not to let this dog roam at large or be tied outside the home.

To properly house, care for, train and exercise the dog, while providing appropriate veterinary care throughout the life of the dog.
