Compatible with all insecticide, fungicide and other nutritional.

Palm trees, hardwoods and fruit trees: Add 1 pint to 1 quart per 50gl. water.

Apply as a drench under the drip line plus foliar application. Can be added to arbor jet systems for enhanced delivery into xylem.

Transplant application: 1 pint per 50gl water.
