

NECTR COMMUNITY ATHLETICS **ATHLETE & PARENT WAIVER AND RELEASE** **OF LIABILITY**

This Waiver and Release of Liability (“Agreement”) is executed by the undersigned parent or legal guardian (“Parent/Guardian”) on behalf of the minor participant (“Athlete”) in favor of NecTr Community Athletics, including all affiliated entities, its owners, directors, officers, employees, coaches, volunteers, contractors, sponsors, partners, venues, and any associated organizations or individuals (collectively referred to as the “Released Parties”).

This Agreement applies to participation in the Elite Flag Series Combine and any related activities, programs, events, travel, and associated functions (the “Event”).

1. VOLUNTARY PARTICIPATION

I acknowledge that my child is voluntarily participating in the Event. I understand that participation is not required and may be withdrawn at any time at my discretion. I further acknowledge that participation is a privilege and subject to compliance with all rules and expectations established by NecTr Community Athletics.

2. ASSUMPTION OF RISK

I understand and acknowledge that participation in athletic activities involves inherent risks, including but not limited to:

- Physical injury, including serious injury or death
- Contact-related incidents
- Falls, slips, and collisions
- Heat-related illness, dehydration, or exhaustion
- Equipment-related injuries
- Exposure to other participants and environmental conditions
- Other known and unknown risks

I knowingly and voluntarily assume all risks associated with my child’s participation, whether foreseeable or unforeseeable, and accept full responsibility for any injuries or damages that may occur.

3. RELEASE AND WAIVER OF LIABILITY

To the fullest extent permitted by law, I hereby release, waive, discharge, and covenant not to sue the Released Parties from any and all claims, demands, damages, causes of action, liabilities, or losses arising out of or related to my child's participation in the Event.

This includes, but is not limited to:

- Personal injury, illness, or death
- Property damage or loss
- Accidents occurring before, during, or after the Event
- Negligence of the Released Parties

I understand that this release is intended to be as broad and inclusive as permitted by applicable law.

4. MEDICAL AUTHORIZATION

I authorize NecTr Community Athletics and its representatives to obtain emergency medical treatment for my child if deemed necessary.

I understand and agree that:

- I am responsible for all medical expenses incurred
 - The Organization does not provide medical insurance coverage
 - Efforts will be made to contact me prior to treatment when possible

5. CODE OF CONDUCT AGREEMENT

I understand that my child is expected to:

- Follow all rules, instructions, and safety guidelines
- Demonstrate good sportsmanship and respect
- Conduct themselves in a positive and appropriate manner

Failure to comply may result in removal from the Event without refund.

6. MEDIA RELEASE

I grant NecTr Community Athletics permission to photograph, video record, and otherwise capture my child's participation during the Event.

I authorize the use of my child's image, likeness, voice, and performance for promotional, marketing, social media, and media purposes without compensation or further approval.

7. NO GUARANTEE OF SELECTION OR RECRUITMENT

I understand that participation in the Event does not guarantee:

- Selection to any team or program
- Placement within any organization
- Recruitment or exposure opportunities

All decisions are based on evaluation, performance, and organizational needs.

8. NON-REFUND POLICY

I understand that all registration fees are non-refundable unless the Event is canceled by NecTr Community Athletics.

9. GOVERNING LAW

This Agreement shall be governed by and interpreted in accordance with the laws of the State of Alabama.

10. ACKNOWLEDGMENT AND AGREEMENT

I acknowledge that:

- I have read and fully understand this Agreement
- I voluntarily agree to its terms on behalf of my child
- I understand that NecTr Community Athletics is not responsible for transportation to or from the Event. Any transportation provided is voluntary and at the parent/guardian's risk.
- I, as the parent/legal guardian, give full permission for my child to participate in all activities associated with this event.
- I understand that while supervision will be provided, NecTr Community Athletics cannot provide one-on-one supervision for each participant at all times.
- I certify that my child is physically fit to participate in athletic activities and has no medical conditions that would prevent safe participation.

- NecTr Community Athletics reserves the right to remove any participant for unsafe behavior, misconduct, or failure to follow instructions, without refund.
- NecTr Community Athletics is not responsible for lost, stolen, or damaged personal belongings.
- I acknowledge the risks associated with outdoor activity in hot weather conditions, including heat exhaustion and dehydration.
- I understand the risks associated with head injuries and agree to notify staff immediately if symptoms occur.
- I understand that I am giving up certain legal rights
