DD Form 370, Request for Reference, is used for requesting additional data about an applicant wishing to enlist in the Armed Forces of the United States. The provided information helps to determine whether or not the applicant meets the criteria to become a member of the Army. The latest version of the form - sometimes confused with the DA Form 370, Request for Alteration and Repairs - was released by the Department of Defense (DoD) on April 1, 2021, with all previous editions obsolete. An up-to-date DD Form 370 fillable version is available for download and digital filing below or can be found through the Executive Services Directorate website. The data included in the DD 370 Form becomes a part of the military personnel records of the applicant. The request is sent to a past employer, an official or church representative chosen by the applicant. The answers received through the form assist in determining whether the applicant fits the standards of the U.S. Armed Forces.

The individual responsible for initiating and sending out the form is the recruiter or the appropriate recruiting personnel. The responsible official should strictly keep to the following rules: The DP Form 370 cannot be given to the applicant to complete under any circumstances; The document is either given directly to the recruiter or recruiting personnel or mailed to the institution; The commanding officer may request two types of references: employer references and personal references. References from relatives are not accepted. The references may be requested through a DD 370 form or via a phone call. All of the information provided in the document is strictly confidential. It is used to make a subjective judgment on an applicant's suitability. The recruiter is not allowed to divulge it either to the applicant or upon special request. Disclosure of the data is a criminal offense and may lead to a fine or imprisonment. Confidentiality is especially important if the applicant is later rejected. The paper should be filled out and returned as soon as possible. For the convenience of the person completing the document, the return envelope requires no postage enclosed. The instructions for completing the DD 370 are as follows: The first box should contain the name and address of the law enforcement agency to which the completed document must be returned. 21523525707.pdf

Next is the applicant's identification data. Boxes 1 through 4 are for providing their full name, a mailing address, the date of birth, and dates of school attendance or employment. The entire next block is meant for the individual tasked with providing a reference for the applicant. It contains an explanation of the form, an assurance of strict confidentiality, and the release of any responsibility for the applicant's conduct if accepted or not accepted. The next part of the form - Boxes 5 through 9 - requires the name of the recruiting officer, their unit or command name, a signature, the date of signing, and a mailing address of the unit or command. Boxes 10 through 14 are designed to define the relationship of the person completing the questionnaire to the applicant. Box 15 requires providing an assessment of the applicant's qualities. The applicant's relationship with alcohol or drugs should be described in Boxes 16 and 17 if there is a reason to assume that it may prevent them from performing their duties in the Army. Box 18 is intended for a personal narrative about the applicant and for a detailed explanation of Box 16 and 17 if those were answered positively. Before sending the form back to recruiters, the individual filing the questionnaire has to provide their name and title before signing and dating the form. The DD Form 370 is a form used to obtain personal and professional references for a prospective military applicant. This form is also used for processing enlistment waivers. It is a part of the package for all new US Army recruits. It is important for recruiters to understand the confidentiality of reference information. The individual providing the reference must agree to keep all details of the applicant confidential. [91563282020.pdf](#) All applications for enlistment will have a sex offender query conducted before enlistment. This query includes a search of all territories and states to verify that the applicant's name, age, and address match those of a sex offender. Applicants will be notified of their sex offender match if the result is positive. Applicants who do not have any law violations are not required to get a police record check. However, applicants who have been convicted of a new offense or a repeat offense are required to get a court check. Applicants who are self-employed are required to obtain a DD Form 370 from someone who performed services for the applicant.

Additional, photocopies of these references may be included in the applicant's pre-enlistment kit. During an interview, an individual will fill out a NAVCRUIT Form 1131.5. They will then give the form to the recruiter. A commanding officer or a school administrator may request a reference from an employer. Where Can I Find a DD Form 370? DD Form 370 is an important document for US uniformed services. It is used to verify the identity of an applicant and to gather personal reference data on them. This form is also used to request copies of official military personnel records. Applicants who want to be assigned to the US Army may be required to complete a DD Form 370. Applicants who are already in the US military or have civilian work experience are not required to complete this form. However, this form is important to determine the applicant's suitability for the US military. Enlistees are responsible for ensuring that the information provided on the form is accurate. They must indicate any rights they have regarding the information contained in the form. A recruiter may not release any of the information provided in the form without the applicant's permission. The results of the query will include the name, age, and reported address matches. Enlistees will have the option of submitting a character reference. Personal references may include schoolteachers, pastors, or church members. Employer references are also acceptable.

DD Form 370 - Request for Reference The DD Form 370 is a document that is part of the application process for military service. It is used to obtain personal and professional references for applicants. Applicants may also be required to submit a character reference. [theological workbook of the old testament pdf](#) If a person is a current or former employer, a commanding officer can request a reference through telephonic procedures. Alternatively, a school, a community leader, or a church pastor may be used as a personal reference. This information will help to determine a person's eligibility for service in the military. Those requesting a reference should be aware that it is a confidential document. Disclosing any information about the reference may lead to fines. In addition, anyone who provides a reference will have to sign a questionnaire. Those who provide references will be asked to indicate the circumstances in which they volunteered their services. The DD Form 370 is not provided to the applicant, but it can be printed or downloaded.

Applicants can also export the form to a digital device or share it via email. Using the form, a person providing a reference will be asked to write a statement about why the applicant should be considered for a position.
