**2. What are your qualifications to run for a Judicial Seat? What specific accomplishments in your past have qualified you for this?**

I am a graduate of Duquesne University Law School. I have been a trial attorney for 26 years. Over the course of my career, I have had dozens of jury trials and bench trials. I have navigated both trial and investigative processes which has given me an understanding of both the law and courtroom procedures.

I have the ability to analyze evidence thoroughly, weigh evidence objectively and make informed decisions based on my evaluation.

**3. Describe the nature of your legal practice since graduating from law school, including the percentage of your practice dedicated to litigation and whether you appeared in court frequently, occasionally, or not at all.**

After graduation from law school, I was the judicial law clerk for the Honorable Cynthia Baldwin. I joined the Allegheny County District Attorney's Office in 1998. I appeared in court daily representing the Commonwealth of Pennsylvania. I served in the Domestic Violence Unit, Violent Crimes and Firearms Unit and the Child Abuse Unit. I was promoted to Deputy District Attorney and placed in charge of the General Trial Unit along with three other supervisors. The General Trial Unit was made up of approximately 18 attorneys. I was responsible for giving guidance and assistance in preparing and presenting their cases or trial.

In 2014, I joined the Pennsylvania Office of Attorney General. I prosecuted various crimes in 23 counties in Western Pennsylvania. I was promoted to Assistant Chief Deputy Attorney General of the Criminal prosecution Section. In this capacity, I am responsible for overseeing the day to day operation of the office in the West and the supervision of trial attorneys. In addition to my supervisory responsibilities, I also led the Pennsylvania Office of Attorney General Medical Legal Advisory Board on Child Abuse.

I have appeared in court on a regular basis and 100% of my work has been in litigation.

Over the course of my career, I have been committed to justice, fairness, and the rule of law. I have witnessed firsthand the impact that the judiciary can have on individuals. I aspire to contribute meaningfully to a system that protects individual rights and uphold the principles of justice. My career demonstrates a steadfast commitment to public service, extensive courtroom experience and proven leadership in both trial and supervisory roles. **19. Please explain your thoughts on cashless bail? i.e. when is it appropriate and when is it not appropriate?**

Bail is not to be considered a punishment but to ensure that a person returns to court. When determining whether a person should be released on cashless bail several factors are considered, such as, whether the charges are nonviolent, does the person have long standing residency in the community, family connection, whether the person works, the likelihood the person will appear in court, whether they have failed to attend other hearings, whether they have given previously false information about themselves, not a threat to community or person's safety. These factors are not exhaustive but are important to considering whether to give cashless bail.

**20. Are you familiar with Senate Bill ("SB") 752 (Expanding Diversion; Focusing Detention and Out-of-Home Placements; Related Juvenile Justice Reforms)? Please explain whether you support the bill and explain your reasoning.**

I am not familiar with SB 752 but I reviewed the components of the Bill. Without having a complete understanding of how effective the Bill would be or what type of crimes would be included or counter arguments to the Bill, it is difficult to state definitively whether I support the Bill. I am in support of improving the outcomes of the youth. I also agree that there should be state-wide consistency in pretrial diversion to avoid disparity between communities that receive diversion and those that do not.

I have had to overcome challenges that have strengthened my resilience, humility and ability to relate to those experiencing difficulties. I have also had to make ethical decisions under scrutiny which has shaped my integrity and commitment to fairness. My life and experiences outside of my profession, such as raising children, volunteering in the community, and overcoming setbacks, has fostered patience, empathy and humility.
