Cross Lake Education Authority invites applications for the position one (1) full-time Student Wellness Counsellor position. This position is based at the CLEA Mikisew School Cross Lake with duties commencing November 2025.

POSITION SUMMARY

The Student Wellness Counsellor will be responsible for providing individual support to students that require additional support on their personal, emotional and intellectual development support at Mikisew school.

The counsellor will collaborate with teachers and the student's family in addressing the physical, emotional and intellectual development needs of the student and to increase parent knowledge on supporting their child's education to ensure their success.

QUALIFICATIONS

Education:

- A bachelor's degree from a recognized post-secondary institution **or** a diploma in Applied Counselling **and/or** similar training and/or experience

Experience:

- Two years of previous experience in providing counselling services

Knowledge and Abilities:

- Knowledge of childhood development
- Knowledge of different learning techniques for children such as special needs students like autism,

- Knowledge of various agencies as potential resource in addressing behavioural issues of students offered by various external organizations such as Nikan Awasisak Agency programs <https://nikanaa.ca>
- Ability to advocate and prioritize student needs and requirements,
- Ability to conduct presentations to students, CLEA staff and management, community leadership, parents and agencies.

REQUIREMENT

- A majority of CLEA employment positions are considered “safety sensitive positions” (working with children) that may require drug testing of employees, as a condition of employment, if a manager/supervisor has reasonable cause to suspect that an employee is under the influence of an illegal drug. This authority for this policy is under the Cross Lake Band of Indians By-law #276-105-25. A by-law to Prohibit Illegal Drugs.
- The successful candidate will be required to provide a Criminal Record Check and Child Abuse Registry Check at start of employment and updated checks every two (2) years during employment
