## Grants Status Updates --- Program Manager Reports

- Check-in on Grantees: For full information, please consult the workplan.
  - ➤ COVID-19 Emergency
    - Chris 180
      - Submitted an expenditure report, but has had issues with spending down their grant
      - Expecting to spend the rest of the grant amount in the next few weeks
    - Emmaus House
      - Documentation needed to process next payment
      - Natasha will check in with them to receive the documents
      - Suggestion that organizations that provide food must provide quality food and organizations with staff must pay their staff a living wage
        - Requires changes to RFP
        - Questions around enforcement
        - Clarification: give additional points during proposal review phase for organizations that pay a liveable wage
  - ➤ Community Care → 2019 Grantee
    - Awaiting documentation to close out this grant
  - > 555
    - First payment was received
    - Funds not completed expended due to COVID
    - Last report said that \$1750 was spent
    - Extension requested through June of 2021
- Grant Overview Session
  - ➤ There was a session on 1/5/2021
  - > 20 participants
  - > 28 proposals received, over \$2 million in requested funds
- Proposal Assignments
  - ➤ As in the past, all committee members will receive their assignments at the February meeting
  - ➤ If any conflict of interest arises, committee members will not be assigned to review that applications
- Stipend Wire Transfer/DoorDash
  - All committee members now have the option for a wire transfer for their stipend
    - Check with bank for fees associated with a wire transfer

- New members should submit a W-9 if they choose to receive a stipend
- DoorDash for Meals During Meetings
  - Members will receive a \$25 e-gift card every 2 months
    - Trying to mirror the \$15/member that was allotted
    - Option to move increment up to \$50
    - Keep in mind that:
      - ◆ The standard delivery fee is \$3.99
      - ◆ DoorDash marks up the prices
      - ◆ Tax and fees are added on to the end
      - ◆ A tip is optional but prefered
  - Proposing to start this in February
  - Motion to increase the member food allowance to \$25/month on a trial basis

  - > Looking for community reviews to give feedback on proposals
  - > Share with community members
  - > Actively looking for reviews to train in the month of February
