### **Ethics Training**

- Carlos Santigo, Deputy Ethics Officer for the City of Atlanta
  - Code of Ethics are part of city law
    - Sections 2-801 through 2-825 in the Atlanta Code of Ordinances
    - Violation is subject to serious consequences
  - Guideline for avoiding violations and appearance of violations of the Code
    - Code is the minimum legal standard
    - Looking at the appearance of impropriety
  - Conflict of Interest: when personal connections interfere with the ability to perform duties objectively
    - Only deals with first degree family members (immediate family) but from appearance standpoint all family members are important to watch out for
    - Only includes current relationships as well but from appearance standpoint be mindful of how long ago the relationship took place
    - When there is conflict of interest the official needs to file an official report with the Ethics Office
      - Make the recusal as soon as the conflict is discovered
  - Personal businesses can only do business with the city if it is part of sealed competitive bid but officials need to recuse themselves from decision making process and disclose through the Ethics office
  - > No gifts and gratuities allowed from a prohibited source
    - Prohibited source: anyone trying to business with the city
  - > There is a 1 Year Cooling Off Period after you leave the committee
  - > Annual City Financial Disclosure due by April 1st each year
