- Distribution of Proposal Reviews
 - Each Committee member is paired with a fellow committee member and sent an email with their slate of proposals they need to review and submit to through the review Google form

 - ➤ Each member also received a link to all the other proposals in case they wanted to look at them before the consensus meeting
 - > The process is the same as before just virtual due to the pandemic
 - > Partners will be given time to deliberate during the consensus session
 - > The committee will not be changing the requested funding amount. The proposal will be approved as is or not approved
 - ➤ The cap for funding requests is \$250,000 and all the funding levels are in the RFP
 - > There was a question about financial homework/ background checks on each organization
 - Organizations need to submit documentation based on their funding request
 - Ensuring that the committee is not funding organizations entire budget or giving them an amount of money that they've never had before
