Military Service Survey



In September 2012, President General of NSSAR, George L. Leishman, announced the creation of the Veterans Recognition Committee.

The committee is in charge of the World War II Veterans Corps, and has now implemented the establishment of the Korean Service Veterans Corps.

In November 2012, the United States Senate approved a bipartisan resolution (602), formally recognizing the 60th Anniversary of the Korean War, and announced the 2013-2014 as the "Year of the Korean War Veteran"

The NSSAR Veterans Recognition Committee has approved a "Certificate of Patriotism", signed by the President General, for Korean War Service Veterans. Which means any Korean War Veteran who served in Korea during the war, or in Korea after the war, and was awarded any of the following medals:

Korean Service Medal; Armed Forces Expeditionary Medal; Korean Defense Service Medal; United Nations Service Medal; Republic of Korea War Service Medal

If any Chapter member is a Korean War Service Veteran, and qualifies for this

Eagle Scout Recognition Program

Since 1980, the SAR and the BSA have had a close relationship as a result of the establishment of the Eagle Scout Recognition Program.

The competition is open to all Eagle Scouts who are currently registered in an active unit and have not reached their 19th birthday during the year of application. (The application year is the calendar year, 01 January to 31 December.) The year that the Eagle rank was awarded is not restricted.

College/higher education plans do not have to be completed in order to receive the cash award. Three cash awards are given: For the National First Place Winner - \$8,000; Runner-up - \$4,000; 2nd Runner-up - \$2,000. You may apply more than one year if you meet the age requirements but no more than \$8,000 total may be granted to any one Eagle Scout. Prizes and recognitions are also awarded at the Chapter and State level. The State offers three cash awards, \$500. \$250. and \$100 and our local gives one cash award of \$200 (thanks to one of our members who contributes \$100/year to enable us to give the \$200 award).

Entrants need complete only one application - the one for the Chapter competition. The application of the Chapter winner is forwarded to be used in the State and National competitions as appropriate.

As you can see the total award for the winner in any given year is a sizable amount. The policy of Gov. Joseph Hiester Chapter is to attend each Eagle Scout Court of Honor and to present a letter of congratulations, a certificate and information on the recognition program. Unfortunately, even after the telephone call to offer congratulations, many of the Eagle Scouts fail to notify the chapter of their upcoming court of honor. We still manage to honor about one hundred scouts per year.

One would think that the competition would be greatest at the local level where all Eagle Scouts may participate. We should have a hundred boys compete in our program, unfortunately the most scouts we have had participate is six. Is this because the rest do not care, they are too busy to take the time necessary or is the monetary reward too small? We would like to increase the award and perhaps honor three scouts as do the state and national organizations but unless we have some compatriots who would be willing to contribute financially to the Eagle Scout fund on an on-going basis we must remain status quo.

If any of the compatriots would like to assist us in this endeavor please contact the Eagle Scout Chairman. Also if you know a scout who has received his Eagle Award, have him contact us so we might attend his ceremony and please encourage him to enter the Eagle Scout Recognition program.

SAR License Plate

You can have your own SAR license plate issued by the PA Department of Transportation. To obtain your SAR plate, please follow these instructions:

You must fill out Section A of Form MV-904SP for each vehicle (passenger car, motor home, or truck only) you wish to register. The fee is twenty dollars (\$20) per vehicle. Remember that in addition to filling out all of section A, you also need to provide your signature in section D. Your check for the plate itself should be made payable to Common-wealth of Pennsylvania. Your registration renewal date will not change with the new plate.

PASSAR was billed by the State for design and sample costs of original plate production, and is billed at the time of order for manufacturing costs of the plate you personally receive. To help defray those expenses, you need to enclose a SECOND check made payable to PASSAR for fifteen dollars (\$15) for EACH plate you order.



Remember: TWO CHECKS!! One for the Commonwealth of Pennsylvania (\$20 per vehicle) and one for PASSAR (\$15 per plate). Blank application forms MV-904SP may be requested from, and completed applications should be sent to:

When Compatriot Showler receives your application and checks, he will verify your PASSAR membership, then sign his name in Section C and forward your application(s) to PENNDOT. Please allow four to six weeks for the delivery of the new plate to your home address. Plate numbers are now assigned by PENNDOT; PASSAR has no control over the five-digit number(s) you receive. Just a reminder that by signing your name on Section D, you agree to return your plate to PENNDOT if you subsequently drop your PASSAR membership.

Quarterly Meeting


