
Dues must be paid by Dec. 31, 2012.

# **Constitution 225th Anniversary Celebration**



NSSSAR celebrated the 225th anniversary of the signing of the Constitution with a gathering of compatriots from across the country on September 14 & 15 at the Double Tree Hotel in King of Prussia which was hosted by PASSAR and the Philadelphia Continental Chapter.

On Friday, September 14, the festivities began with an informal buffet dinner. The next morning the Guardsmen suited-up and boarded buses for downtown Philadelphia. The parade formed up opposite the Liberty Bell Pavilion and proceeded to Chestnut Street in front of Independence Hall where a brief SAR ceremony was held. From there, the march proceeded to the front of the Constitution Center for the speaker and program. About 100 uniformed Color Guard members marched in the parade followed by wives and family members in colonial dress.

The celebration continued on Saturday evening with a banquet for almost 200 which was highlighted by an inspirational talk given by President General Stephen Leishman

## First Battle of Saratoga (Freeman's Farm) - Sept. 19, 1777

General Horatio Gates, along with General Benedict Arnold, engaged British General John Burgoyne on September 19, 1777 a few miles south of Saratoga, NY. At the end of a vicious day of fighting, the British were in charge of the field but their success came with a huge cost. Rather then engaging the Americans to follow up on the success, Burgoyne consolidated his forces and rested his army waiting for reinforcements from New York City. The delay allowed American reinforcements to pour in and set up the second, and decisive, Battle of Saratoga at Bemis Heights on October 7th.

#### Second Battle of Saratoga (Bemis Heights) - Oct. 7, 1777

After the Battle of Freeman's Farm, Gen. Burgoyne consolidated his position and planned to follow-up with an attack on September 21st. In a pivotal and ironic twist of fate, he received a letter from General Henry Clinton indicating that reinforcements could be sent his way in about 10 days. Burgoyne knew that even under the best of circumstances, a force could not reach him before early-October. Because of his poor situation and his expectation of receiving reinforcements and supplies, he decided not to press his planned attack.

The Americans used this valuable time to gather reinforcements and supplies, including much needed ammunition. Generals Horatio Gates and Benedict Arnold also used the time to skirmish and argue among themselves. This culminated in General Gates relieving Arnold of his command. Arnold, however, remained in camp.


The British began the action on October 7 by attempting to test the strength of the American left flank. Burgoyne sent a small force, which included 10 cannon, into Mr. Barber's wheat field. Opposing them were the men under the command of Generals Poor and Learned and Col. Daniel Morgan. In all, the Americans had about 8,000 men in the field to the British 5,000.

The British fired on General Poor's troops, on the right of the American line at about 2:30 PM. The Americans initially held their fire until the British advanced to close range and then devastated their ranks. The left flank had Col. Morgan's men also sweeping aside the British who began a disorganized retreat. At this point, the Americans were joined by an unexpected participant. General Arnold.

Arnold joined the American chase, and then led Poor's men in an attack on the Balcarres redoubt. This redoubt had been set up well, and the redoubt was held, in action so fierce that Burgoyne afterwards wrote, "A more determined perseverance than they showed ... is not in any officer's experience". With the action at the Balcarres redoubt checked, and seeing that Learned was preparing to attack the Breymann redoubt, Arnold moved toward that action, recklessly riding between the lines and remarkably emerging unhurt. He led (or joined) the charge of Learned's men between the two redoubts, which exposed the rear of Breymann's position. Morgan's men had circled around from the far side and in furious battle, the redoubt was taken and Breymann was killed. Arnold's horse was hit in one of the final volleys, and Arnold's leg was broken by both shot and the falling horse. The capture of Breymann's redoubt left the British in a very exposed position and they withdrew and consolidated their forces at the Great Redoubt.

#### Surrender!

Burgoyne lost about 1,000 men in the battles. His army seriously depleted in manpower and supplies attempted to withdraw but found themselves surrounded near the town of Saratoga by the ever-growing American ranks. On October 19, 1777, Burgoyne surrendered his army to General Gates. News of the surrender emboldened France to enter the war in support of the American cause, turning the fortunes of war in favor of the Liberty. Thus, Saratoga is "The Turning Point" in our War for Independence.

We're honored to be joined by NSSAR President General Stephen A. Leishman who will speak to us and ad-




minister the Oath of Office to our newly-elected officers.
