DUES AND DON'Ts



Dual members will receive a separate notice from that chapter's Treasurer.




A FEW WORDS FROM OUR FAVORITE DISTRICT DEPUTY

MEMBER HONORED BY NSSAR

At the recent NSSAR Annual Congress held in Williamsburg, VA, the NSSAR Eagle Scout Scholarship Committee voted to award Compatriot Nevin C. Miller the newly created Robert E. Burt Boy Scout Volunteer Award. It's an honor due to members of the SAR who act as role models and provide dedicated service to the young men in the Boy Scouts of America (BSA). To be eligible, a compatriot must meet the criteria established in the award guidelines, be recommended by a compatriot of his chapter and a completed application must be approved by the Chapter and State Presidents and the State Eagle Scout Chairman. The award application is then reviewed by the national committee which grants the award. Only 2 such awards will be granted within each state society per year. Compatriot Miller's award was sent to President Troutman and presented at the chapter's quarterly meeting.

EAGLE SCOUT REPORT

From the "Better Late than Never" category! The following is from an Associated Press story that ran in the Reading Eagle on July 29, 2007:

Florida Man, 88, Becomes an Eagle Scout

Fort Myers, FL – More than a half-century after he finished the requirements to earn the rank, an 88-year-old man was honored as an Eagle Scout on Saturday (July 28th), making him possibly the oldest person to ever collect the honor.

Walter Hart couldn't become an Eagle Scout at the time he earned the rank because his service in World War II got in the way.

Hart joined the Cub Scouts in 1928 in Malden, Mass., and earned 23 merit badges during his years as a Boy Scout, scouting officials said. Of the 120 merit badges available, 21 must be earned to qualify for Eagle Scout rank.

Only about 5 % of all Boy Scouts earn the rank of Eagle Scout. Since 1912, nearly 1.9 million Eagles have been awarded, but the recipients' ages aren't recorded, Boy Scout officials say.

PROPOSED MONUMENT FOR BERKS COUNTY REV. WAR SOLDIERS

A committee has been formed to pursue the creation and installation of a monument to Berks County's Revolutionary War soldiers in the veterans section of City Park in Reading. This is a location where ceremonies honoring veterans are held regularly by the local veteran's organizations. It would give the SAR, DAR and CAR a special place to lay a wreath on patriotic holidays and be a lasting legacy to the Gov. Joseph Hiester Chapter.

The preliminary concept envisions a monument that is an obelisk in nature with a statement as to the purpose of the marker and other appropriate phrases, quotations or illustrations to be determined. A monument roughly 6 feet tall and 2 ¹/₂ feet wide at the base is estimated to cost approximately \$15,000 to \$20,000. This amount includes the monument, installation, permits and an appropriate dedication ceremony.

Funding for the project is yet to be determined. If a benefactor can not be found, the Chapter could attempt to raise the funds through donations and fund-raisers or apply for funds from the State of Pennsylvania's Community Revitalization Program or look to the George Washington Endowment Fund

The monument project will be discussed at the Annual Meeting on December 6th so the membership can pose questions and express their desires.

2008 PRESIDENT'S DAY LUNCHEON USS CONSTITUTION – "OLD IRONSIDES"

The USS Constitution was among the first group of ships commissioned by the fledgling Federal government. Designed by a visionary ship designer Joshua Humphreys and built at Edmond Hartt's Shipyard in Boston, the ship has served the United States for more than 200 years, most notably during the War of 1812. Although on several occasions she was almost scrapped due to lack of funds.

One such occasion occurred about 1830. She was slowly rotting away and in need of much repair. But when the public heard of the plans to scrap the venerable warship, such an outcry arose from the people of the United States that the ship was saved. The following poem expresses the sentiments of the people:

> **"Old Ironsides"** By Oliver Wendell Holmes

Ay, tear her tattered ensign down! Long has it waved on high, And many an eye has danced to see That banner in the sky; Beneath it rung the battle shout, And burst the cannon's roar;-The meteor of the ocean air Shall sweep the clouds no more.

Her deck, once red with heroes' blood, Where knelt the vanquished foe, When winds were hurrying o'er the flood, And waves were white below, No more shall feel the victor's tread, Or know the conquered knee;-The harpies of the shore shall pluck The eagle of the sea!

Oh, better that her shattered bulk Should sink beneath the wave; Her thunders shook the mighty deep, And there shall be her grave; Nail to the mast her holy flag, Set every threadbare sail, And give her to the god of storms, The lightning and the gale!

At the Annual National Congress of the Sons of the American Revolution in 1895 the following resolution was passed. "RESOLVED; that it is the sense of the National Society of the Sons of the American Revolution, that the Historical battleship 'Constitution' should be rebuilt, and forever preserved as an illustration of the type of warship which has immortalized the United States Navy, and that she be located at the National Capital, Washington, to be used as a National Naval Museum."
