### **Eagle Scout Report: R. Wayne Murray**

So far in 2013 we have attended forty Eagle Courts of Honor and have two additional ceremonies on our schedule. Certificates were sent to seven Eagle Scouts whose ceremonies we were unable to attend. The Program is experiencing declining interest. The number of scouts is remaining constant, however, we are being contacted less to participate. In 2012 we attended sixty ceremonies and sent certificates to seventeen scouts. For 2011 we attended fifty-nine ceremonies and sent certificates to twenty-one scouts. During 2010 we attended seventy-three ceremonies and sent certificates to twenty-seven scouts. The next scheduled event is on November the 24<sup>th</sup> at St. Joseph in Boyertown.

Nevin made a motion to send three \$25 gift cards, Wayne seconded and the Board approved.
