

Crime Rate Analysis: Mead Area High School Vicinity and Arrowhead Point (99208) Compared to Greater Spokane

Based on comprehensive crime data analysis, the neighborhoods surrounding Mead Area High School demonstrate significantly lower crime rates compared to the broader Spokane metropolitan area, while Arrowhead Point (area code 99208) exhibits crime levels that are elevated above national averages but remain below Spokane's city-wide statistics. This analysis reveals substantial geographic variations in public safety across the Spokane region, with the Mead area representing one of the safer residential zones despite some concerning trends in property crime rates.

Mead Area Crime Profile and School District Safety

Overall Crime Statistics in Mead

The Mead area, where Mead Area High School is located, demonstrates markedly lower crime rates compared to central Spokane neighborhoods. According to the most recent data, Mead experiences 14 crimes per one thousand residents annually, representing a substantially safer environment than the broader Spokane region^[1]. This crime rate positions Mead as considerably safer than many Washington communities, though it still exceeds the rates found in 48% of the state's cities and towns^[1].

The violent crime risk in Mead is particularly low, with residents facing a 1 in 842 chance of becoming victims of violent crime annually. This represents one of the most favorable violent crime statistics in the greater Spokane area. Property crime presents a more concerning picture, with residents experiencing a 1 in 77 chance of property crime victimization, indicating that while violent crime remains rare, property-related offenses require ongoing community attention.

Comparative Analysis with Spokane City Proper

When examining Mead's crime profile against Spokane's city-wide statistics, the disparity becomes particularly pronounced. Spokane proper maintains one of the highest crime rates in America, with 62 crimes per one thousand residents annually^[2]. This represents more than four times the crime rate experienced in Mead, highlighting the significant safety advantages of the suburban Mead area surrounding the high school district.

Spokane's violent crime rate reaches particularly concerning levels, with residents facing a 1 in 140 chance of violent crime victimization compared to Mead's 1 in 842 ratio [2][1]. The property crime differential is similarly stark, with Spokane residents experiencing a 1 in 18 chance of property crime compared to Mead's 1 in 77 ratio [2][1]. These statistics demonstrate that families in the Mead Area High School district benefit from substantially enhanced public safety compared to central Spokane neighborhoods.

Arrowhead Point (Area Code 99208) Crime Analysis

Crime Levels in the 99208 ZIP Code

Arrowhead Point, designated by area code 99208, presents a mixed crime profile that falls between the safer Mead area and the higher-crime central Spokane districts. The available data indicates that the crime rate in 99208 exceeds national averages, with a violent crime rate of 26 compared to the national average of 22.7^[3]. This positioning places Arrowhead Point above typical American community safety standards while remaining below Spokane's most problematic crime zones.

The 99208 area code encompasses portions of northern Spokane and represents a transitional zone between suburban safety and urban crime challenges. While specific property crime statistics for this ZIP code were not fully detailed in the available data, the elevated violent crime rate suggests residents should maintain heightened awareness of personal safety compared to communities like Mead^[3].

Geographic Crime Distribution Patterns

Spokane's crime distribution follows distinct geographic patterns that help explain the variations between areas like Mead, Arrowhead Point, and central city districts. The safest areas in Spokane are generally found in the northeast and southeast portions of the city, while central and southwestern neighborhoods experience the highest crime concentrations [4][5]. This pattern suggests that Arrowhead Point's location in the northern portions of the metropolitan area provides some insulation from the most severe crime challenges.

The data reveals that crime occurs approximately every 14 minutes somewhere in the greater Spokane area, with the highest concentrations in central commercial and residential districts^[4]. Areas like Mead benefit from their suburban positioning and lower population density, which typically correlates with reduced crime opportunities and enhanced community surveillance capabilities.

Comparative Regional Safety Assessment

Spokane County Context

When evaluating both Mead and Arrowhead Point within the broader Spokane County framework, both areas demonstrate relatively favorable safety profiles compared to the county average. Spokane County maintains a C- overall crime grade, with violent crime rates of 4.020 per 1,000 residents and property crime rates of 35.79 per 1,000 residents^[6]. The county experiences approximately one crime every 16 minutes, with both areas under examination falling below these statistical averages^[6].

Spokane Valley, another suburban community within the county, provides additional context with its D+ crime grade and rates of 3.267 violent crimes and 34.46 property crimes per 1,000 residents^[7]. This comparison suggests that Mead's positioning at 14 total crimes per 1,000 residents represents exceptionally favorable safety conditions within the regional context.

Neighborhood-Level Safety Variations

The crime data reveals significant micro-geographic variations that affect daily safety experiences for residents and students in these areas. Within Spokane proper, crime rates can vary dramatically between neighborhoods, with some areas experiencing victimization rates as low as 1 in 29 while others reach concerning levels of 1 in 12¹⁴¹. This variation underscores the importance of location-specific safety assessments rather than relying solely on city-wide statistics.

For families considering the Mead Area High School district, the data strongly supports the area's reputation as a safer educational environment. The school's location in a community with violent crime rates approximately six times lower than central Spokane provides substantial peace of mind for parents and students^{[2][1]}.

Crime Type Analysis and Trends

Violent Crime Patterns

Violent crime analysis reveals distinct patterns across the studied areas. Spokane's violent crime profile includes assault rates of 444.8 per 100,000 residents compared to the national average of 282.7, along with elevated rape statistics of 84.6 per 100,000 versus the national rate of 40.7 M. Murder rates in Spokane reach 7.9 per 100,000 compared to the national average of 6.1, while robbery rates remain close to national norms at 134.8 per 100,000 M.

The Mead area's dramatically lower violent crime exposure suggests that residents benefit from community characteristics that discourage criminal activity. These may include stronger social cohesion,

better economic conditions, enhanced informal surveillance through neighborhood networks, and more effective law enforcement coverage relative to population density.

Property Crime Challenges

Property crime represents the most significant safety challenge across all studied areas, including the relatively safe Mead community. Spokane experiences particularly severe property crime rates, with burglary at 772.4 per 100,000 residents compared to the national average of 500.1, theft at 4,177.6 versus 2,042.8 nationally, and motor vehicle theft at 786.3 compared to the national rate of 284^{181} .

Even in Mead, property crime remains the primary safety concern, with the 1 in 77 victimization rate indicating that residents must maintain vigilance regarding home security, vehicle protection, and personal property safeguarding^[1]. This universal challenge across the region suggests that property crime prevention requires coordinated community-wide approaches rather than relying solely on geographic advantages.

Conclusion

The comparative analysis reveals that neighborhoods surrounding Mead Area High School offer substantially superior safety conditions compared to both central Spokane and the broader metropolitan area. With crime rates approximately four times lower than Spokane proper and violent crime risks six times lower, the Mead area represents one of the region's safest residential and educational environments. Arrowhead Point (area code 99208) occupies a middle position, with crime rates above national averages but below the most concerning levels found in central Spokane districts.

For families and educators in the Mead Area High School district, these statistics support the community's reputation as a safe educational environment while highlighting the continued importance of property crime prevention measures. The data suggests that both areas benefit from their suburban positioning and community characteristics that discourage criminal activity, though vigilance regarding property security remains essential across all neighborhoods in the greater Spokane region.
