Dawn Pasela, 26 years old, didn't appear in court as scheduled and was found dead in her apartment shortly thereafter. Dawn served as Office Manager for a multi-jurisdictional Task Force and was set to testify about wrongdoing (including the destruction of evidence, an illegal undercover spying operation and an affair between Prosecutor Dan Kasaris and government witness Kathryn Clover) that led to as many as 1,200 wrongful convictions. The death scene in Dawn's apartment was suspicious: her computer was missing, the heat was cranked up but the window was open and **three** cell phones were nearby. Dawn's death was ruled an accident but recently, significant new evidence has come to light confirming her death was the result of foul play, including:

- Both the FBI and Department of Justice confirmed Dawn's allegations of misconduct when they admitted making false statements about evidence in criminal cases prosecuted by the Task Force where Dawn served as Office Manager.
- One of Dawn's bosses, federal prosecutor Mark Bennett, was fired and disbarred for serious misconduct following a Justice Department Inspector General investigation. Bennett recently admitted that he was aware Dawn was engaged in an improper undercover operation – something Bennett had vociferously denied earlier.
- In 2022, the retired chairman of the Task Force Donald Cleland stated under oath that Dawn was ordered to make illegal voice recordings of criminal defendant Anthony Viola's trial preparation and that Dawn was given hard drives of all evidence in 1,200 criminal cases to take home.
- The last person to see Dawn alive was recently caught lying about his presence in her apartment.
- The Cuyahoga County Medical Examiner recently produced new information, including that an outbound call on a cell phone left at Dawn's apartment that took place ten hours after her supposed death.

Despite overwhelming evidence that Dawn's death was no accident, the Parma Police refuse to reopen this case, and also refuse to allow other law enforcement agencies to conduct a new inquiry.

We are reaching out to prominent and respected Ohioans such as yourself and asking that you to join our effort by:

- Issuing a statement on your letterhead that you support our request for a new and independent investigation into what happened to Dawn; and
- Writing Ohio Attorney General Dave Yost and ask him to look into allegations that Senior Assistant Attorney General Dan Kasaris ordered Dawn to engage in an illegal “undercover operation” that led to her death, and alleations that Kasaris was romantically involved with multiple government witnesses including Kathryn Clover and Kelly Connors **while at the same time they were testifying for the government in criminal cases and receiving undisclosed financial benefits.**
