RENTAL RULES AND REGULATIONS

- 1. CHECK-IN TIME IS AFTER 3 P.M. EST AND CHECK-OUT IS BEFORE 10 A.M. EST. You will be notified where to pick up the keys at the premises and will be presented the house manual 1 week prior to your arrival. Tenant agrees to abide by all house rules.
- 2. This is a NON-SMOKING house. Any evidence of smoking in the house will be grounds of an additional cleaning fee and/or forfeit of the security deposit.
- 3. Small Pets are permitted in the house <u>only</u> with prior approval. There is a \$200/per pet fee added to the cleaning fee. Pet owners are responsible for cleaning up of any/all pet refuse. Pets are not allowed on furniture at any time. Any evidence of pets on furniture may incur extra cleaning fees. All pets must be up to date on rabies vaccinations and all other vaccinations. Please make sure that dogs are well behaved, house trained, and have been treated for fleas. All items above are the sole responsibility of the pet owner. The owners assume no responsibility for illness or injury that may incur to pets or humans while on the premises.
- 4. We will not rent to vacationing students or singles under 25 years of age unless accompanied by an adult guardian or parent.
- 5. DAMAGE/RESERVATION DEPOSIT- A damage/reservation deposit of \$3,000 is required. This must be received within 7 days of booking the reservation. The deposit automatically converts to a security/damage deposit upon arrival. The deposit is NOT applied toward rent; however, it is fully refundable within (30) days of departure, provided the following provisions are met: a. No damage is done to house or its contents, beyond normal wear and tear. b. No charges are incurred due to contraband, pets or collection of rents or services rendered during the stay. c. All debris, rubbish and discards are placed in the correct refuse containers outside by street, and soiled dishes are placed in the dishwasher and cleaned. d. All keys are left at the house and house is left locked. e. All charges accrued during the stay are paid prior to departure and f. No linens are lost or damaged. g. no fines have been given by The Village of Islamorada during the rental period.
- 6. PAYMENT An advance payment for the reservation/security deposit is required at the time the house is reserved. The RENT TOTAL is due 90 days before your arrival date. Please make payments in the form of traveler's check, bank money order, or cashier's check payable to Ocean Oasis of Islamorada, LLC. You can also pay online at www.OceanOasisofIslamorada.com
- 7. CANCELLATIONS A Three Hundred and Sixty Five (365) day notice is required for cancellation for a full refund by Owner or Guest. Cancellations that are made within (356) days prior to the arrival date forfeit the full damage/reservation \$3,000 deposit. Cancellations that are made within Ninety (90) days of the arrival date, forfeit the full damage/reservation \$3,000 deposit + \$3,000 = \$6.000. Cancellation or early departure does not warrant any refund of rent or deposit. If Guest cancels this agreement less than 60 days prior to the check-in date, Guest shall be obligated to pay all RENT payments specified in this agreement and all monies received by Owner may be retained (excluding damage deposit). If another Guest is located and another rental agreement is entered into for the same time period, the Guest will receive a full refund minus a \$3,000.00 cancellation fee. Owner shall not be responsible for any costs Guest may incur for travel or other arrangements in the event of cancellation by Owner or Guest.
- 8. MAXIMUM OCCUPANCY- The maximum number of guests sleeping in beds is limited to ______ persons. Guest agrees to abide by all occupancy rules and agree that at no time will the number of occupants exceed the total number of occupants permitted in the rental unit. A violation of the number of occupants will be grounds for immediate cancellation of this agreement and forfeiture of security deposits. Guest will be given notice and agrees to vacate the premises within 24 hours of notice. PER THE VILLAGE OF ISLAMORADA, THIS PROPERTY REQUIRES A SEVEN NIGHT BOOKING.
- 9. NO DAILY MAID SERVICE While linens and bath towels are included in the house, daily maid service is not included in the rental rate. We do not permit towels or linens to be taken from the house. If you are interested in daily maid service, that can be provided at an extra charge.
- 10. AMENITIES: Guest agrees to hold Owner harmless in the event of a failure of or non-availability of any amenity. The house includes kayaks and paddleboards along with paddles for each. Please put them back where you found them in the paddleboard rack. Guest is responsible for missing paddle.
- 11. MAINTNENANCE Owners shall be responsible for maintaining the unit unless damage is caused by Guest's misuse or neglect. Guest may not make any changes to the unit and must put furniture back to its original placement if moved. Owner will order repairs in a timely manner once notification is given by Guest, but Owner has no control over the scheduling availability of vendors. Owner shall not be liable for any losses or damages, including incidental or consequential damages, including those caused by Owner's failure to immediately perform repairs and maintain the unit.
- 12. WRITTEN EXCEPTIONS Any exceptions to the above-mentioned policies must be approved in writing in advance.
- 13. POOL/HOT TUB No children under the age of 16 permitted in pool/hot tub without an adult. When using the pool, remember there are certain risks associated with this activity. Use at your own risk.
- 14. HURRICANE POLICY If there is a hurricane warning or watch affecting the Keys within 2 weeks of arrival (or any act of God), Guest may cancel and receive a 50% refund. If there is an evacuation of any part of the Florida Keys while the Guest is at the house (or scheduled to be at the house), the Guest will be refunded 100% for any days not yet occupied.

- 15. COVID POLICY If Monroe County closes entry into the Florida Keys within 2 weeks of arrival date due to COVID, Guest may cancel and receive a 100% refund.
- 16. ASSIGNMENT Guest shall not assign this agreement or sublet the premises or any part thereof. Any unauthorized transfer of interest by the Guest shall be a material breach of this agreement.
- 17. INDEMNIFICATION Guest agrees to indemnify and hold harmless Owner and their agents from claims, suits or damages of any kind, from or related to any acts or omissions of Guest or Guest's guests. Guest agrees to indemnify and hold Owner and its agents harmless from damages and losses unless due to Owner's gross negligence. Guest agrees to look solely to the Owner in the event of a legal dispute regarding this agreement or the premises.
- 18. RISK OF LOSS -This house is privately owned; the owners are not responsible for any accidents, injuries or illness that occurs while on the premises or its facilities. The Homeowners are not responsible for the loss or damage of personal belongings or valuables of the guest. By accepting this reservation, it is agreed that all guests are expressly assuming the risk of any harm arising from their use of the premises or others whom they invite to use the premise.
- 19. Additional Wedding Terms: A wedding ceremony is permitted during this time. Music is to be off by 11:00 and music needs to be at reasonable levels not facing the townhome neighbors to the south. If the neighbors call the property manager or the police, there will be a \$1000 charge taken from the deposit. Wedding caterers are permitted to use the kitchens. You can park up to up to 30 cars at our location. Because of parking violations and safety reasons, NO cars shall ever be parked outside of the property by Overseas Hwy. Guests and Guest guests understand the property is on a turtle beach and will not tamper with turtles or turtle nests. Guest also agrees to only dim, amber or yellow lighting to be kept from shoreline. No bright lights should be facing the shore/ocean.
- 20. Moving Items. Tenants must put back lounge chairs, tables, bricks, lights, kayaks, paddles boards, furniture, umbrella's back in the general location that they found them in when they checked in or there be a \$200 fee taken from the deposit.
- 21. Garbage. Tenant agrees to take out all garbage the night before its pick up day. Regular garbage (darker green bins), are picked up Tuesdays and Fridays. Recyclables (blue bins) are picked up Fridays only. Tenants must NOT put ANY garbage in the large light green bins that are marked only for lawn and leaves. A \$200 fee will be taken out of the deposit if any garbage is placed in the incorrect bins. Empty cans must be pushed back to the hedges before 8pm or the City of Islamorada will assess us a \$75 ticket that will be taken from deposit.
