Treasurer's Report presented by Virginia Renfrew

Questions:

- Discussion of targeted reserves for MPCA Virginia discussed her work with Federation of Vermont Lakes & Ponds (FOVLP) and the financial burden at lakes with invasive plants costing upward of \$60,000 in addition to what state paid. Rhonda also discussed charitable giving to Concord School and the ongoing desire to continue to donate to local nonprofits.
- Sharlene Corliss discussed possibility of MPCA purchasing a keg for year end social so there is no cost.
 Rhonda reminded folks that every member gets 2 free beers

David Richardson made motion to pass, seconded and approved

Lake Water quality and Loon update provided by Virginia

- Further info was provide on FOVLP which was founded in 1971 in order promote water quality and preservation of our lakes and ponds for future generations. The board has decided to become a member of FOVLP
- The greeter program was having it's funding cut this year which would impact not just Miles Pond but all ponds and lakes. Virginia worked with FOVLP to submit a funding request and the state has appropriated 500,000 annually to support the program. This support will also result in the Lakewise program not being cut
- Virginia has continued water testing and informed us that the newest testing is checking for caffeine levels which
 indicate if septic systems are leaching into the pond
- Hours of the greeter program was discussed. Number of hours provided is total dollar amount divided by \$12 an
 hour. Bob Briggiman questioned why we have greeters when it rains and can we only have greeters at peak traffic
 times. It was discussed and agreed that given todays labor market staffing is an issue and if we start sending
 employees of the program home whenever it rains it will be harder to attract future employees.
- Virginia informed us that the loons on the island did have one baby and that the pair of the beaver lodge have renested and currently have two eggs

General Updates

- Rhonda thank all the volunteers that help with so many projects, i.e. black board, little library gardening
 opportunities, water testing fundraising, RSVPs, BBQ, grant writing, wash station, ice out, coffee hours and so
 many more projects
- Rhonda reported board decided to accept paypal on the website and all members should subscribe to email

- Barbara Corey gave an update on recent and upcoming events:
