Annual meeting minutes, July 13, 2024

Meeting opened that 10:04 AM

- 1. Rhonda welcomed everybody

- 3. Rhonda welcomed Alex Huizenga. From Stone Environmental Consulting firm. His firm is contracted by the state to help with the watershed action plan. He explained they are going to be surveying this area over the next 2 years and give recommendations to the state. Typically, they report top 5-10 things on an action plan. He did describe that phosphorus is slowly increasing in most Vermont ponds. This is from runoff from roads streams and lawns.

Identify areas that are chronically washed out. He can come to your camp and evaluate. See how you could improve your camp to minimize runoff directly into the pond and have it filtered before it enters the pond. Make recommendations. Participation is voluntary.

If 15% of our pond area becomes Lake wise Certified, then our pond is listed and being Lake wise certified.

Sharlene noted the Better Back Roads program replaced all the culverts several years ago.

Phosphorous is a limiting nutrient for cyanobacteria. If we minimize phosphorous, we minimize cyanobacteria. Phosphorous enters from non-filtered water entering the pond.

Mike asked about beavers. Alex said there is not a lot you can do as if you move them others will come. You can wrap a large tree with wire to try and prevent the damage.

Joe asked about Rails to Trails and how the asphalt will contribute to water runoff into the watershed. Alex said Vermont rail trails are not asphalt and that the run off from the gravel could create an issue.

Jared asked about people with a long lawn leading to the water. Will Alex's firm make them change it? Alex related that this is all voluntary. They don't make recommendations unless the homeowner agrees.
