7. Committee Reports

7.1 Membership

106 members at end of December 2021 76 members to date for 2022

7.2 Communications (March 2021 - March 2022)

Website – 1375 unique visitors to the site in 2021 Facebook - 754 members - increased from 452 in 2020 - 28% male, 72% female

7.3 Versatility award

Rebecca Brown had planned to present upcoming versatility award information to commence in 2022 but was unable to attend.

7.4 Pedigree

12 inquiries made in 2021 - most having to do with how to navigate CLRC website, 4 transfers and 4 lost pedigrees

7.5 By-law Committee

It was decided not to increase the number of board members as it is not advantageous at this time. It would be good to volunteer at the local level.

7.6 Nominations Committee

1 CHA board position is open. - 2 applicants were accepted - Juri and Pierre

7.7 Breeder Committee

purpose was to facilitate transfers of Haflingers from AHR to CHA

- letter was sent to CLRC to allow AHR transfers and registration to new owner to happen simultaneously (one step rather than the previous two step process)
- consider dual registration of horses (AHR and CHA) nothing confirmed yet more discussion required with AHR in order to make sure is works both ways and both AHR and CHA are in agreement
- AHR registered stallion can also be licensed with CLRC (licensed to breed in Canada as well as US, and registered in either US or Canada)

7.8. Calendar

Pascalle was lead on organizing calendar for 2021 - 100 calendars sold for total of \$1049.40 net profit of \$384.26 (\$3.84/calendar average) - selling price was \$15/member, \$17.50/non-member, \$14/calendar purchased in bulk (10+) no calendar to be produced in 2022

7.9 SCC testing

CHA members only - any horse can be tested, but owner must be a CHA member for \$40 (our cost \$30 US)

- Pascalle to send samples 1x/month to save postage
- several samples have already been sent with few positive/positive results, majority with negative results
