## MEMBERSHIP AGREEMENT AND WAIVER OF LIABILITY

In consideration of and as inducement to the acceptance of my Membership Application, I agree to each of the following:

- A. To hold Dog Agility Sport Handlers, Inc. (hereafter referred to as "DASH" or the "club"), its directors, officers, members, volunteers, and the owners of premises on which club activities are held (collectively the "aforementioned parties"), harmless from any claim for damage, loss or injury to myself, my dog, or any other individuals or dogs, which may be alleged to have been caused directly or indirectly by myself, my dog(s) or any other person or thing while in or on any property or location at which the club holds agility trials, practices or related activities.
- B. To hold the aforementioned parties harmless from any claim for loss of dog by disappearance, theft, death, or injury caused or alleged to be caused by negligence of the parties aforementioned or by the negligence of any other person or persons.
- C. To assume the sole responsibility for and agree to indemnify and hold harmless the aforementioned parties from any and all expense (including legal fees) by reason of the liability imposed by law upon any of the aforementioned parties for damage to property, injury or death arising from my participation in club activities howsoever such damages, injury or death may be caused.
- D. To abide by the club Constitution and Bylaws when participating in any activities sponsored by the club and acknowledge that failure to abide by the club Constitution or Bylaws may result in termination of membership from the club.

Furthermore, I acknowledge that the activity of dog agility requires physical effort by myself and my dog. By signing this Membership Application, I certify and confirm that my dog(s) and I are in good health, that each of my dogs are current in all legally required vaccinations, and that I am capable of engaging in the physical demands that are required to train and compete in the activity of dog agility.
