Exhibitors should follow their veterinarian's recommendations to assure the dogs are free on internal and external parasites, any communicable diseases, and have appropriate vaccinations.

MEASURING AND JUMP HEIGHT CARD INFORMATION

Handlers whose dogs measure into the 8" through 20" regular jump height divisions may opt to enter in a higher or 24-choice height division for all **Regular** titling classes, but not in a division *lower* than their proper height division. Dogs who measure into the 24" regular jump height division may not enter 24-choice. Dogs entered in the **Preferred** classes **must** compete at the required jump height and **may not** compete in a jump height division **higher or lower** than their proper height division.

All dogs that have not been officially measured for an **Agility Jump Height Card** may still compete; however, they must be measured by a Judge of record, an Agility Field Representative, or a Volunteer Measuring Official, prior to running.

On the entry form, please designate whether your dog has a valid jump height card or if your dog needs to be measured. Please check the appropriate box so that the Trial Secretary knows whether to include your dog on the *Dogs to Be Measured List*. It is no longer required that you submit a copy of your dog's jump height card with your entry form or show it during the day of show check-in. However, it is the sole responsibility of the exhibitor to have their original jump height card or temporary jump height form at each trial to present upon request. Additionally, if a measurement is necessary, it is the exhibitor's responsibility to have their dog measured prior to running. **Regulations for Agility Trials, Chapter 2, Section 4.**

SAFETY, BEHAVIOR and LIABILITY

The safety of the dog is our primary concern. By entering this trial. Exhibitors acknowledge that they are familiar with the rules and regulations of this sport, and that their dogs are familiar with and able to perform all obstacles safely.

It is expressly understood that exhibitors alone are responsible for the behavior of their dogs and/or children. Any exhibitor whose dogs and/or children create an unnecessary disturbance or repeatedly engage in unsafe or disruptive behavior may, at the discretion of the trial committee, be asked to leave the show site. In such case, no refund of any fees paid will be made. DASH and its agents, employees, etc., will assume no responsibility for any loss, damage or injury sustained by exhibitors or handlers, or to any of their dogs or property and further assumes no responsibility for injury to children. DASH reserves the right, at its sole discretion, to (i) decline entries for any cause or no cause, or (ii) remove any dog from the trial or trial venue on account of aggression. No exhibitor shall have any recourse or claim against DASH or any official thereof.

All dogs must be on a leash at all times when on trial grounds except when in the designated warm-up area or competing on the course.

This club does not agree to arbitration as stated on the AKC entry form.

REFUNDS

No refunds will be given for overpayment of \$10.00 or less.

No entry fee will be refunded if the trial cannot open or be completed by reason of riots, civil disturbances, fire, an act of God, public emergency, act of public enemy, or any other cause beyond control of the organizing committee. No entry fee will be refunded in the event a dog is absent, disqualified, excused, or barred from competition by the action of the trial committee.

Bitches in season are not permitted to compete in agility trials. As such, the club will refund less \$15 per day of the entry fee paid for bitches unable to compete for this reason upon presentation of a veterinarian

certificate. **This certificate must be presented to the Trial Secretary prior to the start of judging on the first day of the trial or cluster of trials.**

Refunds for injured dogs or handlers, 50% refund will be given for a dog or handler that has a note from their veterinarian or doctor saying they cannot participate in the show. The appointment must have been before the show.

Change of judge: If the judging assignment has changed after the distribution of the premium list, an exhibitor has a right to request a full refund of their entry fee for any class affected. Exhibitors must submit the request in writing to the Trial Secretary a minimum of 1 hour preceding the start of the event on the first day the exhibitor is entered.

If an entry was made online, no refund of the service fee will be refunded for any reason.

RINGSIDE

Judges are not required to wait for dogs. The owner of each dog is solely responsible for having it ready at ringside when it is to be judged. The club has no responsibility for providing service through a public address system or stewards or runners for the purpose of calling or locating dogs that are not brought into the ring when required.

WAIT LIST INFORMATION

DASH Agility Club of Southern CA is offering a wait list to fill openings created by withdrawn entries after the match's closing date/time. A maximum of 50 entries will be placed in the club's wait list. All entries, including wait-listed entries, must be received by the Trial Secretary prior to September 30, 2026 by 6:00pm PST. Any entries withdrawn that are received by October 5, 2026 by 6:00pm PST will be replaced by a wait-listed entry if any are available. If a withdrawn entry is replaced by a wait-listed entry, a full refund will be issued for the withdrawn entry. Any wait-listed entry that does not move off the wait-list into the match by October 5, 2026 will receive a full refund.

Dog Agility Sport Handlers (DASH) is accepting online entries through LabTested, go to labtestedonline.com to enter online. During the first 48 hours after opening, the initial limit of entries will be designated as follows: Online entries #150; Paper entries #550. If either form of entry has not filled at the end of the 48-hour time period, the club reserves the right to decrease or increase either the online or paper limits accordingly.

Entries must be received by **09/30/2026 by 11:30 pm**.

No emailed or faxed entries will be accepted.

Any returned check, the club will add a \$20.00 collection fee to the amount of the returned check.

DOGS ELIGIBLE TO ENTER

This trial is open to all dogs fifteen (15) months of age and older that are registered with the American Kennel Club or that have AKC Limited Registration, Purebred Alternative Listing/Indefinite Listing Privileges

(PAL/ILP), an AKC Canine Partners listing number, or approved Foundation Stock Service (FSS) breeds are eligible to participate.

Dogs with a Purebred Alternative Listing/Indefinite Listing Privileges (PAL/ILP) or an AKC Canine Partners listing number must be spayed or neutered in order to compete. Wherever the word "dog" is used in these regulations it includes both sexes.

Dogs should be physically sound. Dogs that are blind shall not be eligible, and neither are bitches in season, aggressive dogs, or dogs suffering from any deformity, injury, or illness which may affect the dog's physical or mental performance. No dog shall compete if it is taped or bandaged in any way or has anything attached to it for medical purposes. Refer to chapter 2 of the Registration and Discipline Rules for the listing of registerable breeds that may participate. Puppies under four (4) months of age are strictly prohibited from trial grounds.

Please consult the AKC Regulations for Agility Trials for a complete description and eligibility for entry into these classes. The exhibitor is fully responsible for entering their dog in the correct class(es)/height divisions. Dogs running in a lower height division than they are eligible for will be eliminated.

MOVE-UPS

All pre-show move-ups must be received by 6pm Monday, October 5, 2026. The AKC requires move-up requests to be in writing. Please send an email to dashagilitytrials@gmail.com with your dog's call name, the name and date of the trial and what class you want the dog to be moved to. If you miss the deadline, you may move your dog up on the first day of the trial for any **subsequent** days. If you are not showing on the first day you may still move your dog up for the following day. In addition, a friend may make the move-up request for you. You may not move up the day of the show for that day.

There will be day-to-day move-ups at the show, provided the Trial Secretary receives them within **15 minutes after the last class of the day**. There will be no move-ups in the morning before the trial. Exception: A dog which has been entered in Novice "A" class for which it is not eligible to be entered due to class restrictions on the dog or handler may be moved to Novice "B" under the following conditions: The request for the move must be in writing and presented to the trial secretary at least 30 minutes prior to the start of each trial. The request must state the reason and justification from the move from Novice "A" to Novice "B". **Move-Down:** After the close of entries a dog may be moved down in its class level (i.e. Master to Excellent). The request must be in writing and submitted to the trial secretary at least 30 minutes prior to the start of the trial.

MIXED HEIGHT ENTRIES

Exhibitors may enter a mixture of both Regular and Preferred classes on the same trial day and/or during a trial weekend. Any mixture of Regular and Preferred classes is allowed. Please note that if a dog qualifies in Regular Master Standard or Preferred Master JWW (or vice versa) on the same trial day, then NO Double Q shall be earned toward either a MACH or PACH title. The Double Q still requires that BOTH runs (Standard Agility run AND Jumpers With Weaves run) be either Regular OR Preferred on the same trial day. Additionally, within the same Regular or Preferred classes, a dog may now be entered in multiple jump heights within the same trial day. For example, the same dog may now be entered in 20-inch Master STD/JWW while also entered in 24C-inch STD/JWW on the same trial day.

A separate entry form must be submitted when the same dog is being entered in a mixture of Regular and Preferred and/or different jump heights within the same trial weekend thereby clearly indicating which class(es) and/or jump heights belong together for each trial day of the week.

Simplified Jump Height Card Process

When filling out the entry form, there is a new section at the top of the form for exhibitors to designate whether your dog needs to be officially measured. Please check the box so the Trial Secretary knows whether to include your dog in the *Dogs to Be Measured List*. It is no longer required that you submit a copy of your dog's jump heights card with your entry form or show it during day of show check-in.

RIBBONS, AWARDS, AND PRIZES

Rosettes will be awarded in each jump height division as follows:

First Place ~ Blue, Second Place ~ Red, Third Place ~ Yellow, Fourth Place ~ White

A New Title rosette will be awarded to all dogs and handler teams finishing a title, while quantities are available. A MACH or PACH rosette will be awarded to all dog and handler teams that attain their MACH or PACH. A flat ribbon will be awarded to all teams with a qualifying score. A QQ pin will be available for all teams that had a qualifying score in both Master STD and Master JWW on the same day. **All ribbons, awards and prizes must be picked up before the end of the show.**

PARKING AND SITE INFORMATION

NO ALCOHOL OR SMOKING ALLOWED ON THE PREMISES.

No overnight parking will be allowed at the trial site. No electrical hook-ups for motor homes or campers are available.

Exhibitors are responsible for cleaning up after their dog(s). Any exhibitor failing to do so may be excused without benefit of refund if the trial committee deems the exhibitor to be in violation of this requirement.

HOSPITALITY

We will provide food for our workers. Must work at least one class before lunch. You will also receive a voucher along with lunch.

FOR EXHIBITION ONLY (FEO) FIX AND GO (FNG)

As of July 1, 2024 AKC has passed a new rule that FEO is allowed in all classes. DASH will allow FEO in all classes. Participation in FEO is non-qualifying.

- FEO runs are treated as trial entries, and must be entered, paid and recorded as such. The handler must declare FEO the day of the trial/at the time of the run. FEO does not need to be noted on the entry form; the handler will declare FEO on the day of the show
- Dogs may be entered in any jump height for FEO. If entered in an ineligible jump height, the team is committed to FEO for that run and must declare FEO on the start line. Day of show jump height changes are not allowed.
- If the dog is not eligible for the level entered, the team is committed to FEO for that run and must declare FEO on the start line. Day of show level changes are not allowed.
- The exhibitor must declare FEO in the ring prior to leading out. FEO may be declared earlier by checking in on Agility Gate or at the gate board
- Toys are allowed in the ring
 - Toys must be non-audible
 - Toys may not leave the handler's hand
 - Toys that roll freely cannot be used
- Food and treats are NOT allowed in the ring
- FEO should be utilized for the benefit of the dog and not as a punitive correction. Harsh verbal and/or physical corrections shall not be tolerated. Any determination of harshness by the judge shall be immediately whistled and the handler will be dismissed from the ring
- A judge must monitor the entire run. Judges can stop the run at any time

FNG is not pre-entered, it occurs during the course of the run. FNG allows exhibitors to immediately reattempt an obstacle at any time while on course. FNG may only be used once during a run in order to continue the run. FNG more than once will result in the judge asking the competitor to immediately exit the ring.

COURSE WALK-THROUGH AND WARM-UP INFORMATION

Handlers in all classes are permitted to walk the course, without a dog, during a walk-through period held prior to the start of the class. The walk-through is restricted to handlers entered in that class only. Handlers with multiple dogs, at events with multiple rings may request to walk with a height group other than the one their dog is entered in if a conflict is imminent.

A warm-up area, consisting of a regulation agility jump, may be provided for exhibitors. The warm-up area is to be used exclusively for warming up the dog and not for training or relieving of the dog.

The AKC is committed to creating a safe and respectful sport environment for all. If you need to talk to someone or need help, please call 800.656.HOPE (National Sexual Assault Hotline) or text HOME to 741-741 for free 24/7, confidential services from trained crisis counselors.

Anyone in violation of a restriction pursuant to AKC rules or policies, or the law can be asked to leave the grounds. If the person fails to leave, the local authorities will be contacted. In addition, if the club believes laws, restrictions, or conditions of release are being violated by an individual's attendance or participation in AKC events, the local authorities will be contacted immediately, as they have the authority of enforcement.

In consideration of the acceptance of this entry and of the holding of this event and of the opportunity to have the dog judged and to win prizes, ribbons, or trophies, I (we) agree to hold the AKC, the event-giving club, their members, directors, governors, officers, agents, superintendents or event secretary and the owner and/or lessor of the premises and any provider of services that are necessary to hold this event and any employees or volunteers of the aforementioned parties, and any AKC approved judge, judging at this event, harmless from any claim for loss or injury which may be alleged to have been caused directly or indirectly to any person or thing by the act of this dog while in or about the event premises or grounds or near any entrance thereto, and I (we) personally assume all responsibility and liability for any such claim; and I (we) further agree to hold the aforementioned parties harmless from any claim for loss, injury or damage to this dog.

All dogs that have not been officially measured for an **Agility Jump Height Card** may still compete; however, they must be measured by a Judge of record, an Agility Field Representative, or a Volunteer Measuring Official, prior to running. If measured by the Judge of record, that measurement will be valid for this trial or *back-to-back trials* only. If a measurement is necessary, it is the exhibitor's responsibility to have their dog(s) measured prior to running.

Dogs listed in the **AKC Canine Partners ProgramSM** may be eligible to enter all-breed AKC agility trials at the club's option. These dogs should be listed as All American Dog and must include their AKC number on the entry form and check the AKC No. box.
