OUR HISTORY

Developed from a growing need.

The mission of the Fayette County Public Safety Benevolent Society, Inc. is to become a self-sufficient, self-sustaining organization providing supplemental financial support to its members in their time of need.

How we started: In 2005, a local Fire Fighter developed a terminal illness. This career employee did not have enough sick time and soon exhausted his family medical leave. He was unable to return to work and after a while lost his job. His co-workers banded together and assisted him financially.

The experience with this employee lead to the creation of the Fayette County Public Safety Benevolent Society. The idea was to create assistance modeled after short term disability insurance. Assistance would be available without the member having to jump through hoops.

You may become a member after three (3) months of full time employment. You must be a member for six (6) months before filing a claim. Claims typically are filed after members are out for 30 days however, line of duty injuries may waive the waiting period. The benefit is on a sliding scale based on membership tenure for up to five (5) Years.

WE ARE CHARITABLE

Non-members are given donations for assistance provided they are a public safety employee. The goal is to help a guardian of the community get back on their feet.

This Society has birthed a network of support. We have a variety of experience and expertise to draw and share ideas for positive change. Members across agencies come to know each other and lend support together. If a public safety employee is in need, regardless of membership, help from FCPSBS will be communicated and offered.
