Natural breeding\side by side AI

The stud fee is 1,000 (ONE THOUSAND) OR pick of the litter (determined before breeding). We attempt to get 2-3 live covers (natural breeding) or 2 side by side AI but that is NOT a guarantee of this contract. A non-refundable deposit will be paid at the time of breeding. The deposit will apply to the final stud fee.

If a bitch does not conceive on the first service, one additional service will be provided during the bitch's next cycle at no fee to the bitch owner.

**TERMS AND CONDITONS OF SERVICE**

The bitch owner is responsible for transportation to and from the place of breeding. The stud owner will NOT be liable for injuries that may be sustained by the bitch during the breeding process or while on the stud owner's property.

The bitch owner agrees to preform and pay for any necessary progesterone and\or LH testing on the bitch to determine the proper breeding window. The bitch owner will be responsible for any and all medical expenses, including those pertaining to hormone testing and veterinary fees. If a natural breeding cannot be accomplished, and the bitch desires to proceed with an AI breeding, the bitch owner agrees to provide a credit card number to the collecting veterinary to cover all AI cost, and to pay any travel fees incurred to transport the bitch to the AI facility.

Bitch owner agrees to have a backup stud dog available it the event that the stud dog becomes unavailable.

The remainder of the stud fee is due two (2) weeks after the whelping of a litter of at least 2 live puppies. If fewer than 2 live puppies are whelped, the stud fee will be adjusted by \$200.00. The stud owner will sign the litter registration after receipt of full payment.

The bitch owner agrees that no puppy produced as a result of this breeding will knowingly be sold to a pet shop, agent, broker or to anyone who breeds mixed breeds.

The stud owner is not obligated to sign an application for litter registration with the AKC, nor may such application be made, unless and until all applicable terms and conditions of this agreement have been complied with in full.

If the bitch's owner(s) fails to fulfil the conditions of this agreement, the bitch's owner(s) will be responsible for all attorney's fees, cost and/or expenses incurred by the stud owner to ensure compliance with this agreement.
