For example, a too-forceful reaction to paparazzi can heighten tensions and lead to legal issues. Reflecting on past failures regarding legal errors highlights the need for both personal and team education on applicable laws and regulations, making sure that all actions remain within legal limits while still providing effective protection for the client.
