- On the move: Could their route be ambushed or tracked?
- At events: Is the venue secure and access limited?
- Online: Are they protected from scams and leaks?
- In the media: Do they have a plan if something damaging goes public?

### Helpful Tools:

- A threat matrix to map risk areas.
- Scoring system to weigh likelihood vs impact.
- Team briefings before and after events.

### **Physical Protection Measures**

- Residential Security: Alarms, access control, vetted staff, layered zoning.
- Close Protection: Low-profile or high-visibility detail depending on context.
- Vehicle Security: Armoured options, convoy tactics, GPS tracking, route mapping.
- Venue Security: Recon, advance teams, green room safety, VIP exit strategy.

#### Note:

Plan for "Embus and Debus" as they are the most vulnerable times.

### **Cybersecurity for Celebrities**

- Use of alias accounts for personal matters
- Multi-factor authentication on all devices
- Regular digital hygiene: patching, VPNs, encrypted comms
- Monitoring for data leaks or impersonation

### Response Plan Includes:

- Rapid account recovery protocol
- Legal action toolkit (cease and desist, takedown requests)
- Cyber forensics contacts on call

### Managing the Paparazzi and Media Exposure

- Create 'safe zones' where media is not tolerated.
- Use decoy movements and shadow scheduling.
- Engage media reps to coordinate voluntary exposure vs privacy needs.
- Know the law: harassment and privacy statutes vary by jurisdiction.

### **Stalker and Fixated Individual Management**

- Use behavioural threat assessment tools.
- Build a multidisciplinary management team (security, legal, mental health).
- Work with police, obtain restraining orders when appropriate.
- Never ignore "low-level" incidents—they often escalate.

- Medical emergency protocols
- Kidnap and ransom insurance & drills
- Cyber breach incident response
- Media crisis containment

- Hard and digital grab bags
- Updated contact trees
- Location-specific emergency plans

- Staff vetting and training
- NDA enforcement
- Family and partner protection
- Insider threat awareness

An untrained PA or emotional partner can be your weakest link.
