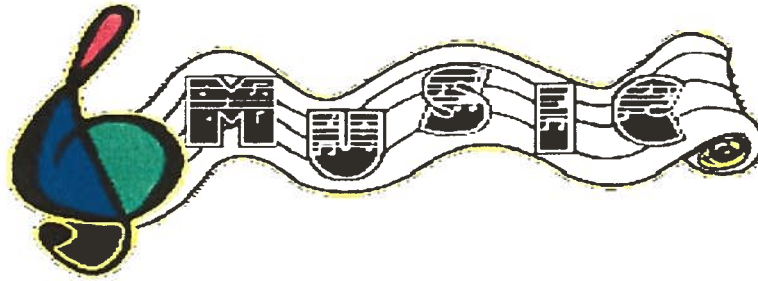

**First Offense:** Participant will be counseled with Parent and M.U.S.I.C. Staff.

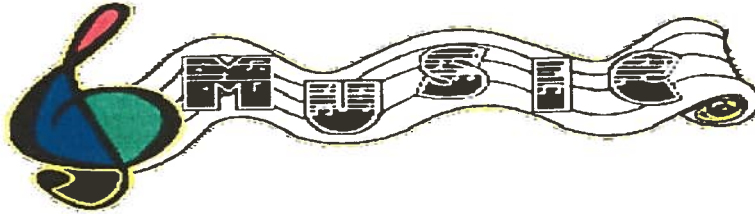
**Second Offense:** Participant will be suspended from the program for a period of time determined by the M.U.S.I.C. Administrator.

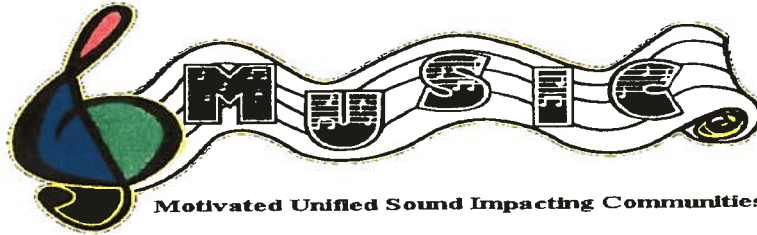
