twenty-four hours a day, 365 days a year.

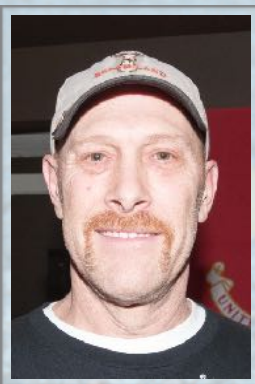

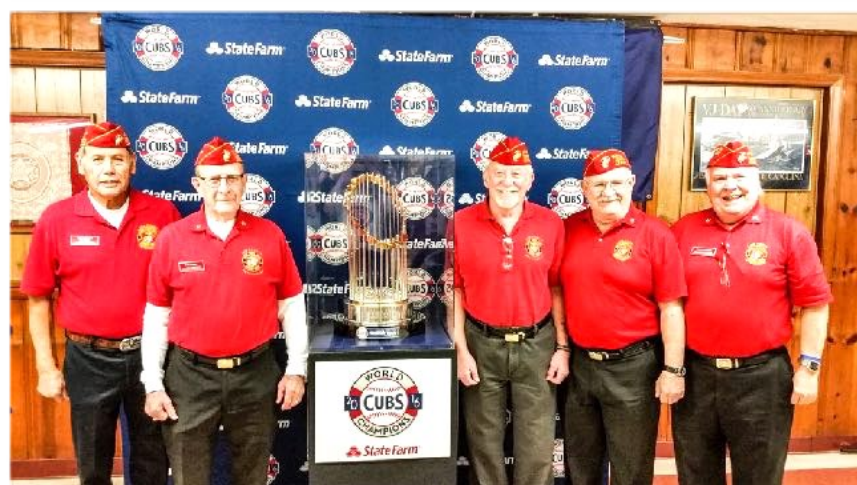
