# Explaining Wills and Trusts By Peter S. Karlovics, Judge Advocate Det. 801

Celebrities and notable figures in history, such as Abraham Lincoln, Martin Luther King, Jr., Jimi Hendrix, Aretha Franklin, and Prince did not leave a Will. According to a 2017 Caring.com survey, only 42 percent of US adults currently have estate planning documents such as a Will or Living Trust. For those with children under the age of 18, the figure is even lower, with just 36% having an end-of-life plan in place.

Failure to do some type of estate planning can result in unintended consequences. Without a Will or Living Trust, instead of the wishes of a deceased person determining who receives the deceased person's assets, Illinois statutes make that determination. A person who dies without a Will is known as "intestate."

Illinois intestate laws provide that a deceased person's estate is distributed as follows:

- If the deceased person is survived by spouse and descendants: the spouse receives half the property and the children split the remaining half
- If the deceased person is survived by spouse and no descendants: the spouse receives the entire probate property
- If the deceased person is survived by descendants and no spouse: the descendants receive the entire property
- If the deceased person is only survived by parents or siblings: the parents and siblings
  equally inherit the estate; however, if one parent is deceased, the other parent receives a
  double share of the estate.
- If the deceased person is not survived by parents, brothers, sisters, or descendants of brothers and sisters: estate is split equally between maternal and paternal sides of the family
- If the deceased person is survived by no one: estate is left to the state of Illinois

If a person dies without a Will, he or she has also likely not named an executor for the estate. In this case, the family members closest to the deceased share the right to appoint an administrator for the property. If all family members agree upon who should be the administrator, that person is appointed. If there is disagreement, the matter will go to court and a judge will determined who the administrator should be.

Dying intestate can be prevented through proper estate planning. The common goals of estate planning are simple: 1) to provide for spouses and/or dependent children; 2) to distribute property; 3) to plan for disability; 4) to organize finances; and 5) to reduce estate taxes.

# **Explaining Wills and Trusts (continued)**

Two basic forms of estate planning primarily involve either creating a Living Trust or executing a Will. A Will only becomes effective after your death. A Living Trust goes into effect during your lifetime, and can be made to be revocable, changeable, amendable, or terminable.

Wills and Trusts each have their advantages and disadvantages. For example, a Will allows you to name a guardian for children and to specify funeral arrangements, while a Trust does not. On the other hand, a Trust can be used to plan for your disability or to provide savings on taxes. Further, a Will can ensure that all of your property is distributed to your designated beneficiaries through a "residuary clause," whereas a Trust will only pertain to property that you specifically place into the Trust.

Illinois requires a Will to be in writing. The person creating the Will is called a "testator." The testator must sign the Will at the end of the document. The Will must be signed by at least two attesting witnesses. Those that wish to change their Will may either revoke their will and execute a new Will, or execute a "codicil," which is used to make minor changes.

A Will takes effect upon the death of the testator, and the Will is administered through "Probate," which is a legal process by which the assets of a deceased are properly distributed.

Probate is not restricted to a circumstance where a decedent has executed a will. If the deceased has a Will, the executor named in the Will pays the deceased's debts, taxes and other claims, and distributes the assets of the decedent's estate according to the directions provide by the Will under the court's supervision. If a decedent does not have a Will, the court will appoint an administrator and ensure that the deceased's debts, taxes and other claims are paid, according to laws of intestate listed above.

Real estate that is subject to some type of joint ownership, such as joint tenancy or tenancy by the entirety, does not go through probate, but instead, the decedent's share is transferred to the other party in joint ownership upon the decedent's death.

In a probate involving a Will, the deceased can waive the requirement of an expensive surety bond. Without a Will, a probate court will require a surety bond, paid out of the proceeds of the estate, to be posted by the court appointed administrator.

# **Explaining Wills and Trusts (continued)**

A Living Trust is created through the execution of a Trust document. A Trust document will provide a name for the Trust, names a Trustee or Trustees, and possibly one or more successor Trustees, provide for the powers of the trustee, and directs how the Trust is to be administered for the term of the Trust. The Trust must also specify the property to be transferred to the Trust to be effective, and most Trusts can accept any property transferred to them. In order for the Trust to be effective, property must be put into the Trust, and the Trust only has authority over that property that you specifically put into the Trust.

The Trust specifies what to do with property left in the Trust after the person who created the Trust dies. The distribution of property held in Trust can be made directly from the Trust without the necessity of submitting the Trust to probate court.

Some of the advantages of having a Living Trust over a Will are: assets transferred to a Trust during your lifetime will avoid probate at death, the attorney fees are more easily predictable in a Trust distribution than that in probate, beneficiaries have immediate access to assets, court approval is not required for payments of debts and distributions to beneficiaries, and details of your estate will not become public due to the Trust not being filed with a probate court (the proceedings are done in public and court documents are available to the public).

Some of the advantages of a Will over a Living Trust are that an estate can select a fiscal year, whereas a Trust select the calendar year for tax payments. Further, a will in probate has a shorter claims period for debts and taxes owed from the estate from two years to six months. Also, an estate in probate that is not contested can be resolved shortly after the period, mandated by Illinois law, that gives creditors time to file claims. The number one cause of delay in probate are family fights.

In conclusion, regardless of the manner of estate planning you choose, engaging in estate planning will protect your assets and loved ones, avoid possible tax burdens, provide predictability as to how your assets will be distributed, and avoid having the courts determine how your assets are divided. Do not follow the example of the celebrities listed above. Consider developing an estate plan right away.
