

Well, here I am back in the ‘frozen North’ again and actually, it’s good ta be home. Good to see you agin. Grab a hot cup and a chair and let’s visit.

Cup’la things occurred recently I’d like to talk about:

First, a number of our Detachment (BDDiTN) participated in the nationwide Wreaths Across America at Warren Cemetery in Gurnee on December 14th, 2019. The reason I mention this now is because at the same time this scenario was occurring all across this great Nation of ours, 38,000 volunteers at Arlington National Cemetery also placed wreaths including two notable gravesites. One was Major General Merritt Austin Edson, Sr. USMC (1897 – 1955) and Brigadier General Joseph Jacob Foss, USMC (1915 – 2003) both of whom served as presidents of the National Rifle Association (Edson also served as executive vice president).

Additionally, both of these distinguished veterans were presented the Medal of Honor for fighting the enemy in Guadalcanal in 1943.

Second involves another Marine from WW11, Corporal Joe Vandever Sr. of Window Rock, Arizona. Flags across the Navajo Nation were flown at half-staff from February 3-6 to honor the life and memory of Navajo Code Talker Joe Vandever Sr. at the age of 96. “As we mourn the loss of Navajo Code Talker Joe Vandever Sr., we also remember all his great sacrifices for our Navajo people and the entire country. Our thoughts and prayers are with his family and friends as they lay him to rest this week,” said Navajo Nation President Jonathon Nez.

Vandever enlisted with the U.S. Marine Corps in Santa Fe, New Mexico on March 26th, 1943 and was honorably discharged as Corporal on January 22nd, 1946. He served in the northern Solomans, Emirau Islands, Bougainville, Guam, Marianas Islands, Okinawa, Ryukyus Islands, Occupation of Japan, and Occupation of China. In 2001, he received the Congressional Silver Medal for his service as a Navajo Code Talker in World War 11.

He was born on February 5th, 1923 into the Red Running Into the Water People clan born for Two Who Came to the Water clan. He was married for 73 years to his wife Bessie D. Vandever who passed on September 24th, 2019. Funeral was in Gallup, New Mexico with internment at the Santa Fe National Cemetery in Santa Fe, New Mexico.

There are no additional requests for assistance at this time.

We will continue to apply for Grants.

The Boat Load of Booze raffle is under way. Our **GOAL is \$15,000.**
