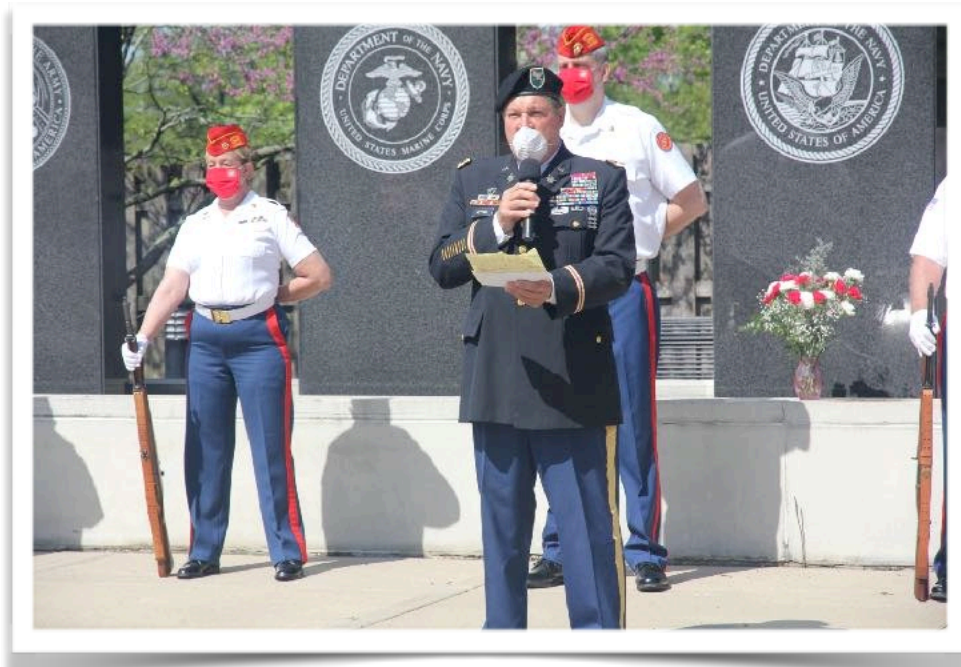

First of all, we had to cancel the originally scheduled St Patty's Day and the Memorial Day gatherings. We had planned on re-scheduling them but we have no idea when we will be allowed to get together in a future so we just decided to cancel them.

We want to have a welcome back-to-Steven's buffet when we are allowed to. We hope this can occur in July but we still don't know. We are still not allowed to visit patients at the VA or practice with the Color Guard at the Warren Center in Gurnee so Hospital visits and Color Guard will be postponed until further notice. Eagle Scout Court of honor events will also need to be rescheduled. Only the Detachment 801 presenter will be allowed to attend.

Our spring fundraising events were postponed. We did hear that other detachments were still fundraising. We will be checking with the Jewel and Walmarts to see if that is possible and when we can do so. If we run into the same time as the Toys for Tots fundraising, we will address that at that time.

Our major fundraiser, the Boat Load Of Booze Raffle, will be extended into the fall. We have only sold 25% of our tickets and will need some time to sell the rest. If you have not gotten any tickets to see, please call Al Seyler. He will get some to you. We need to sell these tickets!!!!

Your staff members are still here to serve you as your elected and appointed staff members. If there is any reason you need to reach one of us feel free to call. We are still here for you. We know these times are really stressful. If you just need a person to talk to or to have a cup of coffee with, call. That is what we are here for.
