2. The **Troop number**, name, telephone number and e-mail address of a contact person for the new Eagle Scout, i.e. scoutmaster, parent, mentor, etc. and the date of the Eagle Board of Review.
3. Date of the Eagle Board of Review

In addition to the congratulatory certificate we present, we can also present a USMC Ka-Bar knife to the new Eagle Scout. Due to both the number of presentations we make and the cost of the knife, the Detachment has requested that the Troop/Parents cover the \$70.00 cost of the knife.
