## Traditional IRA

A traditional IRA is any IRA that is not a Roth IRA or a SIMPLE IRA. You can set up a traditional IRA if you receive taxable compensation during the year. You can have a traditional IRA even if covered by an employer-sponsored retirement plan. However, the deductible amount of contributions to a traditional IRA may be phased out.

- **Contribution limit.** For 2025, contributions to IRAs are limited to the lesser of your compensation (or spouse's compensation under a spousal IRA), or \$7,000 (\$8,000 age 50 or older).
- **Spousal IRA.** If both spouses have compensation, each can set up a separate IRA. Spouses cannot participate in the same IRA. If Married Filing Jointly, and one spouse's compensation is less than the contribution limit, the lower-income spouse can use the compensation of the other spouse to qualify.
- **SEP IRA.** A SEP is a traditional IRA with different per year contribution limits. An employer (or self-employed individual) makes deductible contributions to a traditional IRA on behalf of the employee (or self-employed individual). Distributions are generally subject to the same rules that apply to traditional IRAs.

**Note:** SEP plans (excluding SARSEPs) can allow employees the ability to treat employee and employer SEP contributions as Roth contributions (in whole or in part). A plan which is designated as a Roth IRA cannot be treated as a SEP unless the employee elects that treatment.

## Prohibited Transactions Involving IRAs

Penalties apply when IRA funds are used in prohibited transactions. A prohibited transaction is any improper use of traditional IRA funds by the participant, the beneficiary,

or a disqualified person. The following are examples of prohibited transactions.

- Borrowing money from an IRA.
- Selling property to an IRA.
- Receiving unreasonable compensation for managing an IRA.
- Using an IRA as security for a loan.
- Buying property for personal use (present or future) with IRA funds.
- Investing in collectibles.

## Roth IRA

A Roth IRA is subject to the same rules as a traditional IRA except for the following.

- Contributions are nondeductible. Thus, your participation in an employer plan is irrelevant.
- If certain requirements are satisfied, distributions are tax free.
- The required minimum distribution rules do not apply. Distributions are not required until your death.
- Contributions phase out for 2025 when modified adjusted gross income is \$236,000 to \$246,000 for Married Filing Jointly and Qualifying Surviving Spouse, \$150,000 to \$165,000 for Single and Head of Household, and \$0 to \$10,000 for Married Filing Separately (if spouses live together).

## SIMPLE IRAs

- **Eligible employers.** Employers can set up a SIMPLE IRA for employees if they have 100 or fewer employees who received \$5,000 or more in compensation from the employer in the preceding year. The employer cannot maintain another qualified plan (except for certain union

employees). The 100-employee limit must be met each year to continue contributing to the plan. A two-year grace period applies once this limit is exceeded.

- **Eligible employees.** Any employee who received at least \$5,000 in compensation from the employer during any two years prior to the current year, and reasonably expects to receive at least \$5,000 in compensation during the current year, is eligible to participate in the employer's SIMPLE plan. The employer can offer the plan on a less restrictive basis but cannot make the plan participation rules any more restrictive.
- **Roth contributions.** SIMPLE IRA plans can also accept Roth contributions. A plan which is designated as a Roth IRA cannot be treated as a SIMPLE IRA plan unless the employee elects that treatment.

### Defined Contribution Plans

A defined contribution plan is a qualified plan that provides an individual account for each participant in the plan. Benefits depend upon the amount contributed, income, expenses, gains, losses, and forfeitures of other accounts that may be allocated to a participant's account. Examples of defined contribution plans include profit-sharing plans, money purchase plans, 401(k) plans, and 403(b) plans.

#### Retirement Plan Contribution Limits

Contributions are limited to the lesser of the following amounts, or 100% of a participant's compensation for the year.

	2025
<b>Traditional and Roth IRAs</b>	Under age 50 = \$7,000 Age 50 or older = \$8,000
<b>SEP IRA Employees</b>	25% of wages up to \$70,000.
<b>SEP IRA Self-employed IRC §408(k)</b>	20% of net self-employment (SE) income after one-half SE tax deduction, up to \$70,000.
<b>SIMPLE IRA* (employees and self-employed)</b>	Under age 50 = Elective deferrals up to \$16,500. Age 50 or older = Elective deferrals up to \$20,000. Age 60–63 = Elective deferrals up to \$21,750.
<b>401(k) Plans</b>	Under age 50 = Elective deferrals up to \$23,500. Age 50 or older = Elective deferrals up to \$31,000. Age 60–63 = Elective deferrals up to \$34,750.

\* SIMPLE elective deferrals are increased to 110% of the limit if no more than 25 employees, or if a larger employer elects a higher matching percentage.

### Retirement Savings Contribution Credit

The 2025 credit percentages are 10%–50% of eligible contributions to IRAs and retirement plans up to a maximum credit of \$1,000 (\$2,000 for Married Filing Jointly). Credit rates vary based on adjusted gross income.

Rate	MFJ	HOH	Single, QSS, MFS
50%.....	\$47,500	\$35,625	\$23,750
20%.....	\$51,000	\$38,250	\$25,500
10%.....	\$79,000	\$59,250	\$39,500
0%.....	\$79,001	\$59,251	\$39,501

The credit is not available if the taxpayer who made the qualified contributions:

- Was born after January 1, 2008,
- Is claimed as a dependent on someone else's 2025 tax return, or
- Was a student during any part of five calendar months during 2025.

### Eligible Contributions

Contributions and deferrals made for tax year 2025:

- Traditional and Roth IRA contributions.
- Elective deferrals to a 401(k), 403(b), governmental 457, or SEP plans.
- SIMPLE plan.
- Voluntary employee contributions to a qualified retirement plan as defined in IRC section 4974(c), including the Federal Thrift Savings Plan.
- Contributions to a 501(c)(18)(D) plan.
- Contributions to an ABL account by a designated beneficiary.

Contribution amounts used to calculate the credit may need to be reduced by distributions received from any of the plans listed above after 2021, through the deadline for filing the 2025 return (including extensions).
