Mr. Burquest is a commissioned Officer in the United States Army Reserve. In this role, Andrew holds the rank of Lieutenant Colonel (LTC) and serves as an Economic Development Specialist in the Civil Affairs branch. LTC Burquest spends approximately 16 hours a month, primarily on weekends, on this activity.

Mr. Burquest is currently securities registered with Realta Equities, Inc., as a registered representative and can provide securities products through this firm. Andrew Burquest may engage in placement of private market investments, including but not limited to private equity, private debt, and other private offerings. Clients are not required to purchase securities products from Mr. Burquest and may seek similar services elsewhere. This is an investment-related activity and accounts for approximately 8 hours of Mr. Burquest's time per month.

Item 5: Additional Compensation

Mr. Burquest does not receive any economic benefit for providing advisory services to clients from any person, company, or organization, other than from Njord Capital, LLC.

Item 6: Supervision

Mr. Burquest performs supervision of Njord Capital, LLC, in his capacity as Chief Compliance Officer. Njord Capital, LLC has implemented a policies and procedures manual and Code of Ethics which guides the Firm and its supervised persons in meeting their fiduciary obligations to the firms' clients when providing investment advisory services. As Njord Capital LLC's Chief Compliance Officer, Mr. Burquest is responsible for the implementation of the Firm's policies and procedures and Code of Ethics.
