This is the 3rd foal of Annies Law who is a **full** sister to Grade 1 winner and stallion Majestic Perfection.

An elegant filly with class and fluid movement, she is a correct filly and covers the ground very well. She has the appearance of a two-turn classic filly. With sound mind and an eagerness to perform, a filly that will make most short lists. One that needs to be bought.

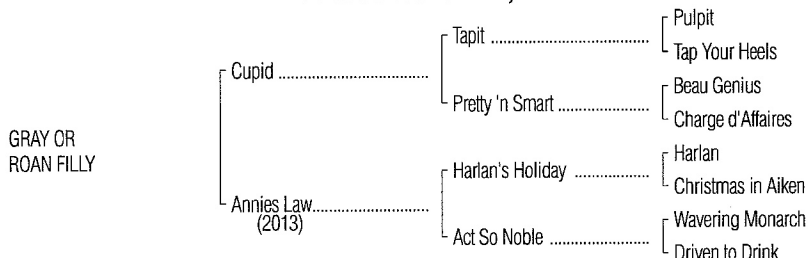


