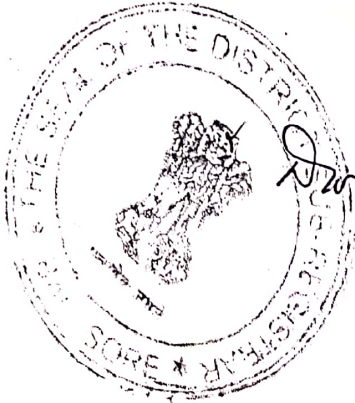

3. The Trust shall function within the country of India.









AIMS AND OBJECTIVES :

4. Distribution of food and clothes to the poor and needy people.






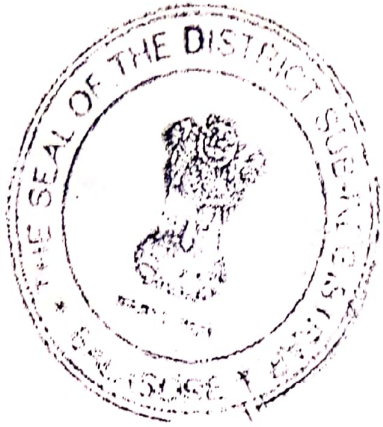

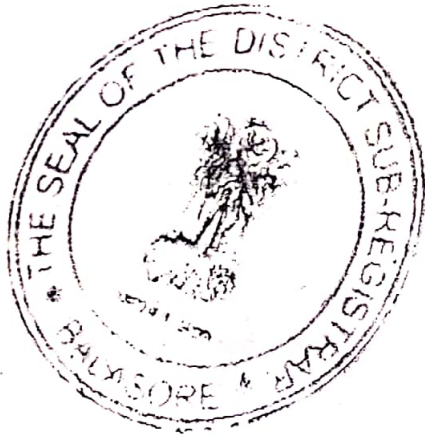

22. Tie up with other developmental agencies like State & Central Government, financial institutions and other Trusts (both in India & abroad) to achieve the aims & objectives of the Trust.
23. To do all such lawful things that may be incidental to or conducive for the attainment of the above objectives.
24. Developing and conserving Forests
25. The objects of the Trust shall be subject to the provisions of Sec 2(15) of the Income Tax Act of 1961.
26. Any other objects as may be decided upon by the Trustees from time to time.

TRUSTEES

1. That any person who wants to become a Trustee shall make an application to the Trust Managing Committee with requisite donation as decided by the Trust Managing Committee from time to time and the decision of the Trust Managing Committee with regards to his admission as Trustee shall be full & final. All such trustees shall be called as Lifetime Trustees.
2. The Founder Trustees shall contribute further amount as and when necessary.
3. The FOUNDER TRUSTEES or any other Life time Trustees shall remain as Trustee for life or until he/she resigns the Trust. However a person shall cease to be a Trustee on death and in that case one of

his/her legal heirs shall be eligible to become trustee as approved by the Managing Committee.

4. If any Trustee does any act which is detrimental to the objects of the Trust he shall be removed from the trust subject to approval by at least two-thirds of the Trustees present in a trust meeting.

MANAGEMENT

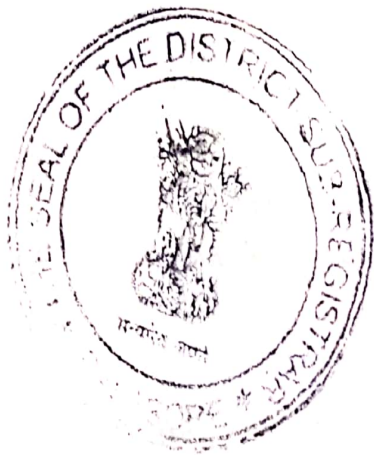
The Management of the Trust shall vest in the Trust Managing Committee to be constituted out of the following persons.

All the nine Founder Trustees shall be the members to the Trust Managing Committee till he/she resigns or dies.

That the Trustees shall elect out of its trustees, other than the Founder Trustees, six members to the Trust Managing Committee for a term of three years.

Thus, initially for a year, the trust managing committee shall consist of nine founder trustees and after completion of one year another six trustees shall be added to the Trust Managing Committee.

The strength of Trust Managing Committee may be increased as resolved in Trust Meeting. Further, the election procedure of Trust Managing Committee may be altered as decided in the Trust Meeting.

That the members of the Managing Committee as constituted above will elect a Chairman, Vice Chairman, Secretary and Treasurer out of the members of the Managing Committee for a term of three years. The election/selection of such office bearers shall be made by members of Trust Managing Committee.

The Office bearers shall be in charge of day to day management of the Trust under the direct and overall supervision of the Managing Committee.

The Managing Committee shall hold at least one Meeting every quarter. Those members of the Managing Committee who fail to attend at least three consecutive meetings without leave shall cease to be members of the committee.

That the Managing Committee can be dissolved by the Trustees by three fourth majorities of the total trustees at any time without assigning any reasons whatsoever and thereafter shall elect a new Managing Committee. However, all the founder trustees shall continue to be the members of the new committee.

That the Managing Committee can appoint such person or persons as may be required to fulfill the objects of the trust.

The Quorum for the Meetings of the Trustees as well as the Trust Managing Committee shall not be less than 1/3rd of the total number of Trustees or Trust Managing Committee as the case may be.

All the decisions of the Trustees and the Managing Committee shall be taken either unanimously or by majority of the Trustees present in the meeting.

- (h) The Chairman of the Managing Committee will preside over all the Meetings of the Trustees or Managing Committee. In the absence of the Chairman, the Vice Chairman, and in absence of the Vice Chairman, the Trustees present will choose one from amongst them to preside at such meeting.

FUNDS

- (a) The FUNDS and properties movable or immovable of the Trust shall vest in the Trustees Holding Office as such for the time being.
- (b) Trustees will keep such sums of money as they consider proper in Current or Fixed Deposit Account with a Schedule Bank.
- (c) Bank Account of the Trust shall be operated by Treasurer and either of the Chairman or Secretary of the Trust jointly.
- (d) Cheques, Bills of Exchange or other promissory Notes or other negotiable instruments shall be signed jointly by the Treasurer and Chairman or Secretary of the Trust.
- (e) After defraying all necessary expenses incurred for fulfilling the objects of the trust, the balance of the income shall be deposited in a Schedule Bank. Such saving shall be kept in a Reserve Fund to be utilised in the case of emergency in accordance with the unanimous opinion of the TRUSTEES expressed in the meeting of the Trustees.
- (f) The TRUSTEE may out of the corpus of the subject matter of the trust spend such money or appropriate such money or part thereof for laying out, erecting and furnishing any building, research, institute or for incurring any capital expenditure as may be unanimously resolved upon by the Trustees.
- (g) Minute Books of the meeting of the TRUSTEES and the Managing Committee shall ordinarily be kept at the office of the Trust or with such Trustee or Trustees as the TRUSTEES may decide AND it shall be open to the inspection by the TRUSTEES.

(h) Resolutions passed, entered and signed by Chairman of the meeting in the Minute Book on any ~~matter relating to the Trust~~ shall be conclusive evidence of the facts and matters duly noted therein.

(i) All the TRUSTEES shall be bound by ~~the decision of the TRUSTEES~~ whether in a meeting or by circular resolutions.

POWERS OF THE TRUSTEES AND MANAGING COMMITTEE

For the furtherance of the objects of the Trust the TRUSTEES and the MANAGING COMMITTEE will have the following powers :-

- (a) The Managing Committee will be at liberty to invest the full Trust Fund or any portion thereof in manner provided hereby but such Trustee shall be responsible and accountable only of such moneys, stocks, shares and funds as shall actually come into their hands and a Trustee shall not be answerable or accountable for ~~neglect, default, acts of omission or commission of the other Trustees, nor of any Banker or other person with whom the Trust properties or any securities may have been deposited or kept.~~
- (b) The TRUST through its Managing Committee may accept any donation or contribution in cash or kind from any person or persons for the furtherance of the objects of the trust
- (c) The TRUST through its Managing Committee may invest the Trust Fund, ~~for carrying out the objectives of the Trust,~~ either in the purchase of immovable property, fixed deposits with banks and/or in such investments ~~as are authorised by the Indian Trust Act, 1982 on such terms as to interest as the Trustees may think proper with power to the Trustees to alter, vary or transfer such investments from time to time in such manner as they may in their absolute discretion think fit, but the alter, vary or transfer of instruments must be accorded by majority of the Trust Managing Committee.~~

Provided that the corpus of the Trust may remain invested in shares of Companies or Loans due from ~~firm or firms~~, individuals or Companies if the donation/subscription to the Trust has been made by the donor in the above form or forms.

- (d) The Trustees may by the consent of two thirds of the total number of TRUSTEES for the time being raise or borrow money required for the purpose of the Trust on Mortgage or Pledge of the Trust Estate or any part thereof with or without any security and at such rate of interest and on such terms as they shall in their ~~absolute~~ discretion think fit.
- (e) The TRUSTEES may demise the immovable property or properties for the time being and from time to time belonging to the Trust either from year to year or for any less term or for any term of years or on monthly tenancies at such rate and subject to such covenants and terms as they may think proper and also accept surrenders of leases and tenancies and generally manage the same in such manner as they think proper.
- (f) The Managing Committee shall subject to the unanimous approval of the Trustees be at liberty to sell the whole or such portion or portions of the movable or immovable properties forming part of the TRUST ESTATE either by public auction or by private treaty at such price or prices and on such terms and conditions relating to title or otherwise in all respects as they may in their absolute discretion think fit and to rescind or vary any contract for the sale thereof and to re-sell the same without being answerable for any loss occasioned thereby and for that purpose to execute all necessary, conveyances, transfers or other assurances for all moneys received by them.
- (g) The Managing Committee may pay all charges and outgoings payable in respect of any immovable property for the time being forming part of the TRUST ESTATE and may carry out repairs required to be done to the same and keep the same insured against loss or damage by

fire or any other type of insurance risk and may incur on behalf of the TRUST pay all other costs, charges and expenses of and incidental to the administration and management of the Trust Estate and the properties for the time being belonging to the Trust as they may in their absolute discretion think fit.

- (h) The Managing Committee shall have full power to institute defend prosecute, compromise or compound all actions, suits, and other proceedings and all differences and disputes touching the Trust Estate and/or the Trust ~~properties~~ and to refer any such action, suits, proceedings and differences relating to the Trust Estate and/or the Trust Properties to arbitration and to do and execute all necessary acts, deeds and things in that connection without being liable or answerable for any loss occasioned thereby.
- (i) The TRUSTEES may frame schemes and rules and regulations including Rules for Election of TRUSTEES and office bearers, for the management and running of any institution established, run or aided by them, for managing the affairs of the Trust and otherwise for giving effect to the objects and purposes of the Trust and to vary the same from time to time.
- (j) The Managing Committee may appoint and dissolve Committee or Sub-Committee and ~~delegate such of its powers~~ to the Committees or Sub-Committees so appointed as they may in their sole discretion think fit. Persons who are not Trustees may also be the member of such committees or sub-committees.
- (k) The Managing Committee may employ Servants, Agents, Attorneys, Lawyers, Auditors, ~~Officers, Doctors, Nurses and Contractors~~ for managing the affairs of and in Furtherance of the objects of the Trust and pay them such salaries, emoluments, bonus, gratuity, annuity, wages and delegate to them such power or powers as the Managing Committee may in their sole discretion think fit.

- (i) No Trustee can file any suit or take any type of legal action against the Trust or any other members or office bearers concerning this Trust in any Court of Law except of very grade criminal nature. All dispute and difference shall be resolved mutually or by the decision of two third majority of the Board. Any member who will violate and disregard this clause and take any matter to Court of Law concerning this Trust will cease to be member of the Trust for a period of six years. No Court should entertain any such dispute.

ACCOUNTS & AUDIT

The Managing Committee shall maintain and keep true and accurate accounts of all moneys received and spent and all matters in respect thereof in course of management of Trust properties or in relation to the carrying out of the objects and purpose of the Trust as well as of all the assets, credits and effects of the Trust Estate and draw the Receipts and Expenditure and other accounts and a Balance Sheet at the end of every March of the Financial year.

The Trustees, in every Annual General Meeting, shall appoint an Auditor or Auditors for Audit of Accounts of the Trust and the Auditor so appointed, shall submit the Audit Report along with the Annual Report to the Trustees

In case the Trust is dissolved or revoked for any purpose, the funds/ cash/Movables or Immovable properties of the Trust shall vest or applied in any charitable organization or purpose as will be decided by the Trustees at that time.
