40% for Items that sell for under \$97.00 (Excluding Taxes/ Fees)

50% for items that sell for \$98.00 or more. (Excluding Taxes/Fees)

60-70% for AUTHENTIC Designer Handbags that sell for \$399 or more. (Excluding Taxes/Fees)

We RESERVE the RIGHT to DONATE Any Items found to have noticeable stains, piling, defects, chips, holes, broken zippers, snags, strong odor, missing buttons, moth holes...Without Notification.
