

Estimated Tax Payment

If you're self-employed or an independent contractor, you should be making quarterly estimated tax payments in order to possibly avoid receiving a penalty or tax bill come tax season. We remind you that the deadline for the last payment of 2023 is January 16, don't miss it!



Standard Mileage Rate

The standard mileage rates for the use of a car for 2024 (also vans, pickups or panel trucks) will be:

 67 cents per mile driven for business use, up 1.5 cents from 2023. (IF you are a business owner/self-employed.)


Report Beneficial Ownership Information

As of January 1, 2024, if you are an owner of an LLC, you are mandated to report your beneficial ownership information to FinCEN. The purpose of this report is to provide information about the beneficial owners (all those that own 25% of the business or exercise substantial control over the company.)

Reports should be filed by January 1, 2025 for companies created before January 1, 2024 and within 90 days for newly created companies. To file your report you must go to https://www.fincen.gov/boi

- Click on File a Report
- Click File Online BOIR
- Click on Initial Report or Update Existing One
- Input your business information (EIN/SSN, address, etc.)
- Identify if your LLC was formed before January 1, 2024 or after. Answer a few questions, upload identification.
- Add beneficial owners and their information.
- Send in your BOI Report.

Make sure you don't miss the deadline or you could be looking at a \$500 per day penalty up to \$10,000 or even jail time.



W9s and Cash Expenses

We kindly remind you that if you have not sent in your updated W9 Forms or your Cash Expenses made in the year 2023, this must be done at the earliest convenience. Forms 1099 must be filed before the end of January, avoid rushing at the last minute and send in your forms!
