

This program focuses on business in the City of Milwaukee looking for business financing during COVID-19. As long as the job creation/ retention requirement is met within six months of loan closing the loans are forgivable. The application will be available on Friday, November 13th at noon. The application will remain open until 11:59 PM on Sunday, November 22nd.

- The maximum amount is of \$15,000 and minimum of \$5,000.
- Term of 12 months if loan is not forgiven.
- Funds must be used for working capital for business purposes only.
