
## To Achieve our Mission

Creating new members is not just the responsibility of the Pastor, or the Elders or the Director of Evangelism. Creating new membership is the congregation's responsibility.

The easiest way to increase our membership, is to bring in new members. Do not miss an opportunity to bring a friend, a neighbor, and acquaintance, someone who has moved into your neighborhood, to visit at Peace.

Continue to be mindful that many of our visitors are just that, visitors. Make them feel welcome when visiting Peace. If they have a vacation home here, they may be the next retiree at the lake, and future members of our congregation. Remember, that is the way most of us got here.

### **The Good and Bad News**

**The bad news.** One of our four Heating, Ventilating and Air Conditioning (HVAC) units has quit working. We have been discussing the age of our equipment for some years, and warning the congregation that we could start to have some issues. It has arrived. We anticipated the cost to be around \$9,000 per unit when and if we lost one of the HVAC units. Trustee Chuck Kral has been working with the HVAC company that put these units in some 26 years ago. Chuck has worked with McGuire Heating & Cooling, and obtained a quote of \$7,000. This is an extremely good quote. Now we have to figure out how we are going to pay for this necessary expense.

**The good news.** I would like the congregation to take a slightly different direction than we have taken for the past ten or fifteen years with our Voters Meetings. Our Voters Meetings are a carbon copy of what is done at the Church Council Meetings.

Historically we ask each Officer and Director to give a verbal report, and you receive the same report they have given to at least a third of the attendees, just a week before. This seems redundant and even worse, "just going through the motions." I know each of you can read, and if you have questions you will ask them.

### **Approach to Improving Meetings**

After our October 14<sup>th</sup> worship service, we will be passing out a packet of information to each of our member families. This will include the minutes of the October 9<sup>th</sup> Church Council Meeting, the quarterly Treasurer's Report, and the year to date Financial Secretary's Report. You will have these for three days prior to the October 16<sup>th</sup> Voters Meeting, to read. If you have any questions at the Voters Meeting, and after the review and approval of the previous Voters Meeting minutes, you will be able to ask them, and the officer or director responsible will respond to the questions. You will see from the agenda, we will have short reports from the Auxiliary Organizations that do not make monthly reports to the Church Council, but otherwise we will restrict ourselves to the issues at hand.

I believe this approach will improve the quality of our Voters Meetings, and encourage more participation by the Voters.

The Voters Meeting Agenda is included in this message.

## Swig Sugar Cookies

This is the original and best recipe for copycat Swig Sugar Cookies!

Prep time: 10 minutes

Servings: 24 cookies

Cook time: 8 minutes

Calories: 293 keal

Total time: 18 minutes

### Ingredients

1 cup butter, room temperature

2 eggs

3/4 cup vegetable oil

1/2 teaspoon baking soda

1 1/4 cup sugar

1/2 teaspoon cream of tartar

3/4 cup powdered sugar

1 teaspoon salt

2 tablespoons water

5 1/2 cups flour

### Preparation

1. Cream together butter, vegetable oil, sugars, water and eggs.
2. Combine dry ingredients and slowly add to butter mixture.
3. Mix until everything is combined. Your dough should be a little crumbly and not sticky at all.
4. Roll a golf ball sized ball of dough and place it on your cookie sheet.
5. Now its time to give these babies their signature rough edge. Put 1/4 cup of sugar and a pinch of salt in a dish (this is in addition to the sugar and salt listed above.) Stick the bottom of a glass in it. This is going to be your cookie press.
6. Firmly press it into the center of your dough ball. You want your dough to spill out over the sides of the glass. If there is a lip its even better.
7. Bake at 350 degrees for eight minutes. They should just barely be browning on the bottom. Move cookies to a cooling rack. Once they are cool put them in the fridge.
8. Start by creaming together butter and sour cream and salt. Slowly add powdered sugar. When it gets so thick its not frosting like add a splash of milk, Alternate this process until your frosting is the desired consistency. Add one drop of red food coloring and whip on high for one minute.
9. Keep cookies in a sealed container until they are ready to serve. The magic of a Swig Sugar Cookie is that the cookies are cold and the frosting is room temperature. Frost right before serving (if you make them in advance and need to refrigerate the frosting make sure you give it time to warm up before serving.)

## Council Meeting Minutes

### September 11, 2018

Vice President Dale Lawson called the meeting to order at 6:30 P.M. and opened with prayer.

The following board members were present: Mic Carlson, Dale Lawson, Susan Kral, Rita Riemann, Chuck Kral, Diane Borgmann, Bob Borgmann, Dawn Hedberg, Russell Schultz, and Bob Mueller.

The minutes from the August 21, 2018 meeting were reviewed and approved as printed.

► **President:** Mic Carlson reported the following:

The church's phone service is now part of Mic's personal phone service. He is also using his unlimited hot-spot service for the church internet service. One telephone was purchased for the church. The church will pay \$80.00 for phone and internet services. He will bill the church for the phone line and internet gigs used by the church.

Mic and Jacey Heinlein have discussed ways that Thrivent Action Teams can provide funds for projects or items needed by the church. Projects need to be in the \$200-\$225 range. Officers and elders are asked to present possible projects.

The Calling and Planning Committee met on Sept. 11, 2018. President Hagan asked that an individual be contacted to serve as our Interim Pastor. The committee discussed what would be the expected duties and responsibilities of this person. Salary for the individual was also discussed.

All Sundays in September are covered by supply pastors.

Officers and Directors will be elected at our October Voter's Meeting. The following offices need to be filled:

► **Financial Secretary:** Mic Carlson presented the report for Vicki Stauch. The report was accepted and approved.



►► **Treasurer:** Rita Riemann presented the treasurer report. The August checkbook balance was \$9,206.84. August deposits totaled \$6,208.73. Monthly expenses totaled \$3,211.78. The difference is \$2,296.95. Rita's report was accepted and approved.

►► **Elders:** Bob Mueller stated that the elders are working on updating the church's membership roster. Names will be placed on inactive lists.

Visiting pastors have all done a fine job. Their efforts are appreciated.

A budget for 2019 was discussed at an elder's meeting. Bob's report was approved and accepted.

►► **Ushers:** No report

►► **Member at Large:** No report

►► **Trustees:** Chuck Kral reported the following:

1. Help will be needed to fill in holes at the cemetery where animals have been digging. Hibdon Gravel donated a load of dirt. A thank you note was sent.

2. The new thermostats were installed by McGuire Heat and Cooling. They again added freon to one air conditioning unit.

3. During a heavy rain Chuck discovered that the garage skylight was leaking. He sealed all around it.

4. He purchased parts to repair the Cub Cadet. (\$134.29)

5. After finding that the fuel cans were empty, he purchased diesel and regular fuels. The report was approved and accepted.

►► **Education:** Vacant

►► **Evangelism:** Russell Schultz sent email letters to Missouri Synod churches inviting their members to visit Peace Lutheran if they are visiting our area. He received one acknowledgement with a request that they send a similar invitation to Peace.

Peace Lutheran is now listed with the Lake Area Chamber of Commerce. The report was approved and accepted.

►► **Stewardship:** No report

►► **Cemetery:** Diane Borgmann reported the following:

1. Rodney Schultz will spray the cemetery pathways and trim the large bush in front of the cross.

2. The cemetery checking account balance is \$2,468.45. The report was accepted and approved.

►► **Pastor:** Vacant

Mic Carlson reported that he and the elders worked on membership lists.

1. Twenty members have relocated and have not transferred membership. These people will be placed on an inactive list.

2. Twenty-four members have not attended in at least one year. These names will be placed on an inactive list.

3. The elders will review these lists and will recommend at the voters meeting that the names be removed from our active rolls.

These actions will take our official membership down to 66 people. The report was accepted and approved.



►► **Old Business:** There was a suggestion that Peace Lutheran donate our excess property to Synod if it is decided that Synod will use it to build a nursing facility. The matter was tabled.

►► **New Business:**

1. A proposed budget for 2019 was reviewed. Some changes were made in the proposal.

2. Dale requested that Doris Lawson be phoned when anyone is donating altar flowers. There have been times when she was unaware that the Sunday was covered. Please call her a week before giving flowers.

3. It was noted that the Peace Lutheran business cards have the former Peace Lutheran telephone number. Susan will ask the LWML members to put the new phone number **573-836-3959** on the cards at their September 12 meeting.

4. There was discussion regarding putting the photos and personal information of frequent visitors in everyone's church directories.

The meeting was adjourned, the council closed with the Doxology.
