

### **Christian Symbols**



**DOORPOSTS** — The image of a blood-marked doorframe is from the Passover account in Exodus. God directed the Israelites to slaughter lambs for a final meal and paint their doorposts with the blood. God sent the Angel of Death to kill the firstborn sons of Egypt, but the blood signaled that the Destroyer should "pass over" those homes. Likewise, the blood of Jesus, the Lamb of God, saves us from eternal death. 'd like to return to the topic of conflict resolution in the church; this church; our church. You know, the one that has the name Peace in it. So I thought I'd begin by disclosing that Pastor Brandt and I had a serious disagreement a few weeks ago. You see, it was after the February council meeting. That's right, *after*. And yet somehow, we got through this conflict. None of us who often carpool together—Sara, Pastor Brandt, or myself—had eaten dinner *before* the meeting, and we were all hungry. So, we found ourselves eating dinner together at the *Grid Iron*, restaurant. Neither Pastor Brandt nor I knew that such a deep, wide, and dark chasm existed between us.

Some of you will agree with me, I'm sure; others will not. But I'm a mediumrare, almost rare kind of guy. Pastor Brandt, however, walks on the dark side. Um, I mean he likes his steak cooked medium well. Now, here's the thing; the *Grid Iron* won't cook one steak two different ways, despite the fact that they have a \$2.00 charge for splitting a meal. So, our first attempt at resolving the dilemma was to get the steak medium. That ought to have worked, right? But after I had eaten a dinner salad, I was pretty full. So, I told the waitress, shortly after ordering, to go ahead with medium well. Problem solved; conflict re-

solved. Everything was "good to go" other than the steak we shared. (I'm afraid I'm still a medium rare kind of guy.)

I hope you see the humor in this true story because there are times, in the life of the church, that individuals will have conflict over something that's really what is known as *adiophora*—something that is neither commanded nor forbidden by Scripture. And because they are neither commanded nor forbidden, we have the Christian freedom to choose to do something or not to do it.

I'm really liking the steak analogy because it helps us see that sometimes



something *is* important, and sometimes it's not. So, let's continue to follow this theme for a little while longer. I'd like for you to think of Dr. Suess for a

minute. Although he is long since dead, he wrote a book called *The Bitter Butter Battle*. In it, he rhymes about two groups of people who argued over whether you're supposed to eat your bread with the butter on the top or turn it over and eat it with the butter on the bottom. He was trying to teach kids (and adults!) that sometimes things get blown so waaaay out of proportion. And sometimes one needs to recognize it and back up to find some resolution. So, when you think of conflict at its lowest level either remember Pastor Brandt's steak (or mine) or the *Bitter Butter Battle*.

Have you ever had a bitter battle with someone over something you later realized was *not* nearly as important as it felt like it was in the heat of the moment? The thing about Peace (our congregation) is that you (plural), with the help of the Lord, have not had any such battle for at least the two or three years or so Pastor Brandt and I have been a part of this wonderful gathering of saints. So, let there be no lines drawn between you *Medium-Wellers* and you *Medium-Rarers*.

You may remember that at its lowest form conflict is simply having a difference of opinion with someone. With the help of the Lord, I pray that this continues to be our way of working and playing together. Said another way, please keep your eyes and lives focused on the cross and let Jesus "Draw all people unto himself" by and through it.

I'm going to be quite hokey here and say we all have a *stake* in continuing to promote peace, here at Peace. And may the Lord bless each of us as we seek to do so. Perhaps that means we learn to laugh at ourselves more often. Whatever it may be, remember that it will not be long until we (all!) proclaim: Christ is risen! He is risen, indeed! Alleluia! Amen.

#### Most historians would

**Say** that Pat Garrett killed Billy the Kid on July 14, 1881. Most people would think Billy's death should have closed the history books on the outlaw's notorious life. If that's what most people think, they would be wrong.

Now, almost 130 years after the events transpired, the governor of New Mexico, Bill Richardson, is thinking about granting a posthumous pardon to Billy. It is a gesture that is not sitting well with the descendants of Pat Garrett. They have a number of objections to the matter. First, it would call into question the actions of their ancestor. Second, they think it's wrong to pardon a criminal who was responsible for the murder of two lawmen as well as many others.

Now the purpose of this devotion is not to share my opinions about a governor who wishes to pardon a murderer who has been dead for 125 years. I have some definite feelings about the matter, but they are not important here.

No, the purpose of this devotion is to talk about the idea of a posthumous pardon. As far as the Lord is concerned, there is no such thing -not when it comes to humanity. The Lord very clearly tells us that if we are to be pardoned from our sins, it will happen while we are alive -- not after we're dead. If the substitution of the Savior is to have an impact, if Jesus is to save us that must happen when we're living. There are no do-overs once we're dead. This is one of the reasons the Savior has asked us to share His story of salvation with those around us.

God wants all people to be saved, and that includes those who are in our immediate family and circle of friends. This is why I encourage you to keep on witnessing to the greatness of God's grace which we've seen in the Bethlehem manger, Jerusalem's cross, and the borrowed tomb. Today is the day to believe. Today is the day to share.

**The Prayer:** Dear Heavenly Father, I give thanks for the faith You have given me. Now may I -whenever I can -- share the Savior's story with others. Keep me from postponing my proclamation of Jesus. Don't let me wait until it's too late. In Jesus' Name. Amen.

**Tuesday:** Jesus teaches in the temple for the last time; God sends the invitation to come enjoy His sacrifice.


Wednesday: Judas betrays; Mary perfumes; God waits for the responses to the invitation

#### Answering Objections to the Faith (The Basics of Christian Apologetics)

### The Problem of Darwinism Cont'd


In addition to the artwork of dinosaurs and the discovery of soft tissue in their bones, we also have written records that may depict dinosaurs and other creatures that were their contemporaries.

Job 40 contains one account: "Behold, behemoth, which I made as I made you; He eats grass like an ox. Behold, his strength is in his loins, and his power is in his belly. He makes his tail stiff like a cedar; the sinews of his tail are knit together. His bones are tubes of bronze, his limbs like bars of iron..." What is this animal? Some have suggested an elephant or hippopotamus.

Many Christian apologists, however, believe the animal to be a large dinosaur. The description does seem to fit a large sauropod, a plant eating, land dwelling animal identified as the largest of the land dwelling animals made by God. It had a tail like a cedar trees, elephants and hippos do not. The name behemeth the Hebrew word for merchants

hemoth – the Hebrew word for megabeast – fits very well.

The next creature described in Job (Leviathon) is also of great interest. Up until a few years ago, this creature was identified as a Nile crocodile or a sea monster. However, in 1997 huge a skeleton of an animal called SuperCroc was discovered in a dry river bed in the Saha-



ra Desert. It was similar to today's crocodiles, only ten times larger. It weighed in at ten tons – making it larger than a Tyrannosaurus rex.

The description in Job 41 appears to be a good match for SuperCroc such as:

- **W** The Hebrew word for Leviathan means one who twists as a crocodile will do as it clenches its prey in its mighty jaws.
- Leviathan is described as having a strong neck such as modern day crocodiles.
- **It's back is described** as made up of shields that can't be penetrated by spears and arrows.
- **Its belly was like** pieces of broken pottery a good description of the underside of SuperCroc.
- Leviathan was at home in the water as well as on land.
- God calls him king of the creatures He has made and nothing on earth is his equal. The scientific name for SuperCroc is *sarcosuchus imperator* which fits nicely since the Latin word *imperator* means king.

So how would Job have known about creatures that supposedly became extinct millions of years ago? As far as biblical scholarship is concerned, this information is relatively new. It will be fascinating to see how biblical scholarship responds to this relatively new information. Meanwhile, the Darwinian history of life continues to be called into question.

# **A Better Way**

The most common question about stewardship is not whether a Christian should give to their church. Of course Christians should give to their church. Everyone knows this. Rather, the question asked most is, "How much should I give?" But this question really means, "Should Christians give a tenth of their income to their local congregation?"

Here are some common reasons against tithing. Some say tithing isn't necessary because it isn't expressly commanded in the New Testament. There is no "Thus saith the Lord," or "should" concerning tithing. Others say that Christians give to their congregation in ways much broader than money. They give of their time and their talents, and these together with treasures (money) add up to more than a tithe. Still others say that they give of their treasures to other things besides their congregation, and they want to support those things alongside their church. And then there are those who think Christians shouldn't tithe because of some fear. They are afraid that if they tithe, their gift will be misused, or that after tithing, there won't be enough left over to get the things that they use, want or need.

Here are some reasons why Christians should tithe. Even though the New Testament doesn't specifically command Christians to tithe, the Old Testament people were commanded to. And on top of this, St. Paul often describes giving a regular and generous proportion of the first fruits of one's income — terms similar to a tithe (2 Cor. 8:7–23; 2 Cor. 9:2– 7).

But here's another way to think about it. What was the point of the tithe in the Old Testament? Where did it go? This tithe was intended to support the ministry of the Levites. They were not given any land because they had no time to farm; their full-time job was the ministry. What does it say in the New Testament? "The Lord commanded that those who proclaim the gospel should get their living by the gospel" (1 Cor. 9:14). This is the verse that Luther used in the Small Catechism's Table of Duties to explain what Christians owe to the support of the ministry.

It seems clear from both the Old and the New Testaments that the tithe is the goal of Christians in their giving. But what if we're not there yet? How should we handle this? What are we to do?

Let's answer this by asking a different question. What would you say to your adult children who only attended church quarterly or once a month? After all, there is no passage in the New Testament that requires Christians to go to church weekly. Hebrews 10:25 is the closest verse we have, and it states simply that Christians should not neglect gathering together. And even though there is no passage that commands Christians to gather weekly, that is the implicit expectation throughout the Old and New Testaments. So, what would you say to that son or daughter? The conversation might go something like this. I'm glad you're still going to church. It is a wonderful blessing to hear God's promises of forgiveness, life and salvation, and to receive His gifts in Word and Sacrament. But you can do better, and it will only be a blessing to you. There is a better way, and I'd really like you to try to attain it.

We should approach the topic of tithing with a similar conversation. The tithe is not specifically commanded in the New Testament, but it sure seems like the implicit expectation of both the Old and New Testaments. So, we're ecstatic that you're giving, and that you're giving in all these various ways — time, talents and treasures. But there is a better way. And that will only be a blessing to you, just as the Word of God - Old and New Testament alike — promises. Can you try increasing your gifts over the coming weeks, months and years? Can you put your trust in the God who sent His Son to take away your sin and give you everlasting life?

And if He did this for you, if He did not spare His only Son, how will He not give you all things? He will not disappoint. - reprinted from the LCMS Stewardship Ministry
