

How Did We Get Here? Part 1

By here I mean to the point where certain people want to de-fund the police, decry our history, and derail thoughts or actions that used to be considered patriotic (ie, taking a knee during the national anthem at the Olympics). So how did we get here? Well, this newsletter article will become far too long if I discussed all the factors that I believe brought us to this point, so I will focus on only a few.

For a couple of decades now, I have argued that everyone “believes” something. If you take away the good, right, and salutary beliefs of Christianity you are left with a void that can seem to be filled by something else. That’s when political ideologies can step in and almost feel like matters of faith. It’s true that there are some things that the two had/have in common. For example, the natural revelation of God’s law includes laws that are universal to the world: murder is wrong, theft is a crime, people should love their neighbor as they love themselves, etc. However, I’m sure you know that political ideologies must take a back seat to matters of faith.



I’m often in awe of how it is that so many people have so much time; enough that they are able to attend rallies and protests. By no means am I suggesting that either of these two events is always wrong or bad. In fact, I have participated in a “Life Chain” more than once and have thought, especially in my younger years, of attending the national Right to Life rally/protest in our nation’s capitol. But there is very little chance that the Christians attending would throw Molotov cocktails!

So one very simple explanation I am putting forth (“arguing” in the classic

So one very simple explanation I am putting forth (“arguing” in the classic sense of the word) is that these quite secular events fill the “need” with which humans seem to be born. So an entire team takes a knee and feels as though they have done something vital to “the cause.” And I have no doubt that there are many Black Christians in our country who want to demonstrate that black lives are important/matter so much that even their pastor is involved in the movement.

But what about cries to de-fund the police? What really happens when those whose job it is to protect and serve are removed from the streets? This is sort of a double misguidedness. As Christians we believe that human beings are sinful by nature. That is to say that humanity if left alone (like an ecosystem) will not grow stronger and wiser but will in fact break down (as per the second law of thermodynamics). Unfortunately, the truth that man is by nature sinful and unclean is no longer evident (if it ever was) to those who take their ideology (a.k.a. “belief) to the streets.

So we find ourselves, in 2021, living in or among a culture that considers political ideologies more important than the Christian faith and feels (or thinks) humankind can pull itself up by its own bootstraps. These are just two factors at play in the USA today. Because there is certainly more to say I will write on this subject again for October’s newsletter article. In the mean time, I would enjoy hearing your feedback on what I’ve said and your thoughts on what I might be overlooking.

The Miracle of DNA—Part 3

In Christian apologetic terms the anthropic argument says that all life is dependent on the specifications, criteria, and physical laws of nature and that life itself could not have come to exist without an all-powerful, all-knowing creator. In recent years the scientific community has been stunned to learn just how complicated the universe is: for example, the ability of inorganic matter to become life. Describing the many steps it would take for this to happen is complicated and too extensive to give in detail here. Basically, atoms would have to form elements – in this case nitrogen, carbon, and hydrogen. These would somehow have to combine to form purines and in turn the chemicals pyrimidine and imidazole which are known as nucleic bases. Then these bases would somehow have to combine with 5C sugar, and phosphate to form the essential nucleotides to form RNA and then DNA. And then genes with their programmed codes are somehow placed in DNA in a specific order to make it possible to form, maintain, and replicate life. It is known that these substances bond chemically, but it's unknown why they should have that propensity. It all goes back to the laws of physics – a few dozen of them - that have been “programmed” into the universe and several hundred specifications needed for life to exist. So, what are the odds that life could exist without an omniscient, omnipotent creator? Back in 2001 astronomer Hugh Ross, who in a chapter in the book *Why I Am A Christian*, lists 35 physical laws for the universe to exist and 122 parameters for the solar system. He calculates the odds as being 1 chance in 10^{138} (that's 1000 with the word “trillion” written eleven times behind it). To give an idea how incomprehensibly high that number is, the number of atoms in the universe is thought to be around 10^{70} . The complicated process plus the intelligence and thought it takes to make it all work is most certainly evidence of a creator God – Creator of Heaven and Earth!

If I had kept that money, I would have lost it too. I am thankful that I gave that building when I did.” How about you? Are you glad for the good things you've done? Or do you regret the sacrifices you've made for others? Mothers, are you sad you did without, so your children could dress right for school? Fathers, do you feel your time and sweat on the job has been ignored as you tried to provide? If so, you need to be like the man in our story. Indeed, you need to be like the Lord. Almost 2,000 years ago Jesus died to save us from sin, death, and Satan. If the statistics are correct, there are hundreds of millions of people who don't believe in Him or the salvation He has won for them. Nowhere in the Bible do I see any sorrow on Jesus' part for having made the sacrifice He did. On the contrary, there is great rejoicing in heaven for every sinner who repents. In short, heaven is rejoicing at the good Jesus has done. Might I suggest we should do the same? We need to rejoice in the good the Holy Spirit does through us; we need to give thanks for every opportunity He puts on our plate. True, not every good witness we make results in someone believing the Gospel message, but we're not asked to convert people. We're asked to make our witness and be thankful that God has entrusted the job to us.

Prayer: Dear Lord Jesus, so often I see people living their lives in regret for things they should have said, for that which they might have done. I pray my days will be filled with rejoicing. Let me give thanks where I can, speak boldly where there is an opportunity, and praise the Holy Spirit for the successes He brings. This I ask in the Savior's Name. Amen.

21 And He looked up and saw the rich putting their gifts into the treasury, ² and He saw also a certain poor widow putting in two mites. ³ So He said, "Truly I say to you that this poor widow has put in more than all; ⁴ for all these out of their abundance have put in offerings for God, but she out of her poverty put in all the livelihood that she had." Luke 21:1-4

When it comes to stewardship, a favorite Bible verse is the account of the widow's mite (Luke 21:1-4). It's a moving account. Our Lord praises the seemingly small gift of two copper coins given by a poor widow above the abundance of gifts given by the rich, saying, "Truly, I tell you, this poor widow has put in more than all of them" (Luke 21:3). And that is usually where we stop. But the text goes on. "For they all contributed out of their abundance, but she out of her poverty put in all she had to live on" (Luke 21:4).

"She ... put in all she had to live on." She gave everything. She held nothing back. She trusted that the Lord who made her and all creatures; who gave her everything she had; who redeemed her from her own sin, from death, and the power of the devil; who called her by the gospel and enlightened her with His gifts of Word and Sacrament; would continue to do this. He would provide her with all that she needed for this body and life because that is the character of the God she had.

But this is not why we give small gifts. Her gift, though it appeared small, was actually large. When we are tempted to give small gifts, it is precisely because we want them to be small! We don't trust the Lord to provide for us. We give small gifts because we lack faith in the One who created us, redeemed us, sanctifies and keeps us in the one true faith. We give small gifts because we doubt that God will really give us what we need and desire. We give small gifts because we are not content

small gifts because we doubt that God will really give us what we need and desire. We give small gifts because we are not content with what God has already given.

We are not slaves, children of the slave woman, under the Old Covenant (Galatians 4). We are adopted sons of the free woman. And since we are sons, we are also heirs. And heirs receive the inheritance. For everything is already ours in Christ. And thus, moved by the willing spirit of adoption, we do the will of God in financial matters far beyond all that done by those under the Old Covenant who were forced by legal demands.

So, what have you decided to give? How do I decide what to give? Let the Scriptures be your guide.

We are to give proportionally to what we have received from God's

We are to give proportionally to what we have received from God's giving to us (Luke 12:48; 1 Corinthians 16:1-2, 2 Corinthians 8:12). But you have not been set free to give nothing. See that you excel in the grace of giving (2 Corinthians 8:7)!

We are not free to live selfishly outside the Gospel, without regard for God who gives us all good gifts, without generosity for our neighbor who needs us and our gifts, without supporting the community of faith in which we live, without care for our spiritual fathers and those who teach and help raise our children in the faith, and without resources for the poor and needy.

In short, we are not free to live unto ourselves, hoarding what God has given us only for us. For love is the fulfillment of the law (Romans 13:10). And the sum of the law is this: Love God and love your neighbor (Matthew 22:34-40). We love because He first loved us. We give because He has given to us.

Luther once said, "Possessions belong in your hands, not in your heart" (LW 14:240). There is a reason your 10 fingers spread apart. With your hands you catch God's gifts for what you need and let the rest fall through your fingers to your neighbors – your family, your friends, your community, your church.


Hospitalized?

- Jeff presented that voters approve the nomination of Mic Carlson as Budget Chairman. It was approved unanimously.


