### Christian Symbol Tongues of Fire



Reminiscent of the Pentecost account in Acts 2 when "tongues of fire" rested on the disciples' heads as the Holy Spirit birthed the church, images of flame symbolize the

Spirit. Sometimes a tongue of fire is paired with a dove and set on a red background — other symbols of the Holy Spirit. Fire may also indicate spiritual fervor and zeal in a Christian's life.

### Robe



A robe, specifically one that's new and white, symbolizes the righteousness we receive through Jesus' death and resurrection. Isaiah 61:10 speaks of "the garments of salvation" and "the

robe of righteousness." In Revelation 6:11, faithful martyrs each receive a white robe. People who are being baptized or confirmed often wear white robes as a sign of purity.

# The Resurrection

**B aster** is not merely a one-day celebration; it is a fifty-day season from the Day of the Resurrection of Our Lord to the Day of Pentecost. It is a victory celebration, a time for all Christians to proclaim boldly their faith in a risen and victorious Savior.

However, the women at the tomb and the Disciples were very confused on that first Easter. So I am going to ask a favor of you: would you get out your Bible and read chapter 20 of the Gospel of John? I am going to select eight verses/passages and share a comment on each of them.

1 V. 2 "...we don't know where they have put him!" Although Jesus had attempted to prepare them several times for this event, they still didn't understand the Resurrection.



(2) V. 6-7 "Then Simon Peter,

who was behind him, arrived and went into the tomb. He saw the strips of linen lying there, as well as the burial cloth that had been around Jesus' head. The cloth was folded up by itself, separate from the linen." A thief wouldn't have taken the time to unwrap the linens and face cloth and then fold the cloth.

3 V. 13 "They have taken my Lord away, she said, and I don't know where they have put him." Even Mary didn't recognize Jesus when He appeared to her.

4 V. 15 "Woman," He said, "why are you crying? Who is it you are looking for?" "Thinking He was the gardener. . ." Nor did Mary recognize His voice.

- V. 20 "The disciples were overjoyed when they saw the Lord." Jesus didn't come to condemn them or even to shame them. He brought them peace amidst their grief and sorrow.
- 6 V. 25 "But he (Thomas) said to them, 'Unless I see the nail marks in his hands and put my finger where the nails were, and put my hand into his side, I will not believe it." Thomas didn't even believe his fellow disciples that Jesus was alive. They had just told Thomas that they had seen the Lord!
- 7 V. 26 "Though the doors were locked, Jesus came and stood among them and said, 'Peace be with you!'" How did Jesus get into the house? The doors were locked!
- 8 V. 27 "Then He (Jesus) said to Thomas, 'Put your finger here; see my hands. Reach out your hand and put it into my side. Stop doubting and believe.'" Jesus knew of Thomas' doubts. No one had told Jesus about Thomas' unbelief.

**Conclusion:** The Father accepted His Son's sacrifice, and the Scriptures are now fulfilled!

May you always believe in the Resurrected Lord and Savior, Jesus Christ, and be filled with His peace and joy!

The McConnell's were in the midst of a family reunion. Their widows went on TV holding pictures of their fellas. They said they hoped their sharing would make other people think twice before getting behind the wheel after drinking. I hope so, too. But I'd like to take that one step further. So often today we hear about individual rights. All too

often we forget we are not islands. The things we do directly touch others -- positively and negatively. Nowhere will we find a better example of that fact than in the life and death of Jesus. His entire life was lived for others. He healed lepers when nobody else would come near them; He reached out to prostitutes and publicans when everyone else shunned them; He even gave His life so some sad sinners -- sinners like you and me -might be saved. Now, a risen Redeemer asks His people to live their lives for others, thinking of others, helping others, witnessing to others. We do this not as an obligation, but because these "others" are brothers and sisters. You see, Jesus gave His life for them, too. They just may

not know it. So, today, as you live your life, live it, but don't forget the other guy or gal. You will touch them for the Savior.

The Prayer: Dear Lord Jesus, today I pray You will be with this family and so many other families that mourn a sad and sorrowful situation. Comfort them with a future reunion in heaven. And for us, we pray that You will allow us to be Your witnesses as we go about living our lives. In Your Name. Amen.

# Answering Objections to the Faith **Natural Law**

e have focused on the reasons for recognizing the truthfulness of the Christian Gospel message. The apostle Paul, however, said, "I did not shrink from declaring to you the whole council of God" Acts **20:27**. The "whole council of God" not only consists of the glorious Gospel, but also God's moral law. Do we have evidence of the reality for God's moral law as we do the Gospel? Yes, we do. And how can we proclaim the Gospel to those who deny the genuineness of the moral law and for that reason will see no need for the Gospel? We can do so by

explaining and documenting the "universal moral code" - that is, by describing the nature and existence of "natural law". The scriptures verify the moral law as Paul said in Romans 2:15 that all persons reveal that "the work of the law is written on their hearts." This innate knowledge of God's moral law is what we know as natural law. There are two avenues by which we can understand God's moral law: one is by God's revelation to us in His Word, illustrated by the Ten Commandments. The other is by God having implanted His moral code within us



when he made us human beings (natural law). To be human is to possess the knowledge of God's moral law. Regardless of how we come to understand this moral law, whether by revelation or by nature, the essential content of the moral law is one and the same.

Therefore, having put away falsehood, let each one of you speak the truth with his neighbor, for we are members of one another. (Eph. 4:25)

• od has placed us in, called **J** and crafted our vocations. He has placed us with the people with whom He wants us to be in relationships through our vocations. Our vocations are His work in our lives according to His plans for us and other people. God's work provides an important insight to being His witnesses. Rather than wondering where we should go and to whom we should witness, God has shown us through our vocations. We don't have to go to faraway places to share the Gospel (though some people are called to

do so). Instead we are His witnesses as we go about our daily lives in the places where He has put us. We don't need to create relationships with people just to tell them about Jesus. God has provided many relationships for us in our vocations. The chief purpose of our vocations is to be witnesses in their contexts. God knows the people He has chosen for eternal life (i.e. His elect) and He has placed us in their workplaces, communities, schools, families, and so on as their co-workers, neighbors, classmates, family

members, and friends so that we would speak of Jesus with them. Being His witnesses in our vocations means that we are His witnesses when and live work, study, serve, and recreate—in our everyday lives. 

## **Follow Him in Generosity**

ur Savior calls us to follow Him in generosity. "For I have given you an example, that you also should do just as I have done to you" (John 13:15). We cannot give our lives for the salvation of the world, of course. Praise God, that job's already done! But with hearts full of thanksgiving for what Jesus has given us, we can follow His example of generous giving. And Jesus' generosity is not merely an example. Our Lord also commands us to act according to our gifts: "The one who contributes, [let him give] in generosity" (Rom. 12:8).

So, when we bring offerings to the Lord, we should strive to heed His command and follow the pattern He has established for us. Jesus did not give us leftovers. He gave His best. We should not give leftovers, either, but the first and best of what He has given us. Jesus did not give as an afterthought — He gave according to the plan of salvation God established from the foundation of the world. So, when it comes to our own offerings, we should make a thoughtful plan to give generously, in proportion to the way He has blessed us. Like the Macedonian Christians, who gave according to their ability, and even beyond their ability (2 Cor. 8:3), we should honor the Lord by giving a generous portion of the in-come that God provides us.


We should also give freely, just as Jesus gave freely for us. There is no compulsion involved in our works of love and our offerings to the Lord. We do not give grudgingly, but willingly and cheerfully, each "as he has decided in his heart," as the Lord says (2 Cor. 9:7). There is no New Testament ceremonial law involved here. Rather, we are free to give as generously as our Savior has given for us!

In the same way, our Lord teaches us to give generously out of our love for Him and for our neighbor. Jesus shows us that genuine love is always love "in deed" (1 John 3:18). It is love that sees our neighbor in need and gives generously to help him. It is love that hears the Word of the Lord and does what it says. If we truly love, we give generously. If we give without love, our giving is not truly following Jesus.

Finally, we follow Jesus in generosity when we support His Gospel ministry and other works of mercy. The people of Israel gave generously to construct and support the operation of the tabernacle, for that was the place where the Lord received the Old Testament sacrifices, through which He bestowed the forgiveness of sins on His people. So, they gave abundantly, so abundantly they had to be told to stop giving! (Ex. 36:5–6). In the same way, we should bring generous offerings to support the Lord's work. We support our congregations in the preaching of His Word, Baptism and the Lord's Supper, which bestow His gifts of forgiveness, life and salvation, and we take care of those who are poor and needy.

Our Savior calls us to follow His example in generous giving. Let us then, with thankful hearts, rededicate ourselves to following Him in generosity.

We have not yet received their bill. **President's Report:** In addition to what is published in the monthly council minutes, Bob Hansen reported the following:

- Insurance for the church has been paid for one full year. We saved \$537.00 by paying the full amount. The total paid was \$4609.00. This amount is a savings of \$1891.00 from last year's figure.
- The insurance payment money was borrowed from the Nadine Meyer fund. Peg will make 12 monthly payments of \$384.09 to reimburse the fund.
- Bob reported that he and Diane Borgmann looked over our cemetery grounds to determine if there is enough room to open the cemetery to non-members. They determined that there is not adequate space for that to occur. The issue will be brought before the council.

#### Old Business:

- A question was raised regarding the state of Missouri's perpetual care plan for our cemetery. Jeff Emery explained that this program does not provide maintenance for private cemeteries. The council will discuss the issue.
- Chuck Kral stated maintenance that the center parking lot light is the responsibility of Southwest Electric. He has spoken with a SW representative. The timer on the light will be reset within the next two weeks.
