

2018 Gene Cloud Memorial Spearfishing Tournament Rules

RULES / REGULATIONS / SIGN UP CAPTAINS MEETING:

- The Captains meeting will be held Friday, July 13th at 6:00pm at the (TO BE DETERMINED) Restaurant.
- All team members are welcome and are encouraged to attend; however, at least **1 registered team member MUST attend** to receive each entrant's bucket of goodies, their team members' shirts, and to finalize registration.
- Failure of at least one team member to attend the Captain's meeting in **its entirety will result in disqualification** of said team. There will be no reimbursement of tournament entry fees. **NO EXCEPTIONS.**
- This tournament is a one-day event and is open to spearfishing only. This tournament is open to SCUBA divers and Free divers alike.
- The tournament will start on Saturday, July 14th at 12:01 am and will end at exactly 6:00 pm Saturday, July 14th. The Tournament clock is the official time.

All entrants weighing in fish must be in the "Weigh-In" line by 6:00 pm (NO EXCEPTIONS).

- Absolutely no fish may be harvested prior to 12:01 am on Saturday, July 14th!
- All fish must be presented to the weighmaster in a condition consistent with harvesting by spear only. Any fish that appears to have been harvested in a manner inconsistent with harvest by spear alone will be disqualified.
- All speared fish must be consistent with current local, State of Florida, and Federal Fishing Regulations pertaining to species, size, bag and aggregate limits. It is the responsibility of each entrant to know and understand and follow all rules concerning the harvest of fish species in the Gulf of Mexico, to have the required license(s), and to maintain a safe distance from all "Diver Down Flags" at all times.
- All weighed-in fish must be harvested from the Gulf of Mexico only.
- Each entrant is competing for cash and prizes as an individual. This is not a "boat team" competition.
- All entrants must have their entry fees paid in full by the end of the Captains meeting.
- No fish may be harvested in water deeper than **120 feet**.
- No fish may be harvested more than **30 nautical miles** from contiguous (exposed) Florida State land, this includes Barrier Islands.
- Each fish must be harvested by the entrant alone- with no assistance from anyone else until they reach their boat or point of exit.
- Any individuals exchanging fish in order to alter the outcome of the tournament will be disqualified.
- Weighing in undersize fish will result in the entrant's immediate disqualification.
- Absolutely no fish harvested from Atlantic Waters will be accepted for this tournament. Any fish harvested from anywhere other than the Gulf of Mexico will result in immediate disqualification of that entrant and of that vessel's entire crew.
- All SCUBA divers in this tournament must be properly trained and have obtained Certification from a recognized SCUBA Certification Agency. All divers agree to stay within the safe dive limits of their Certification.
- In order to be eligible, all entrants weighing in fish must have harvested the fish using a spear loaded by his/her own muscle power. In addition, no powerheads or PPDs are allowed to obtain tournament species
- No firearms may be used as a method of harvest.

ANY DEVIATION FROM THE TOURNAMENT RULES MAY RESULT IN AUTOMATIC DISQUALIFICATION

Cash & Prizes

- Cash prizes will be given for the largest fish in pounds for each of the categories listed. **All weighed fish must be presented gutted and free of debris ****
- If a cash prize is won by an entrant under the age of 18, the prize will be given to the parent or legal guardian for disbursement.
- All fish must be presented to the weighmaster by the harvester of said fish. No entrant may weigh in two fish of the same species to see which is heavier. Only one fish per category per participant may be weighed in and no individual can win more than 1 prize in any fish category.
- It is the participant's responsibility to verify his/ her fish entry with the weighmaster's recording. Once the participant signs the weigh in sheet, he / she cannot challenge or protest the recorded weight.
- In the event that an entrant's boat becomes disabled, all participants and catch of said boat may be brought in to the weigh-in by another boat as long as all other rules have been observed. **IN NO EVENT WILL THE WEIGH-IN CUTOFF TIME BE EXTENDED PAST 6:00 pm on Saturday July 14th, 2018!**
- All payouts of any cash and/or prizes to any entrant in all divisions may be subject to the results of a Polygraph. Decisions and interpretations of the polygraph as it relates to the rules will be made by the Tournament Committee and shall be final. Determination of any rules violations or decisions on any protests will be made by majority vote of the Tournament Committee.

Disqualification:

A tournament participant can be disqualified from the tournament and therefore forfeit all cash or prize winnings for any of the following actions:

- Infraction of tournament rules
- Unsafe or careless behavior or unsportsmanlike conduct during ANY tournament related activities
- Failure to comply with any protest investigation
- Failure to abide by any of the final decisions made by the tournament rules committee.
- Immediate disqualification will apply for any individual/s who are deemed uncooperative with an investigation of rules violation. This may include, but is not limited to, at the request of the tournament rules committee, the presentation to the committee of an entrant's dive computers, and GPS/Plotter information from the tournament day or days prior.

Assumption of risk:

I voluntarily assume all risk of injury or death, damage to others, theft of personal property, or that which may arise from activities and rules set forth in this agreement, even when such is caused solely or in part by negligence of others.

I affirm and acknowledge and am fully aware and informed of the inherent hazards and risks associated with SCUBA diving, freediving, snorkeling and any and all spearfishing and associated activities. I understand that the dangers and risks of Diving may cause me to suffer the "Bends / Decompression Sickness" and Breath Hold /lung overexpansion injuries. I fully understand that these risks can lead to severe injury and even loss of life. I expressly exclude my rights to hold anyone other than myself responsible for any injuries incurred during any activity involved with this tournament.

I also understand that participation in any manner or capacity in the 2018 Gene Cloud Spearfishing Tournament may put me in a position or at a site that is remote from a recompression chamber and competent medical assistance. Additionally, I understand that there are risks associated with Dive travel, including but not limited to the possible injury or loss of life as a result of a dive boat accident, as well as travel associated with the activities of Scuba and freediving/snorkeling/spearfishing. Despite the potential hazards and dangers, I wish to proceed and I freely accept and expressly assume all risk, danger and hazards that may arise from these aforementioned activities.

Photo Waiver

In further consideration of the acceptance of my application for entry in the “2018 Gene Cloud Memorial Spearfishing Tournament” I hereby grant full permission to the “2018 Gene Cloud Memorial Spearfishing Tournament” committee members and or agents authorized by the promoters to use, reproduce, copy, license or sell photographs, videotapes and any other record of the “2018 Gene Cloud Memorial Spearfishing Tournament” events, including my name, likeness and or voice for any purpose.

RELEASE OF LIABILITY, WAIVER OF CLAIMS AND INDEMNITY AGREEMENT:

In consideration of being allowed to participate in the 2018 Gene Cloud Memorial Spearfishing Tournament, as well as using any facilities associated in any manner with the “Tournament”, I hereby agree as follows:

- To waive and release any and all claims based upon negligence, active or passive, that I may have in the future against any of the following named persons or entities; 2018 Gene Cloud Memorial Spearfishing Tournament, its officers, volunteers, members, representatives and agents from liability and responsibility whatsoever, for any claims or causes or actions that my estate, heirs, executors or assigns may have for personal injury, property damage or wrongful death arising from any form of participation in the 2018 Gene Cloud Memorial Spearfishing Tournament.
- By executing this agreement, I agree to hold the releases harmless for any injury or loss of life which may occur to me during the course of the 2018 Gene Cloud Memorial Spearfishing Tournament.
- By entering into this agreement, I am not relying on any oral or written representation or statements made by the releasees, other than as set forth in this agreement.
- If any provision, section, subsection, clause or phrase of this release is found to be unenforceable or invalid, that portion shall be severed from this contract. The remainder of this agreement shall be construed as though the unenforceable portion had never been contained in this document.

I hereby declare that I am of legal age and am competent to sign this agreement and if not, my parent or legal guardian shall sign on my behalf. My parent or legal guardian has read, understands, and accepts all the terms of this agreement.

I have read and understand and accept all the terms of this agreement and I assume all risk associated with scuba diving, freediving, snorkeling and spearfishing.
