## NEWS AND NOTES

### NASOH AND COLLABORATION

In 2010, NASOH's executive board established a committee on collaborations, consisting of Mike Crawford, Vic Mastone, and Geoff Rosano, tasking it with promoting the two goals of NASOH's Strategic Plan that relate to collaborating with other organizations having missions compatible with ours. One of these strategic goals is to "encourage scholarly sessions on maritime topics at meetings of major historical societies." The other goal is to "increase participation in conferences of NASOH and other national and international maritime organizations." The committee concluded that the first step in advancing these goals was to identify those associations with which efforts at collaboration would most likely bear fruit. To that end, the committee conducted a survey of the membership, soliciting the names of the professional organizations whose annual meetings members frequently attend. Thirty-six members responded to the survey that identified forty-eight different organizations whose annual meetings those members regularly attend.

It seems evident that NASOH would get the best return on efforts invested in sponsoring panels at a small selection from among nine conferences drawing the largest participation of NASOH members. These are meetings of the American Historical Association (AHA), the U.S. Naval Academy Naval History Symposium, the Organization of American Historians (OAH), the National Maritime Historical Society, the Council of American Maritime Museums, the Canadian Nautical Research Society, the Society for Historical Archeology, the Steamship Historical Society of America, and the Society for Military History. Members of the board arrived at a consensus that NASOH's collaborations should be with other maritime-focused organizations, rather than in the form of parallel sessions during the annual meetings of large-scale organizations with a high percentage of non-maritime related interests, such as the AHA and the OAH, where maritime history would be lost among a *mélange* of competing specializations.

It may be worth the small effort it would take to reach out to members of all of the organizations that survey respondents identified as having members with interests in maritime topics, inviting them to attend NASOH's annual meetings as well as propose papers. This might be accomplished by placing announcements in those organizations' newsletters. Linking websites with the websites of all the organizations enumerated in the responses is one possible way of encouraging cross-fertilization among the myriad of scholars working in fields related to maritime history. We should build on our recent history of regularly collaborating with other organizations for joint conferences. We regular co-organize our annual conference with the Council of American Maritime Museums, the Canadian Nautical Research Society, the Steamship Historical Society of America, and the National Maritime Historical Society. However, we have not co-organized with the AHA, OAH, or U.S. Naval Academy Naval History Symposium. Greater than 60% of the respondents suggested these latter three. But, again, members of the executive board are alive to the dangers of becoming swallowed up by massive conferences like those of the AHA and OAH. NASOH might act as a more active broker/matchmaker in alerting members about smaller gatherings and programs, perhaps suggesting or soliciting participation. This might involve individual participation or a panel proposal. Perhaps these might be more regional in nature, especially in a time of expensive travel and limited funding.

What then is the way forward to reach our goals of encouraging scholarly sessions on maritime topics at meetings of major historical societies and increasing participation in conferences of NASOH and other national and international maritime organizations? The executive board or the president on his own authority would do well to adopt the following recommendations. 1. choose among the 2013 meetings of the U.S. Naval Academy Naval History Symposium the National Maritime Historical Society, the Council of American Maritime Museums, the Canadian Nautical Research Society, the Society for Historical Archeology, the Steamship Historical Society of America, and the Society for Military History, to propose one or more sponsored panels on maritime history; 2. task the planning committee for NASOH's 2013 annual meeting to place invitations to attend and calls for papers in the newsletters and on the websites of the ninety-one organizations identified by survey respondents as having some maritime-history affinity; 3. task the webmaster of NASOH's website with asking a selection of those ninety-one organizations to link their websites with ours; 4. ask the editor of the newsletter and the webmaster to invite members to send in notices of conferences of other organizations of possible interest to other members to be advertised in the newsletter and on the website; 5. appoint the editor or webmaster or another NASOH member to serve as a clearinghouse for members seeking others to serve on conference panels—the editor of the newsletter is, in fact, already doing this—; 6. continue co-organizing our annual meetings with likeminded partner organizations.

## HISTORIC PRESERVATION

**U.S. court backs Spain over \$500M sea treasure,** <http://www.cnn.com/2012/02/01/world/europe/spain-u-s--treasure-dispute/index.html> Spain has won a major victory in its long court battle with a Florida-based deep-sea salvage company over rights to an estimated \$500 million in silver and gold coins, officials said Wednesday. The 11th U.S. Circuit Court of Appeals in Atlanta turned aside another motion from the U.S.-based company, Odyssey Marine Exploration, and Spanish officials said they now expect the coins -- nearly 600,000 of them -- to arrive in Spain soon. "With the ruling by the appeals court, the process begins to recover all of the coins taken illegally" from the sunken ship, Spain's Culture Ministry said in a statement. The battle royal began after Odyssey announced in 2007 it had found the sunken treasure. It quickly laid claim to the coins, put them in crates and said it flew them to a discreet, well-guarded location in the United States. Spain soon filed suit in a federal court in Tampa, Florida, also claiming the treasure. Spain says its navy warship *Nuestra Senora de las Mercedes* was carrying the coins. The *Mercedes*, a 34-gun frigate, left Peru in 1804 and crossed the Atlantic to within a day's sail from Spain when British ships attacked the Spanish fleet. In the ensuing Battle of Cape St. Mary, south of Portugal, the *Mercedes* exploded after being hit in its powder magazine, according to the Spanish government's filing to the Florida court. The federal court in Tampa in 2009 ruled in favor of Spain's claim to the treasure, but Odyssey took the case to the federal appeals court in Atlanta, which ruled last September to uphold the lower court's ruling. It appears that Odyssey's only possible appeal now would be to the U.S. Supreme Court. The appeals court is expected to send the case in the coming days back to the federal court in Tampa, which would establish and supervise the procedures for sending the coins to Spain, Goold said. Peru has also followed this case. The silver and gold came from Latin America when Peru was a Spanish colony. "Formally, they haven't claimed anything, but we are completely open to consider the possibility of distributing some part of the treasure also among the Latin American museums," Wert said. The treasure includes a vast trove of coins, included fabled "pieces of eight," some minted in 1803 in Lima, Peru, Spanish officials said at a 2008 news conference. The treasure already has crossed the Atlantic ocean twice -- by ship in 1804 and then by plane in the other direction just a few years ago. **American Diggers:** Late last week the SAA Board was informed that there are two TV series planned that promote and glorify the looting and destruction of archaeological sites. They are American Diggers and Diggers. The first is scheduled for Spike TV and the other for National Geographic TV. As past SAA President Bob Kelly wrote in a recent e-mail in response to American Diggers, "This shameless and shameful program will glorify and promote the mindless destruction of archaeological sites in the U.S." SAA and other groups, such as SHA, have already prepared and sent strong letters condemning both of these programs to the production companies, networks, and others. Copies of the SAA letters can be found on the SAA website (<http://bit.ly/w2MHJM>, and <http://bit.ly/wzT7IA>). The letters provide details on why we are so concerned. Up to this point Spike TV has not responded to the public outcry. Leadership of National Geographic, however, has indicated that, while they are unable to stop the showing tomorrow on such short notice, they will place a disclaimer into the show that speaks to laws protecting archaeological and historic sites. They are also willing to enter into discussions with the archaeological community to determine how to raise awareness of the impacts of the use of metal detectors for treasure hunting. We will advise you of developments in this area. BUT for the Spike TV program we need your help. ## FELLOWSHIP ANNOUNCEMENT

**The Naval History and Heritage Command**, an official agency of the United States Navy, is offering the following competitive opportunities for funding of research and writing on the U.S. naval history for the academic year 2012-2013. The application deadline for all of these programs is **30 March 2012**. All awards are based on merit, regardless of race, color, creed, or sex. Recipients must be U.S. citizens.

### Rear Admiral John D. Hayes Pre-doctoral Fellowship in U.S. Naval History.

The fellowship provides financial and scholarly aid for dissertation research and writing. The subject matter of the dissertation supported should significantly enhance knowledge of U.S. naval history. A stipend of \$10,000 for the fellowship year (September 2012- June 2013) will be provided in two payments. The successful applicant will be asked to travel twice to NHHC's Washington headquarters, once at the beginning of the fellowship period to meet with command historians, and once at the end of the fellowship period to make a presentation on the progress on the dissertation. A single travel grant of up to \$2,500 will be made to finance these two visits. Applicants must be citizens of the United States, not on active duty in the armed forces; be enrolled in a recognized graduate school; have completed requirements for the Ph.D. except the dissertation by 30 June 2012; and have an approved dissertation topic in the field of U.S. naval history. Current fellows applying for continuation of the fellowship for a second year will be considered on an equal competitive basis with other applicants.

### Vice Admiral Edwin B. Hooper Research Grant.

The grant is intended to assist a scholar in the research or writing of a book or article by helping to defray the costs of travel, living expenses, and document duplication, related to the research process. One award of up to \$2,500 will be made on a competitive basis. Applicants must be citizens of the United States and hold a Ph.D. degree from an accredited university, awarded no later than 30 March 2012, or equivalent attainment as a published author. Proposals that have high promise of filling gaps in the literature of U.S. naval history that the Naval History and Heritage Command has identified as of higher interest are eligible for consideration. The command's list of priority subjects in U.S. naval history is posted on the command's website, [www.history.navy.mil](http://www.history.navy.mil) <<http://www.history.navy.mil>> . Evaluation is based on evidence of ability, including previous scholarship, letters of recommendation, and the nature of the proposed research and its potential contribution to modern scholarship on the history of the United States Navy.

### Rear Admiral Ernest M. Eller Graduate Research Grant.

The grant is intended to assist a graduate student in the research and writing of U.S. naval history in fulfillment of the requirements of a master's or doctoral degree by helping to defray the costs of travel, living expenses, and document duplication related to the research process for a master's thesis or doctoral dissertation. The stipend is an amount up to \$2,500, depending on the research expenses anticipated. Preference will be given to proposals that have high promise of filling gaps in the literature of U.S. naval history that the Naval History and Heritage Command has identified as of higher interest. The command's list of priority subjects in U.S. naval history is posted on the command's website, [www.history.navy.mil](http://www.history.navy.mil) <<http://www.history.navy.mil>> .

### Samuel Eliot Morison Scholarship.

The purpose of the scholarship is to promote the development of a broad understanding of Naval History within the American national experience. The scholarship provides a \$5,000 cash award to one active duty commissioned officer of the U.S. Navy or U.S. Marine Corps with demonstrated leadership potential and high academic qualifications who is already pursuing graduate study in history, international relations, or a related field. The award is to help pay for expenses related to research, travel, and the purchase of books or other educational materials.

The **American Merchant Marine Museum** at the US Merchant Marine Academy in Kings Point, NY is pleased to announce the opening of a new exhibit entitled "CONVOY! Supplying Allied Victory in World War II," commencing 12 January 2012. This exhibit explores the Allied effort to supply its forces and civilian populations during the dark days of the Second World War, emphasizing the enormous industrial and logistical effort the various Allied nations put into shipping and connecting the powerful US industrial economy to the war effort, literally supplying victory against Fascist oppression. Working in conjunction with the Society for Miniature Ship Collectors, the Museum has configured a completely new display centered around a stunning diorama of a World War II convoy in 1:1250 scale that is eleven feet across! Special themes considered include the infamous "Murmansk Run," the contributions of the SS Ohio in saving Malta, and the diverse ships and crews of the convoy!

This exhibit marks a new era for the Museum as for the first time it is utilizing state of the art touch screen technology, video and audio presentations, and a number of maps and graphics created specifically for this exhibit, all in addition to its prized collection of paintings, ship models, and other artifacts, such as an original survival suit, and fragments of an oil tanker that exploded and sank with all hands after being torpedoed. ## FIELD SCHOOLS

**Saint Mary's College-University of Rhode Island**, 2012 Summer Field School in Maritime Archaeology. The Summer Field School in Maritime Archaeology is a joint research expedition conducted in Bermuda by faculty and students of Saint Mary's College of California and the University of Rhode Island. The field school is a research-based learning experience that will expose students to a variety of activities including archival research, artifact conservation, remote sensing survey, and underwater documentation of historic shipwrecks. The field school will be conducted in the three week period from 16 July- 8 Aug 2012. Classroom work related to maritime history and maritime archaeological field methods will comprise week one. Underwater research and documentation of 16th and 17th century shipwrecks will be conducted in Bermuda during the remaining two weeks. Students will receive 3 units of upper division anthropology credit.

Course enrollment is limited. There are no academic prerequisites, but all participants in the field school must obtain both scuba and AAUS certification prior to the beginning of the field school and must have their own diving equipment. In addition, students will attend periodic lectures on such topics as archival research methods, archaeological survey (magnetometer and visual survey), site excavation and mapping, analysis of archaeological data, conservation of waterlogged artifacts, etc. For applications or additional information, please contact Professor James M.
