

# THUNDER BAY NATIONAL SANCTUARY NASOH CONFERENCE 2013

The 2013 Annual Conference of the North American Society for Oceanic History will be hosted by NOAA's Office of National Marine Sanctuaries. It will take place May 15-18, 2013 at Thunder Bay National Marine Sanctuary, in Alpena, Michigan on the shores of Lake Huron. This year's conference theme is *Maritime Borderlands and Cultural Landscapes*. Paper and session proposals are being accepted through January 1, 2013. Please see the Call for Papers in this newsletter or online at the conference website www.nasoh.org.

The conference venue is the portal to Thunder Bay National Marine Sanctuary, and the Great Lakes Maritime Heritage Center. The Center is a 25,000 square-foot museum, along with an active research station, conservation lab, and education hub. In the exhibit hall, you will experience the Shipwreck Century as you battle the fury of a Lake Huron storm aboard a 19th-century schooner and explore a shipwreck without getting wet in our immersive maritime heritage exhibits. Other highlights of the sanctuary campus include an HD theater, wooden boatbuilding workshop, large historical research collection, and gift shop as well as a glass bottom boat taking visitors to Thunder Bay shipwrecks. All sessions will be held in the Center, with several events taking place at various venues around the Alpena area.



Planned conference events include a special glass-bottom boat trip to view Thunder Bay shipwrecks, an afternoon exploring the maritime landscape of Northeast Michigan aboard charter bus – including stops at several lighthouses that dot the Lake Huron shoreline, daily continental breakfasts, evening receptions, catered lunches and banquet.



Alpena, Michigan is a vibrant Northeast Michigan town, located on the shores of Lake Huron, approximately four hours north of Detroit. In this charming mid-sized town, there are plenty of museums, shops, and theaters to explore. The surrounding area also has some of the best beaches, parks, and coastal drives in the region. Several major tourist destinations, including Mackinaw Island, Traverse City, and Sault Saint Marie, Michigan lie within a 3-hour dive of Alpena. <a href="http://www.alpenacvb.com/">http://www.alpenacvb.com/</a>. Also, NOAA's Maritime Heritage Program staff have been volunteering their off-duty time to assist with the interior hull survey of the historic sailing ship *Falls of Clyde* at Honolulu Harbor. Built in 1878 by Russell & Company of Port Glasgow, Scotland, the *Falls of Clyde* was the first vessel in the long line of British "Falls" ships. After 20 years pursuing general cargo including lumber, jute, cement, and wheat from ports around the world, the *Falls* was sold in 1899 to Captain William Matson, founder of the Matson Navigation Company. Today the ship is the oldest surviving member of the Matson fleet. To meet Hawaii's growing need for petroleum, the ship was converted to a sailing oil tanker in 1907 and for the next 14 years she loaded petroleum in Gaviota, California, for shipment to Honolulu. Following that, the ship served for more than 30 years as a floating fuel barge in Ketchikan, Alaska.

Between 1959 and 1963 several efforts were made by Captain Fred Klebingat, Karl Kortum, Robert Weinstein, Harold Huycke, and others to rescue the tough iron ship from being scuttled as a breakwater. In 1963, the *Falls of Clyde* returned to Honolulu where she was restored to a condition that represented her three distinct sailing careers.

She was re-masted and square rigged on all four masts as she was during her first years as a sailing ship. Her cabins were refinished to represent her life as a passenger and cargo vessel in the Hawaiian trade, and her pump room and ten tanks reflected her unique life as one of the world's surviving sailing oil tankers. The *Falls* has served for over four decades as the most recognized feature of Hawaii's historic waterfront. She was designated a National Historic Landmark in 1989.

Since then, the ship has deteriorated markedly. Her owners hired a marine surveyor in 2008, and the decision was made to scuttle the *Falls*. However, the non-profit Friends of *Falls of Clyde* group purchased the vessel from Bishop Museum and, having initiated their own surveys, is making a concerted effort to save the ship. Closed to the public, she remains downrigged and de-masted, alongside Pier 7 at Honolulu Harbor. The current internal survey, supported by the Friends group, Hawaii's Clean Islands Council, and San Francisco Maritime National Historic Park, is being done in preparation for planned dry docking and hull stabilization work. Charles Roy Schultz, 76, of College Station, passed, July 26, 2012. Charles was born December 6, 1935, in Giddings, Texas. Before becoming a rancher, Charles received a Masters Degree in Library Science from Ohio State, and a Doctorate in Oral History from Bowling Green University. Charles worked as an Archivist for Texas A&M University. He served as head of the archives and held the Clemens Chair for many years, was President of the Brazos County Historical Society, and was a standing member of the Presidents Society Southwest Archivist. He was also a member of the Naval History Board in Annapolis, and he was an Admiral in the Texas Naval Reserve.

Ahead Full at Fifty: 50 Years of Collecting at Maine Maritime Museum: An exhibit of more than 150 artifacts and documents collected by Maine Maritime Museum over the past half century marks the culminating event of the Museum's 50th anniversary celebration. Ahead Full at Fifty: 50 Years of Collecting at Maine Maritime Museum opens November 10 and will be on view through 26 May 2013. The exhibit will showcase objects that are historically important, rare in beauty, or have an unusual story about how the Museum acquired them. The exhibit will be curated by Museum Trustee Emeritus Charles E. Burden, with assistance from the entire curatorial staff. Burden is one of the founding members of the Museum and has been an active and involved supporter since 1964. A number of the objects in Ahead Full at Fifty were either donated by Burden or acquired by the Museum through his efforts. An exhibit catalog, titled Maine & the Sea: 50 Years of Collecting at Maine Maritime Museum, has been published. All the objects in the exhibit will be pictured in the catalog in chronological order of their acquisition by the Museum, along with the story of how the Museum came in possession of the object or document. This narrative presents the story of how a Museum's collection is built over decades through donations, planned purchases, and sheer serendipity. "Sugar and Beyond," A multidisciplinary conference sponsored by The John Carter Brown Library, Providence, RI. The John Carter Brown Library seeks proposals for "Sugar and Beyond," to be held on 25-26 October 2013, and in conjunction with the Library's Fall 2013 exhibition on sugar in the early modern period. The conference seeks to evaluate the current state of scholarship on sugar, as well as to move beyond it by considering related or alternative consumer cultures and economies. This conference thus aims to serve as an occasion where new directions in the study of sugar can be assessed. At the same time, the connection of sugar to such broader topics as the plantation system, slavery and abolition, consumption and production, food, commodity exchange, natural history, and ecology has pointed the way to related but distinct areas of inquiry. NOAA's Office of National Marine Sanctuaries will host the 2013 Annual Conference of the North American Society for Oceanic History. It will take place 15-18 May 2013 at Thunder Bay National Marine Sanctuary, in Alpena, Michigan on the shores of Lake Huron. The Conference theme will be "Maritime Borderlands and Cultural Landscapes."

The past two decades have seen a refocusing of scholarship in "borderlands" history with studies of physical and figurative spaces among and between states and cultures transforming our understanding of North American places and peoples. In a similar development, Maritime history and archaeology have embraced the cultural landscape as a means for understanding and illustrating human connections to coastal and marine places. Through borderlands and cultural landscapes, scholars are re-examining the past in ways that are interdisciplinary, multi-cultural, and call into question long-held assumptions of economy, empire, environmental impact, and geographical meaning.

Using the international borderlands of the Great Lakes as a backdrop, the 2013 NASOH Annual Conference invites paper and session proposals that explore maritime borderlands or cultural landscapes, or an interweaving of both to examine the meaning and processes of our maritime heritage. Suggested topic areas include cultural borderlands, race, gender, archaeology, empire, military, indigenous, environmental, public history, and parks and protected areas. Additional topics and geographic focuses are welcome for submission. Papers from graduate students and junior scholars with fresh approaches to maritime history are greatly encouraged.
